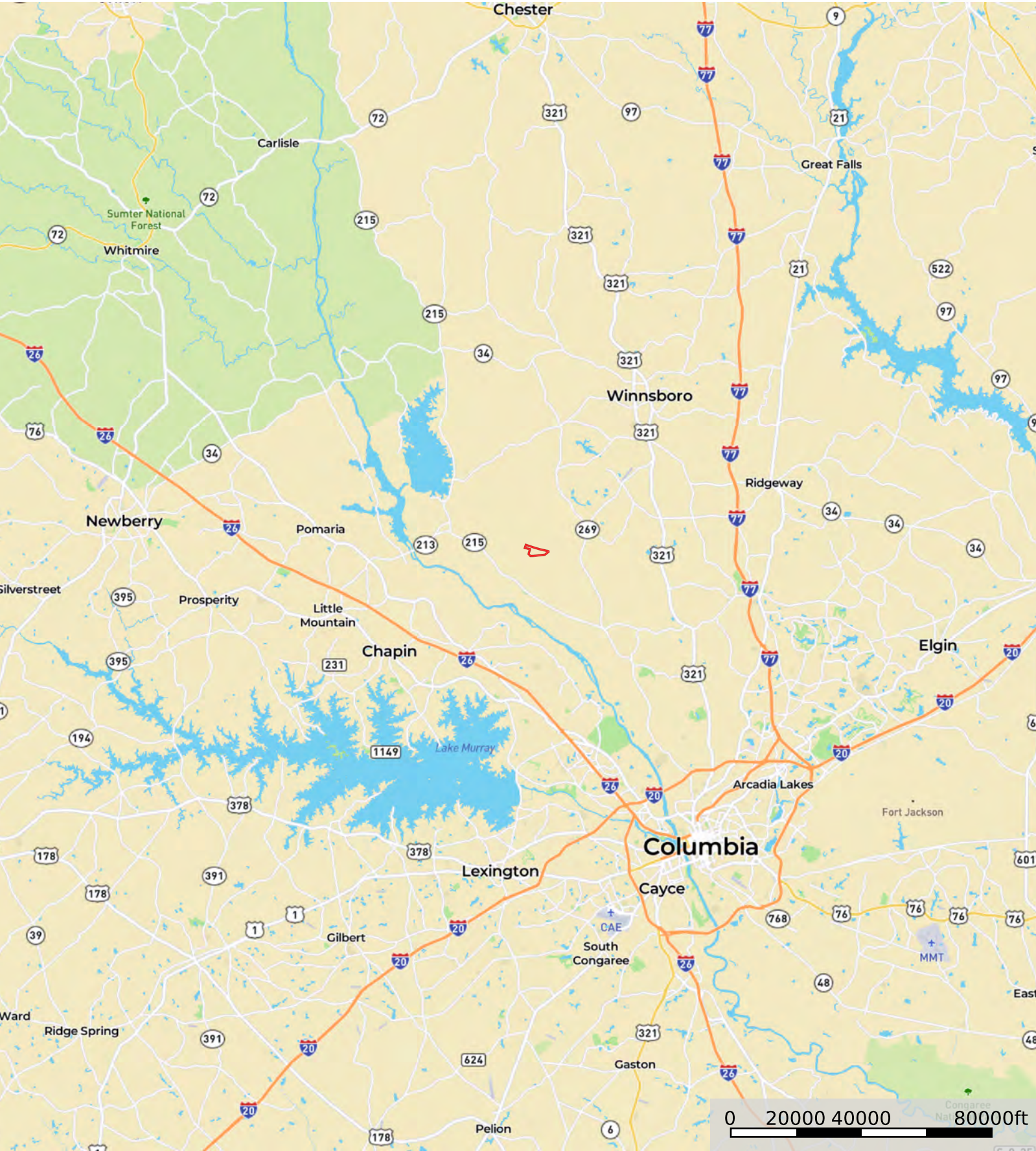

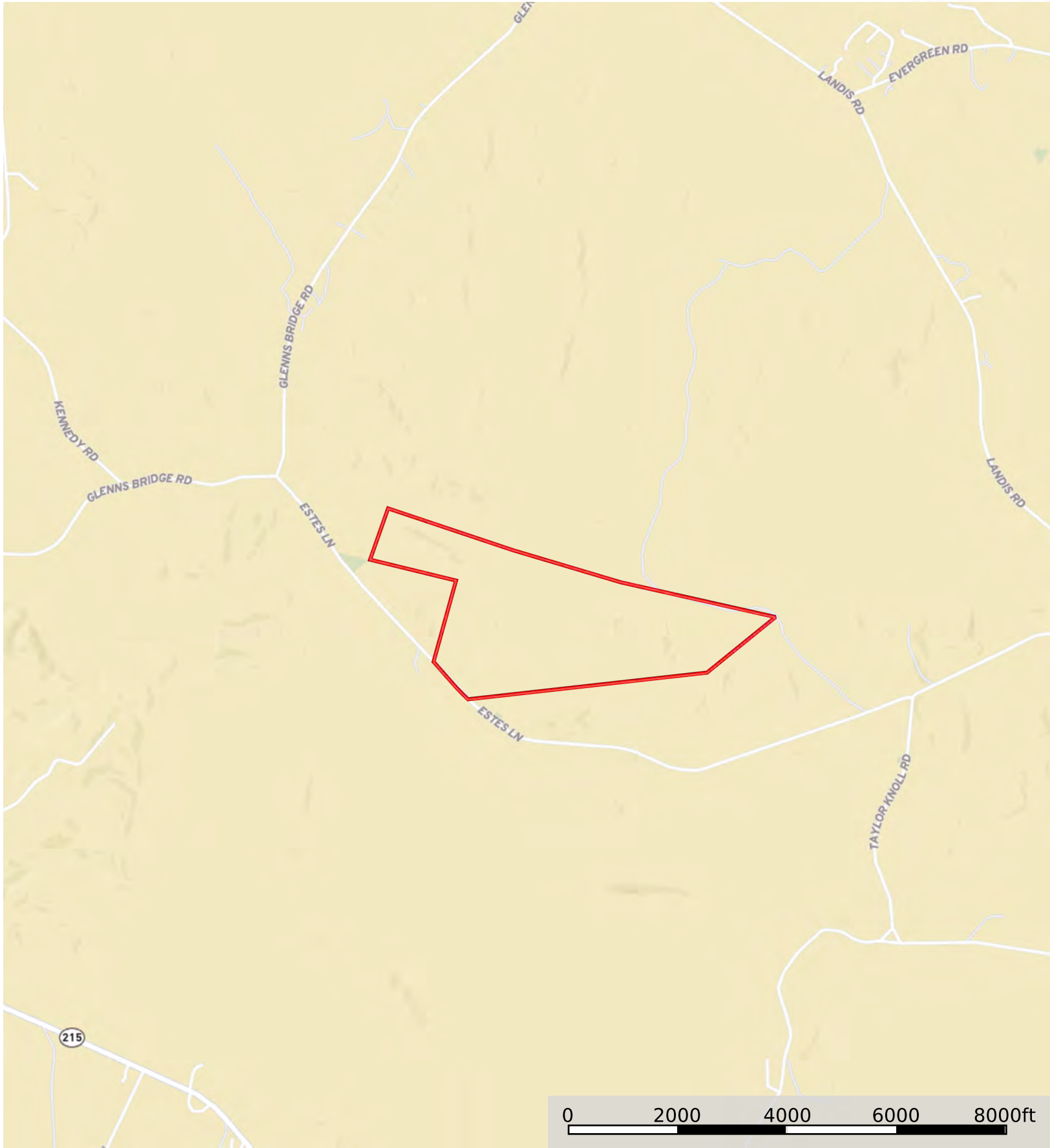
From Winnsboro, take SC 269 S for 7.1 miles, Turn right on Estes Lane and travel for 1.8 miles. The property will be on your left.
