

PROPERTY DESCRIPTION

This conveniently located 67-acre property is just four miles southeast of Summerton, SC, three miles from I-95, and less than a mile from Lake Marion.

This offering has a well-maintained dirt road, splitting the property into two pieces. Roughly forty acres are separated into fields of twenty-two, twelve, and six acres suitable for row crop production. The remaining land consists of mixed mature timber suitable for harvest. A small drainage containing large pines and hardwoods winds through the middle of the property, creating a diverse wildlife sector that is currently contributing to a healthy turkey population in the immediate area. Penn Brook Road runs through the property, making for trouble-free movement of equipment and vehicles to either side of the property.

The surrounding area is known for some of the best recreational opportunities in the state, such as camping, boating, and hunting. John C. Land Boat Landing is just over two miles from the property, allowing easy access to Santee Cooper's Lake Marion. With turkey, deer, and the potential for ducks utilizing the property, the opportunity for weekend recreational activities or a family homesite awaits. Row crop rent and timber harvest allow for immediate investment opportunities in a quickly appreciating area of the state. Whether you want to own recreational income-producing land near Lake Marion and I-95 or a weekend retreat, the Penn Brook Road offering presents various future opportunities.


