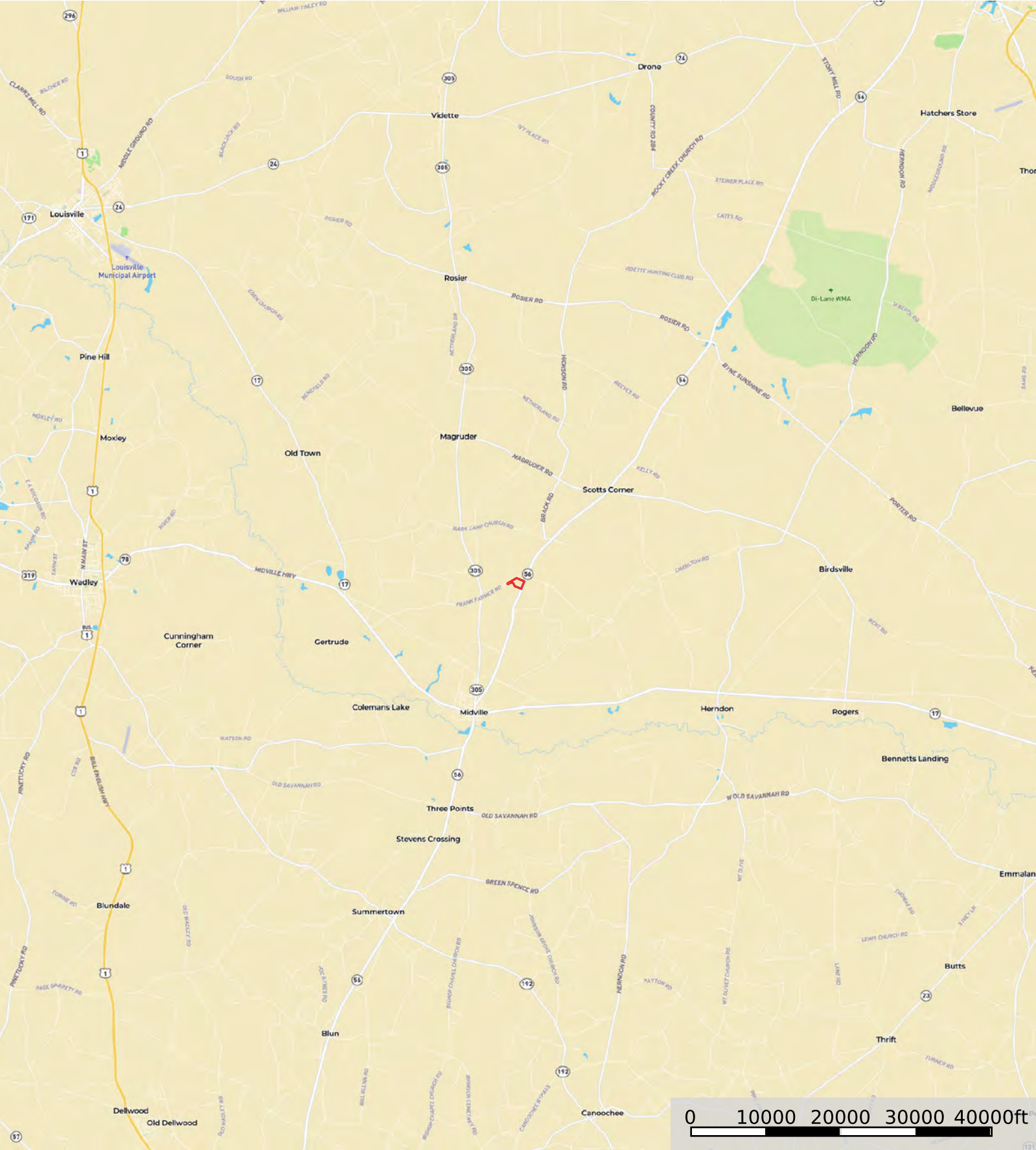
From Midville, take Hwy 56 towards Waynesboro. Travel 3.6 miles and the property will be on the left.
