Deer are abundant, making this a strong candidate for a small hunting retreat. The gently sloping topography also allows for multiple potential homesites or a family compound. In town, turn left onto SC-23 West (Columbia Highway) toward Ward and continue for about 3.7 miles. Then turn right onto Speigner Road. The property will be about 1.2 miles down on your right after you cross a short bridge.




