

PROPERTY DESCRIPTION

The Troy West Tract spans 93 acres and features a well-rounded mix of timberland and natural hardwoods. The property contains 58.86 acres of planted pine suitable for near-term management, along with 19.74 acres of recently harvested land now in early reforestation stages. Mature natural hardwoods cover about 13.45 acres, offering diverse wildlife habitat and seasonal water features.

The property boasts 1400 feet of frontage on Triple C Road and features a partial trail system that ties the tract together and provides access throughout. Whether managed for timber income, used as a recreational getaway, or developed into a rural homesite, Troy West offers both immediate utility and long-term upside. Its location near the Sumter National Forest and Lake Strom Thurmond ensures privacy, recreation, and protection from outside development pressures.
