

PROPERTY DESCRIPTION

The Hunting Road Tract is located in a quiet rural community only 5 miles southwest of Bowman and 7 miles southeast of Rowesville. The property is currently being managed for maximum timber production providing a future revenue stream with sound forestry management practices in place. The landscape of the property is comprised of 44% premerchantable pine plantation while the remaining acreage consists of natural hardwood drains. The natural hardwood drains provide habitat diversity and ample travel corridors for wildlife such as deer and turkey. The property is well suited for a multitude of applications such as timber investments, outdoor recreational pursuits, and is ideal for a permanent residential site in a quiet rural area.

Orangeburg County, SC - approx. 94.0 acres +/-






