

PROPERTY DESCRIPTION

Old Chelsea Hazzard Creek is one of the last true Lowcountry plantations and was once part of the Fields family's historical Chelsea Plantation. From magnificent sweeping live oaks to towering old-growth pines with mixed hardwoods throughout, Old Chelsea Hazzard Creek offers incredible wildlife habitat diversity and a beautiful landscape.

Old Chelsea Hazzard Creek has an abundance of wild turkeys and a very healthy, wellmanaged deer herd. It is situated between Bolan Hall Plantation, Chelsea Plantation, Hazzard Creek Plantation, and Okatie Club while only a short ten-minute drive from Okatie and its amenities. Hazzard Creek and its game-rich hardwood creek bottom runs through the middle of the property, providing excellent turkey roosting, deer bedding cover, and an abundance of quality mast-producing hardwoods perfect for bow hunting. The landscape is rich with diverse habitats, including mature stands of mixed pine and hardwoods that are seldom seen anymore. Much of the upland pine forests are mature and could be thinned. The proper spacing of trees and canopy allows sunlight to penetrate the forest floor, promoting the growth of native warm-season grasses and forbs for bobwhite quail.

Old Chelsea Hazzard Creek is conveniently located only 6 miles from John Paul II and 14 miles from Cross School, Hilton Head Christiaan Academy, and Bluffton High, offering a rare opportunity to be close enough to turn the property into a full-time residence. This property is a blank canvas with no improvements, allowing the new owner the freedom to craft their dream home or hunting compound.

The current zoning for Old Chelsea Hazzard Creek is very liberal, as this property has been fully entitled to an existing development agreement with Jasper County. This would be a rare opportunity for a conservation-minded buyer to capitalize on potential tax incentives by placing an easement on this historic property. The donor can design easements for all historical usages providing protection from development.




