

PROPERTY DESCRIPTION

A rare opportunity to buy 25 +/- acres of high land with access to Leadenwah Creek on Wadmalaw Island. Located within Selkirk Plantation, this property offers 1500 feet of marsh front with east-to-west panoramic views of expansive marsh and tidal creeks. The property offers a 400-foot dock leading out to a navigable tributary creek less than 600 feet from Leadenwah Creek. The landscape comprises 15 acres of open agricultural land with a balance of mature stately pine, moss-draped live oaks, and mature saw palmettos, creating a picturesque low-country setting.

Selkirk Plantation is an 835-acre planned conservation community with a limited number of large acreage lots. The easement allows for historical usages and permanent residences but limits the number of allowed divisions, ensuring the natural beauty and protection from high-density development in perpetuity.

DIRECTIONS:

From Main Road on Johns Island, take Maybank Highway towards Rockville. Cross Esau Jenkins Bridge onto Wadmalaw Island and travel for 5.9 miles. Turn right onto Liberia Road, and in 1 mile, turn left onto Selkirk Plantation Road. Continue on Selkirk Plantation Road for 1 mile and then turn left onto Back Forty Road; in two-tenths of a mile, the property is on the left.


