

The Munnerlyn tract consists of 215 +/- acres of timber investment opportunity. The property is easily divisible with multiple road access points. The entire tract has an adequate road system, allowing recreational access to most of the property. The wildlife is supported by the thick underbrush, wetland branches, and natural food supply. The smaller 21.7-acre portion has road frontage on Alexander-Munnerlyn Rd and Idlewood-Munnerlyn Rd and could be purchased separately from the rest of the property with a price adjustment. This property is conveniently located off State Highway 25 and only 50 minutes from Augusta, 1 hour and 50 minutes from Savannah, and 50 minutes from Statesboro. 


