This home offers 3 bedrooms and 2 bathrooms but needs repairs, creating an opportunity for a guest house, hunting cabin, rental property, or renovation project. An old barn provides additional storage and character.

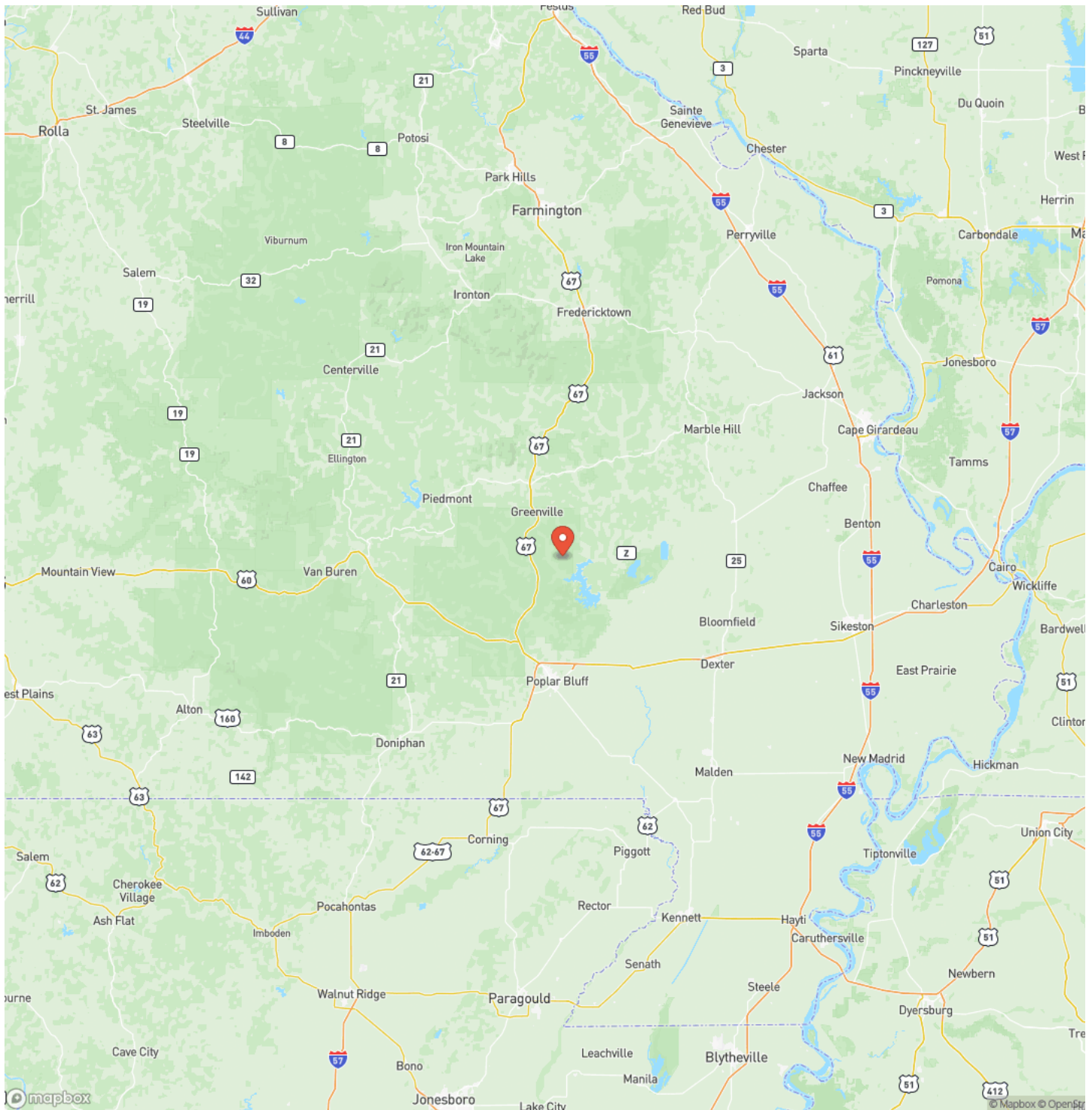

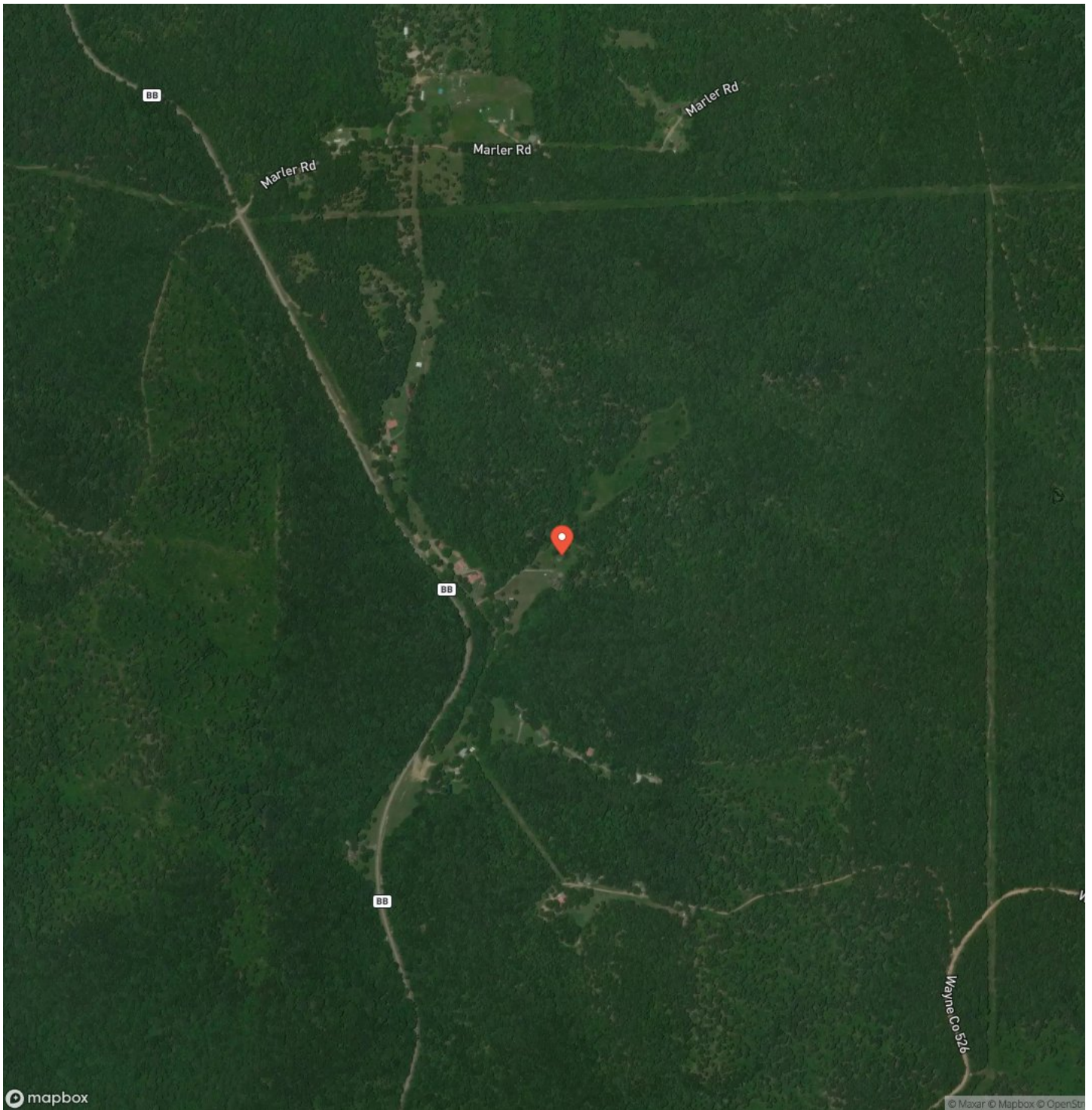
Locator Map
