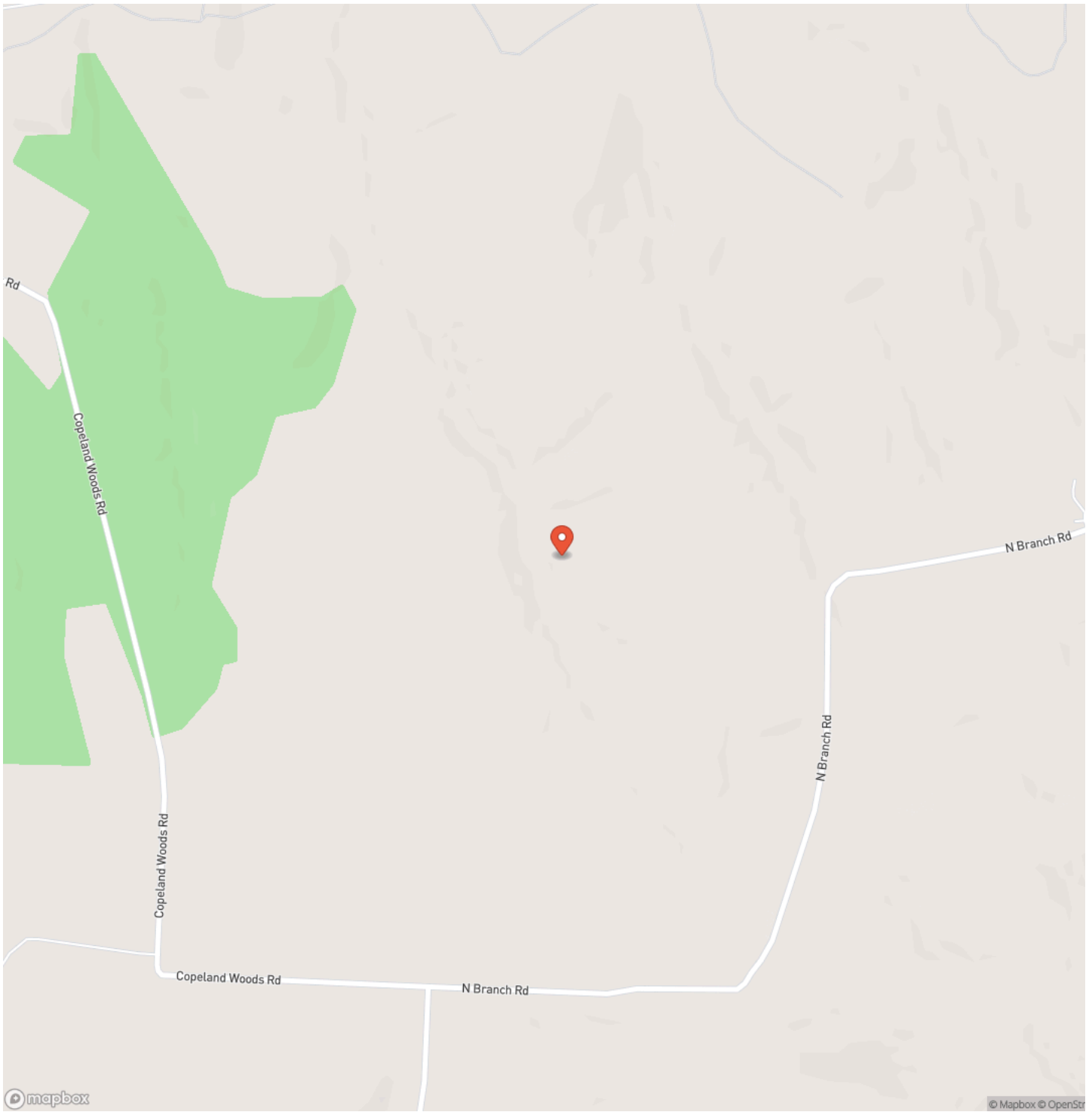

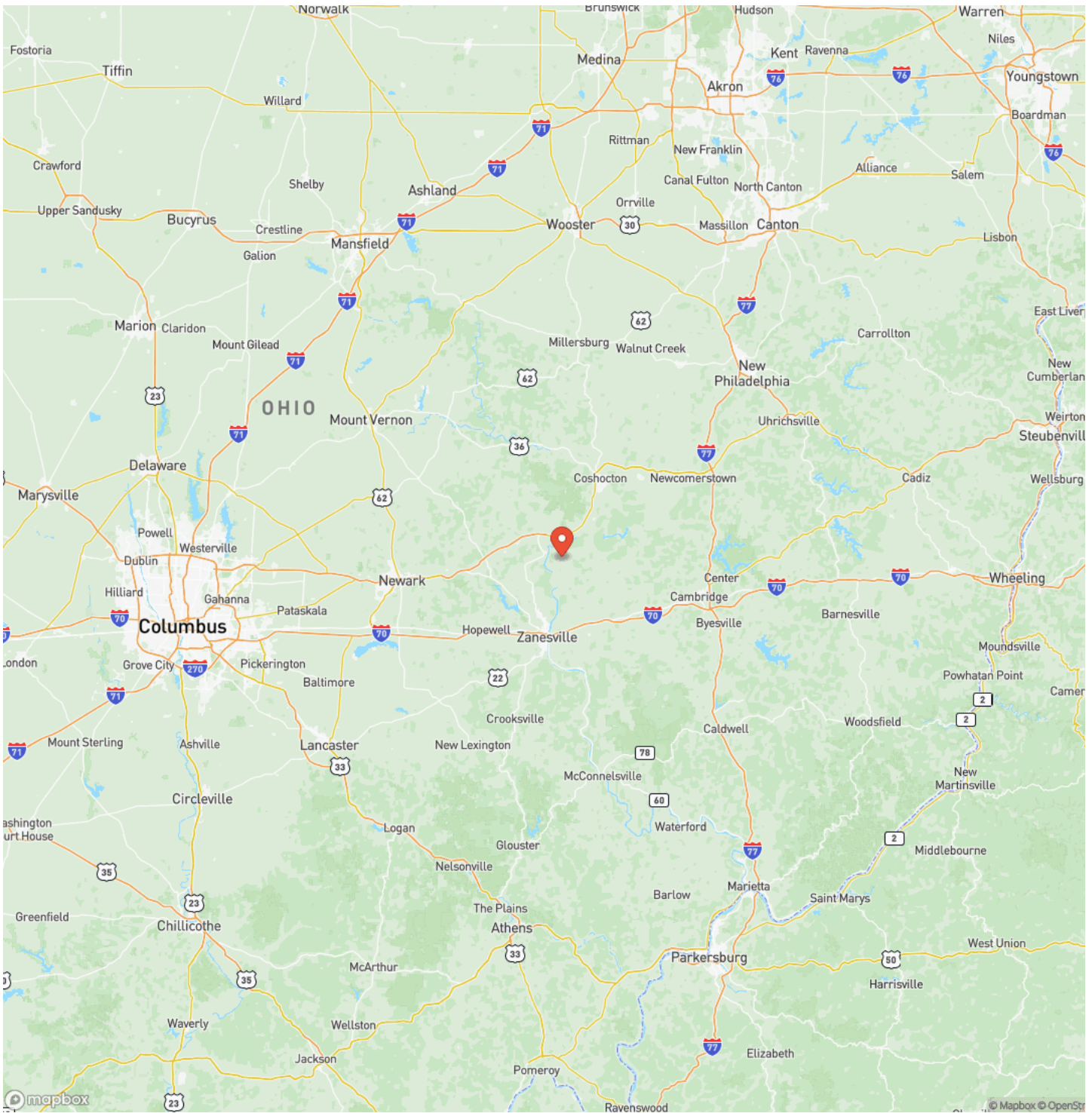

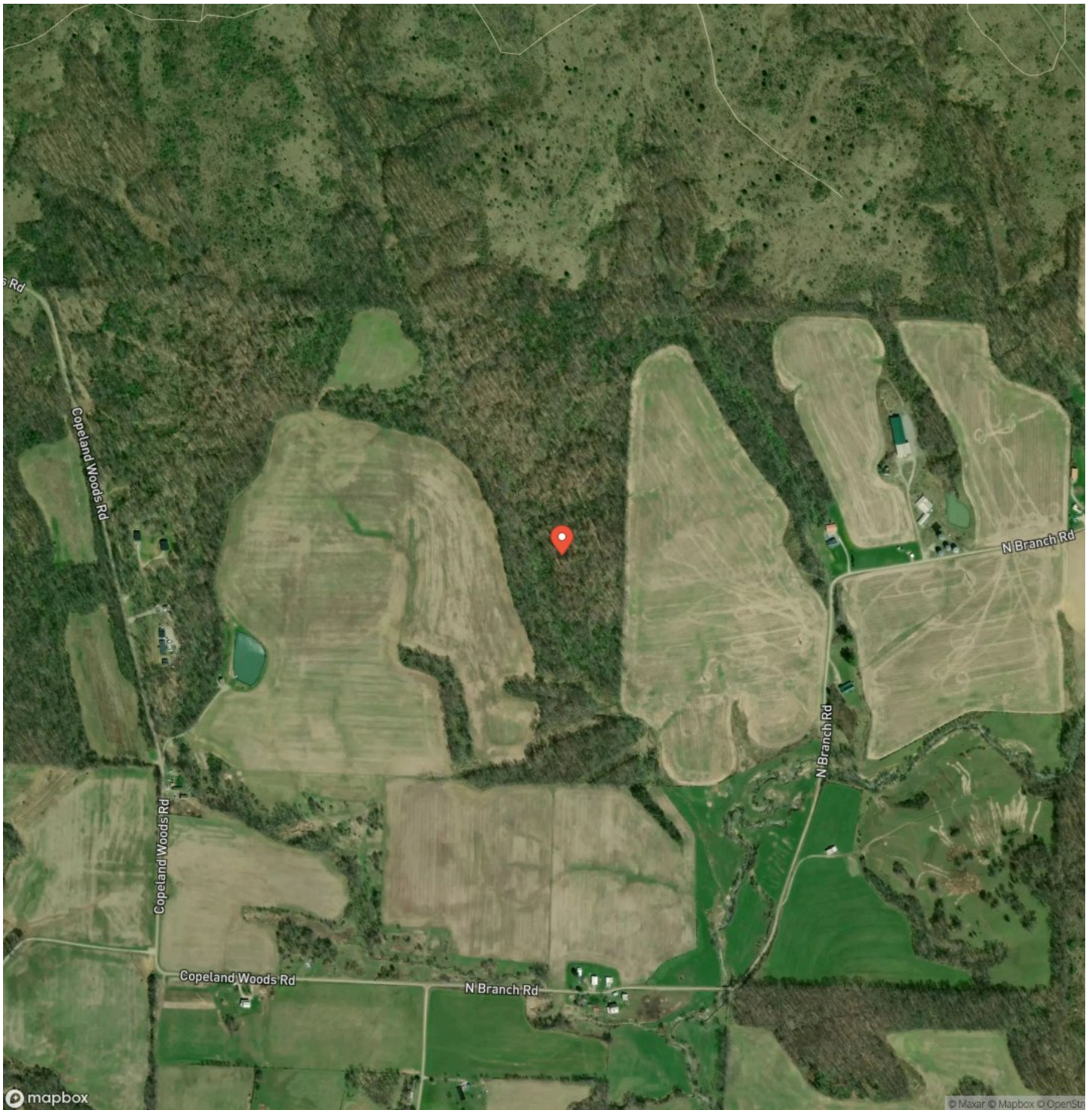
Locator Map
