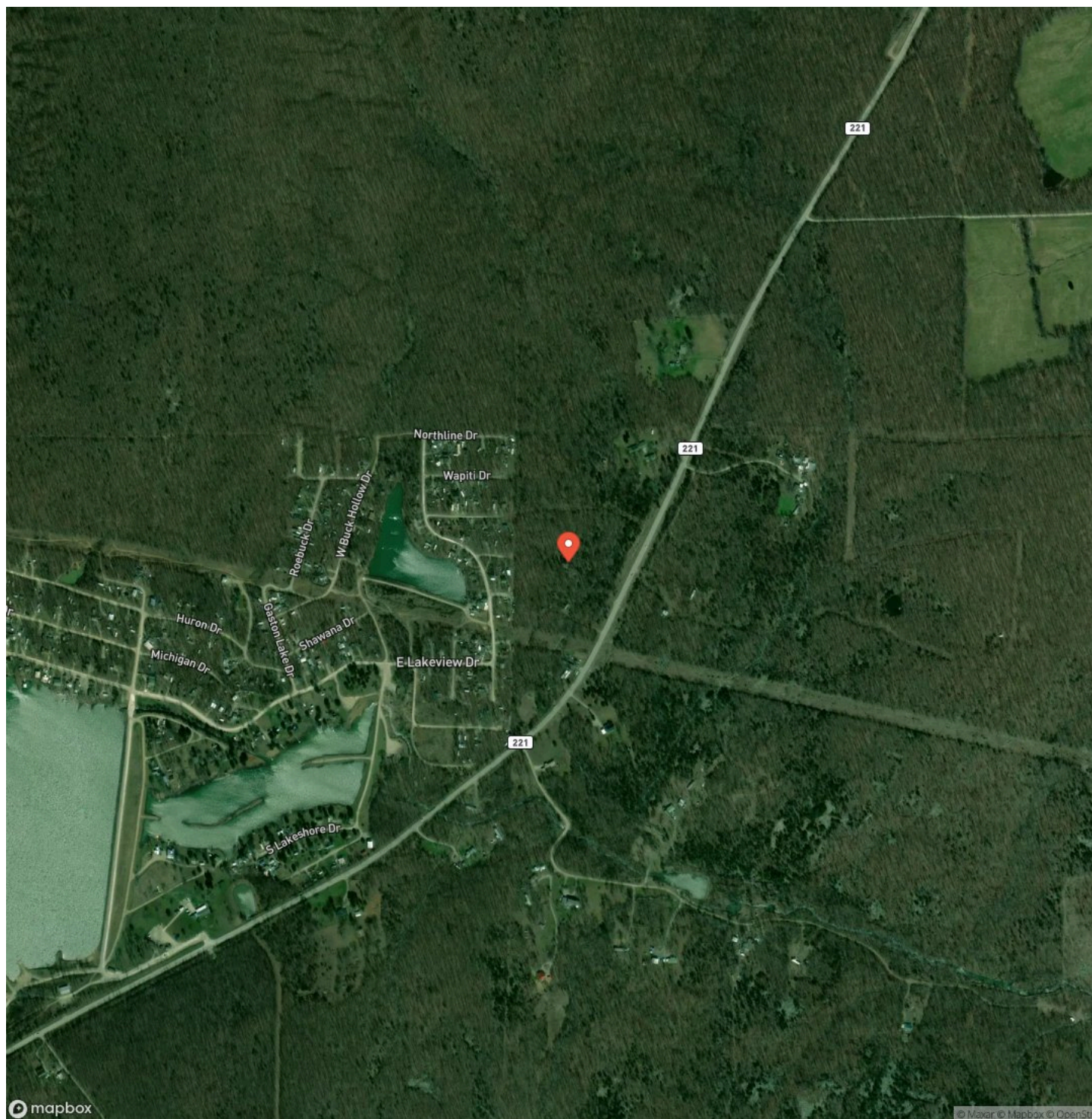
Locator Map
