Woodland Lake Estate is a peaceful and secluded property located in the west central Piedmont region of Georgia.

Featuring a custom built home surrounded by beautiful woods, fescue pastures, with a natural lake, Woodland Lake Estate offers the ideal spot for a recreational getaway, an equestrian estate, or simply a serene place to call home.

This rural property is perfect for the buyer who wishes to experience the relaxed country lifestyle.

Woodland Lake Estate is a turnkey property which includes all remaining furniture, appliances, and furnishings. With its multiple outdoor living spaces and beautiful grounds, it provides the perfect setting for relaxation and rejuvenation. The entry with its deep porch, wicker furniture and fire pit invites one to enjoy the view of the pasture and lovely trees that dot the expansive front acreage. A two-story foyer leads to a vaulted great room with stacked stone fireplace. This room includes a passthrough to the chef's kitchen which features a breakfast area, large pantry, and keeping room with gas fireplace. Accessible from the kitchen is the back patio with brick fireplace. Wicker patio furnishings which remain provide another option for enjoying early mornings or cool evenings. The formal dining room features judges paneling and an unusual double tray ceiling. The master bedroom suite also features a double tray ceiling, a sitting area, his and her closets, and spa-like bathroom with double vanity, whirlpool soaking tub and separate tiled step-in shower. Also on the first floor is a second bedroom with full bath, laundry room and a large den/study/bonus room with another full bath. Three additional bedrooms and a full bath are on the second floor, with one bedroom furnished with an antique bedroom suite. All rooms have 10-foot ceilings, 8-foot doors and crown molding. Graber plantation shutters can be found on all windows throughout the home.

For the outdoorsman there is the lake for fishing or kayaking and woods for hunting. Other ample recreational opportunities can be found nearby. Only 6.5 miles away is Big Lazer Creek Wildlife Management Area, a 7,200-acre property which offers hunting opportunities for deer, turkey, small game and waterfowl. Additional accommodations at Big Lazer include a shooting range, lake and river fishing, canoe access, picnic tables, and primitive campsites.

Listed at \$725,000, well-maintained and upgraded, this is definitely the property you will want to call home.
