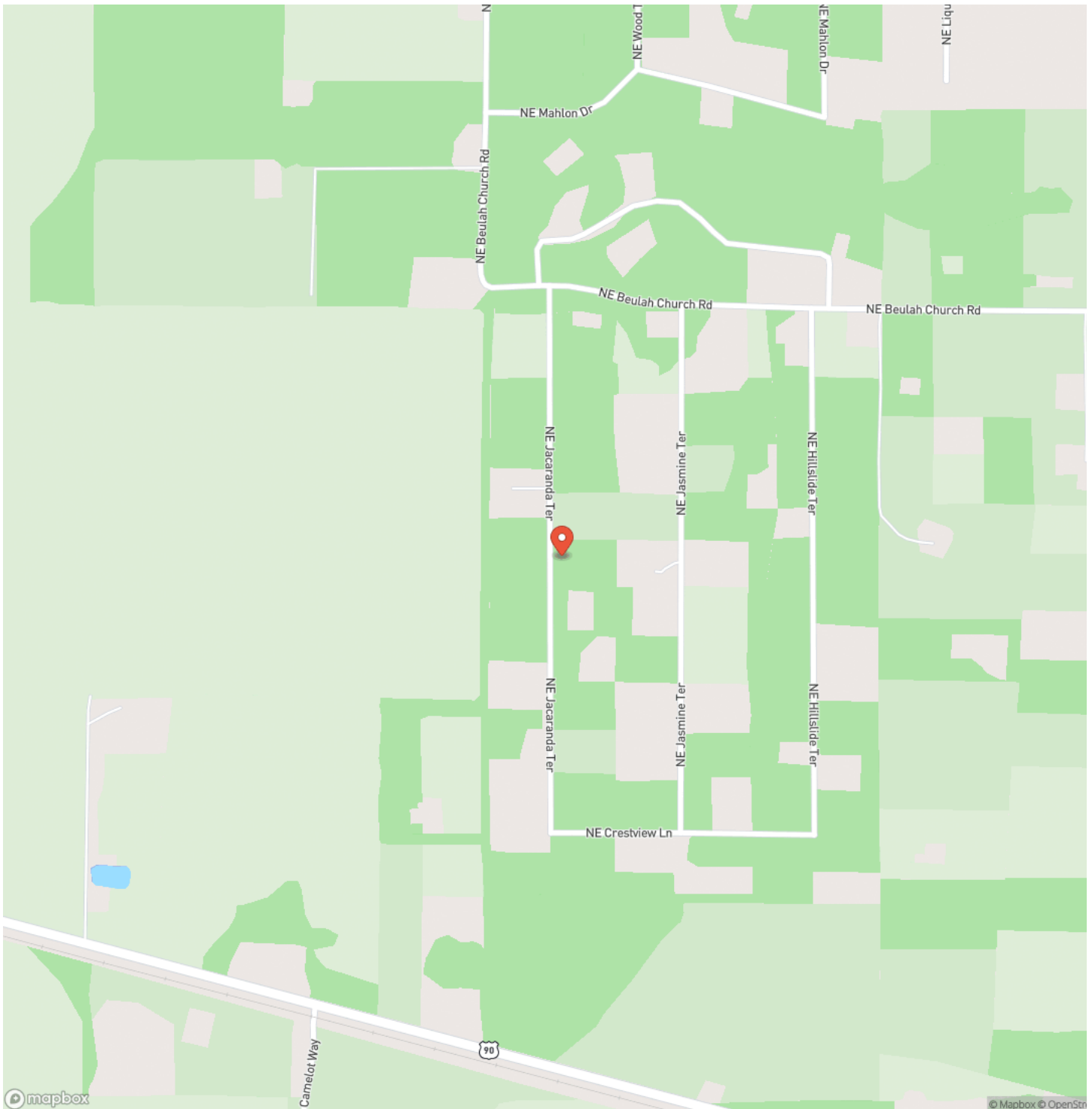

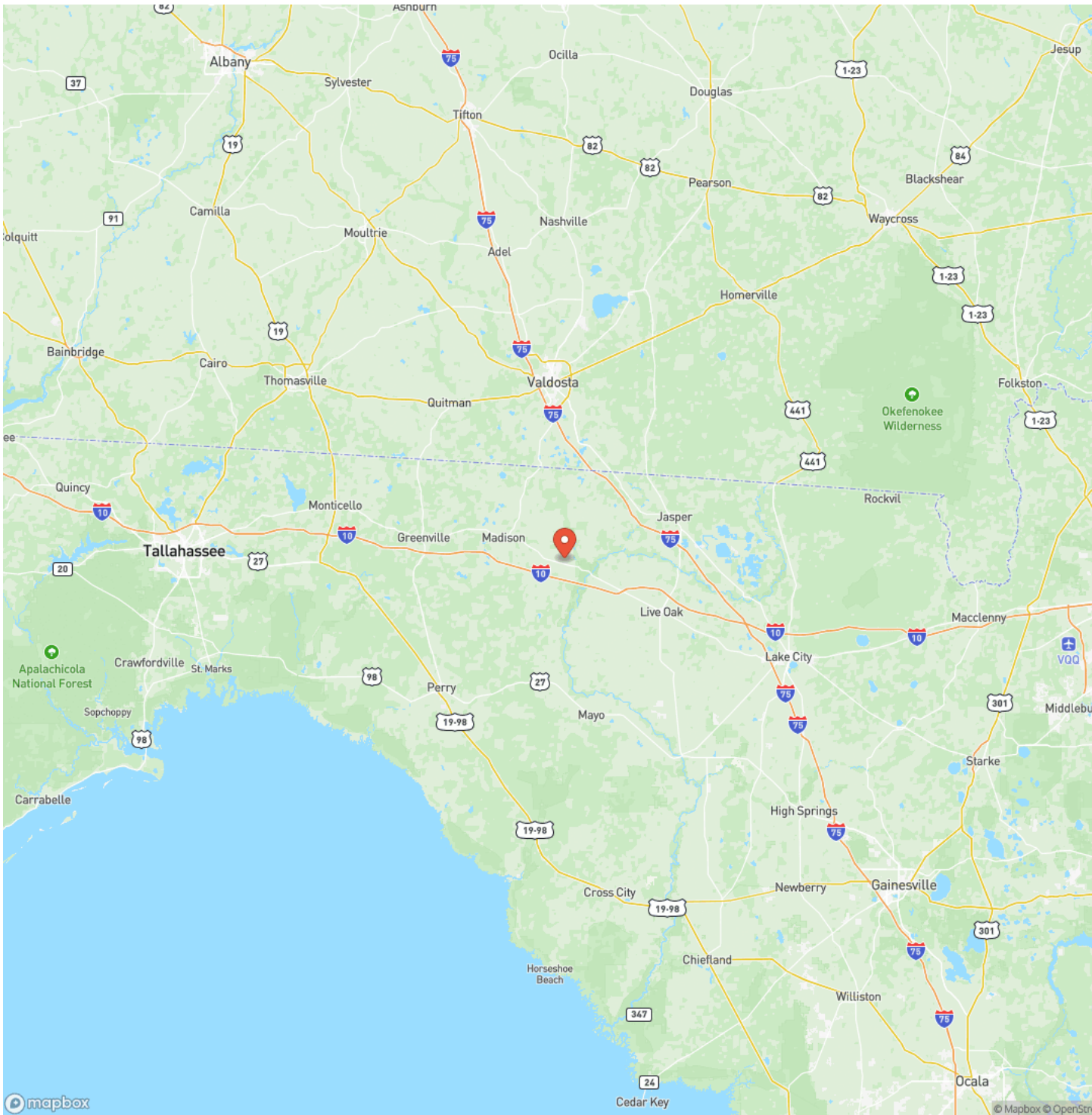




Locator Map
