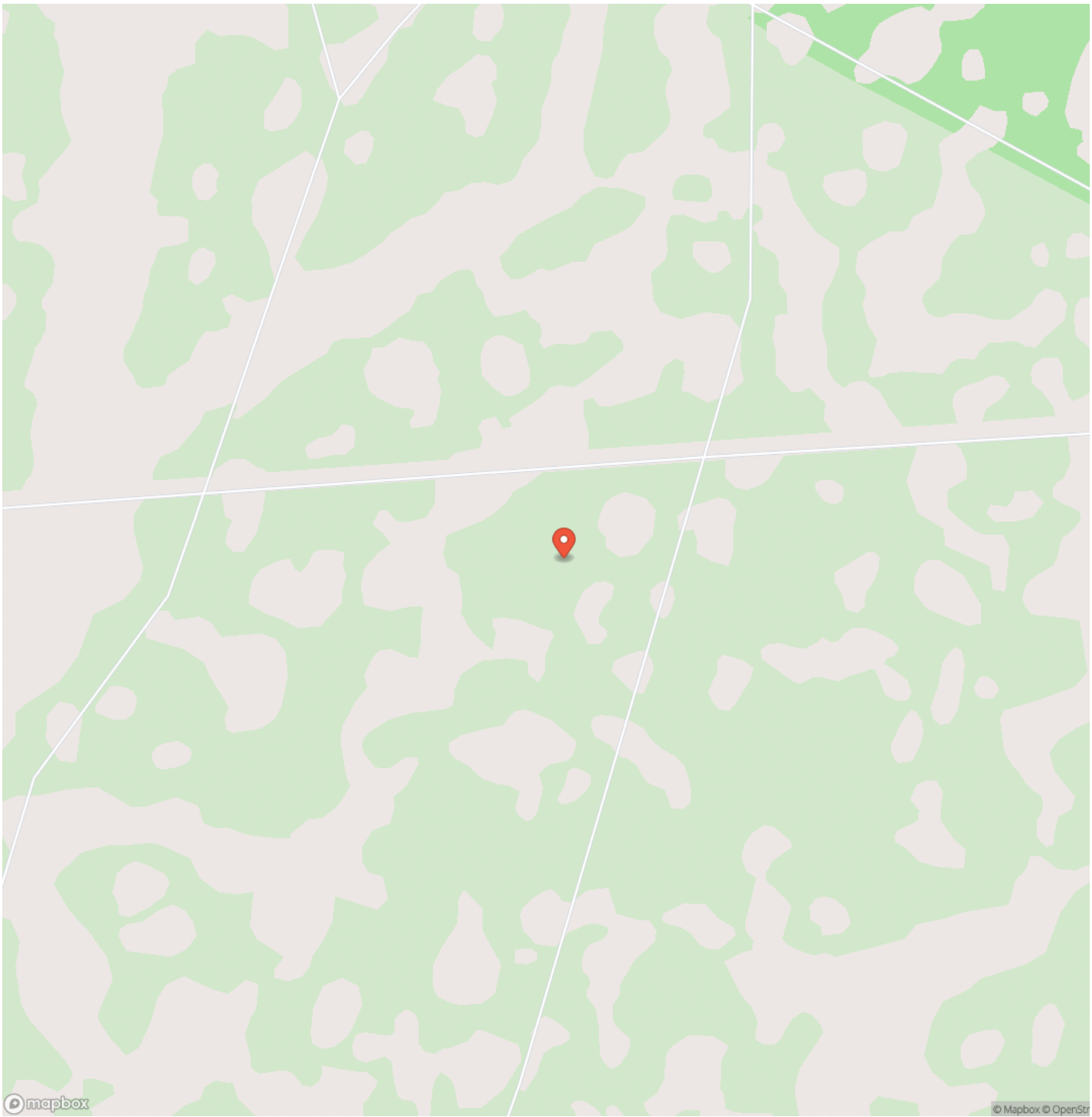

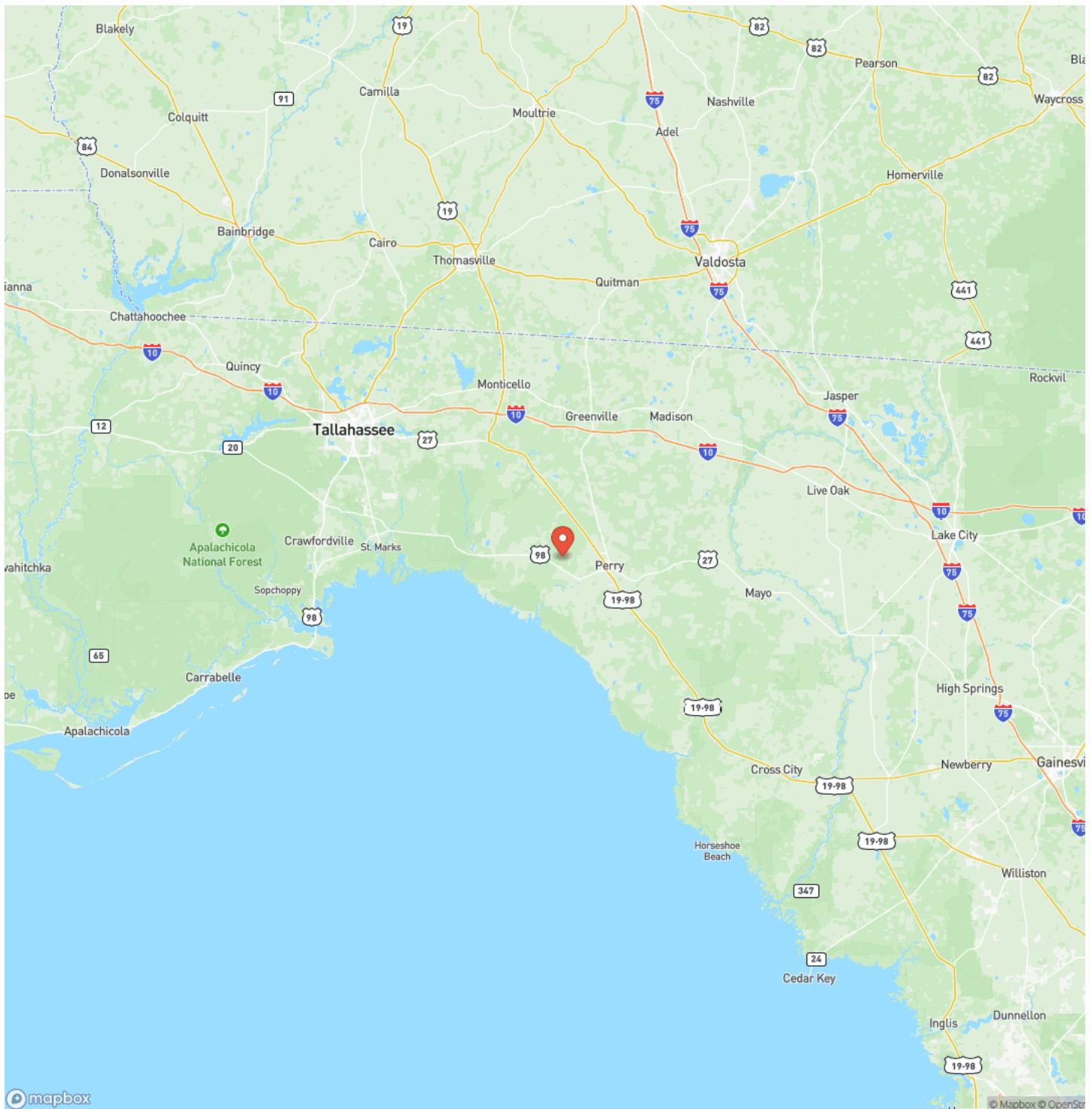
Taylor County 15 Acres

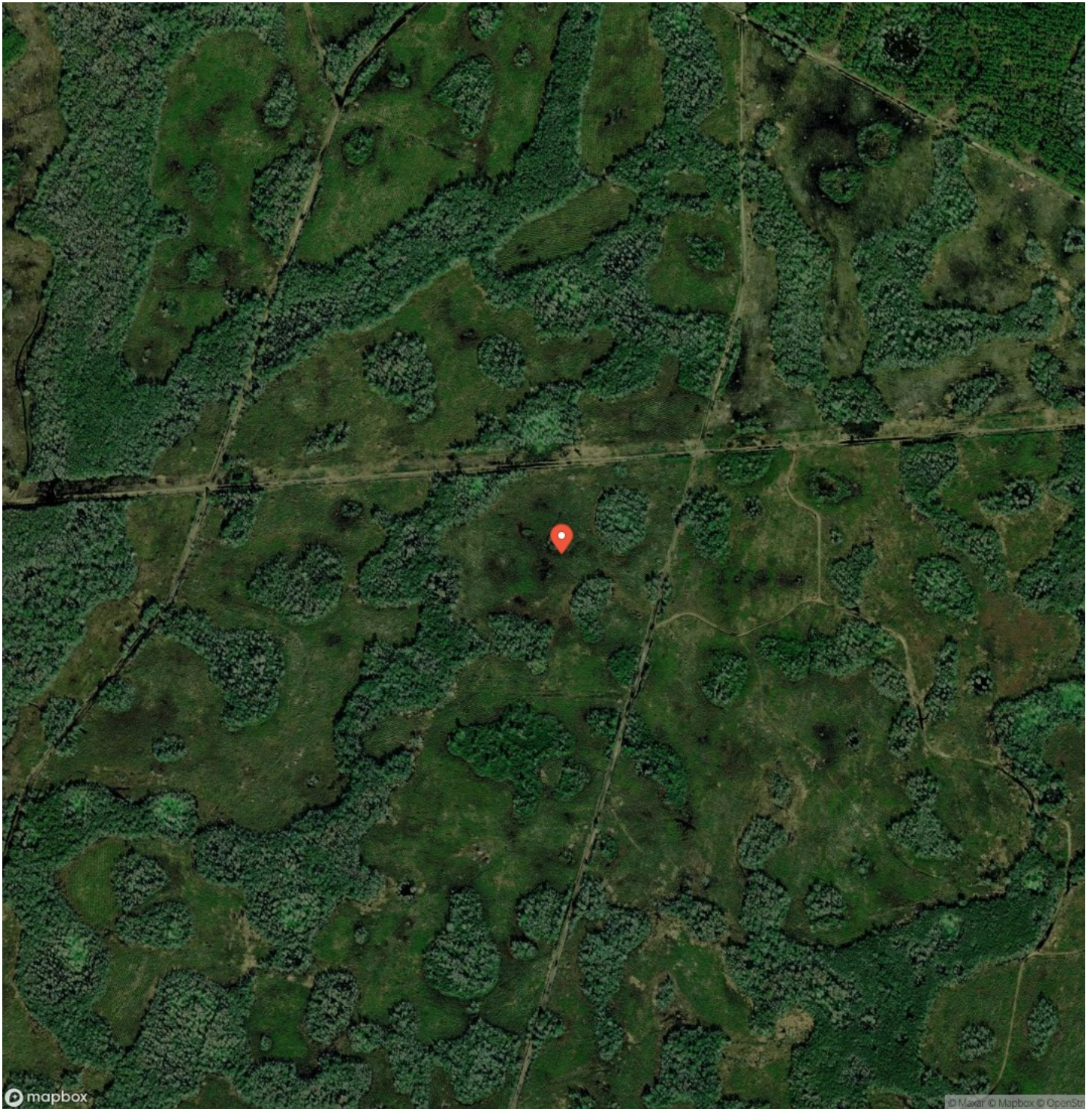
Locator Map
