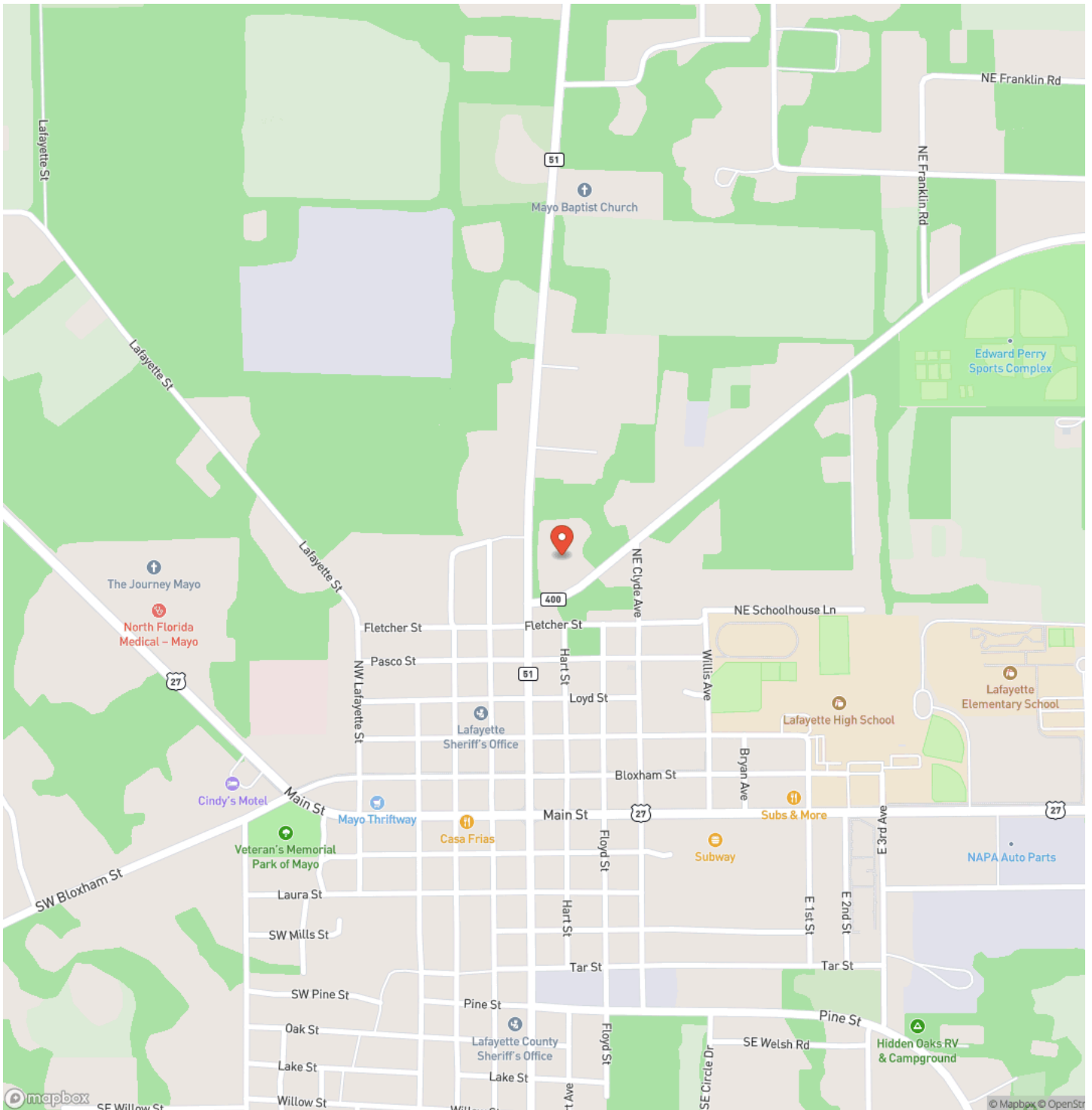

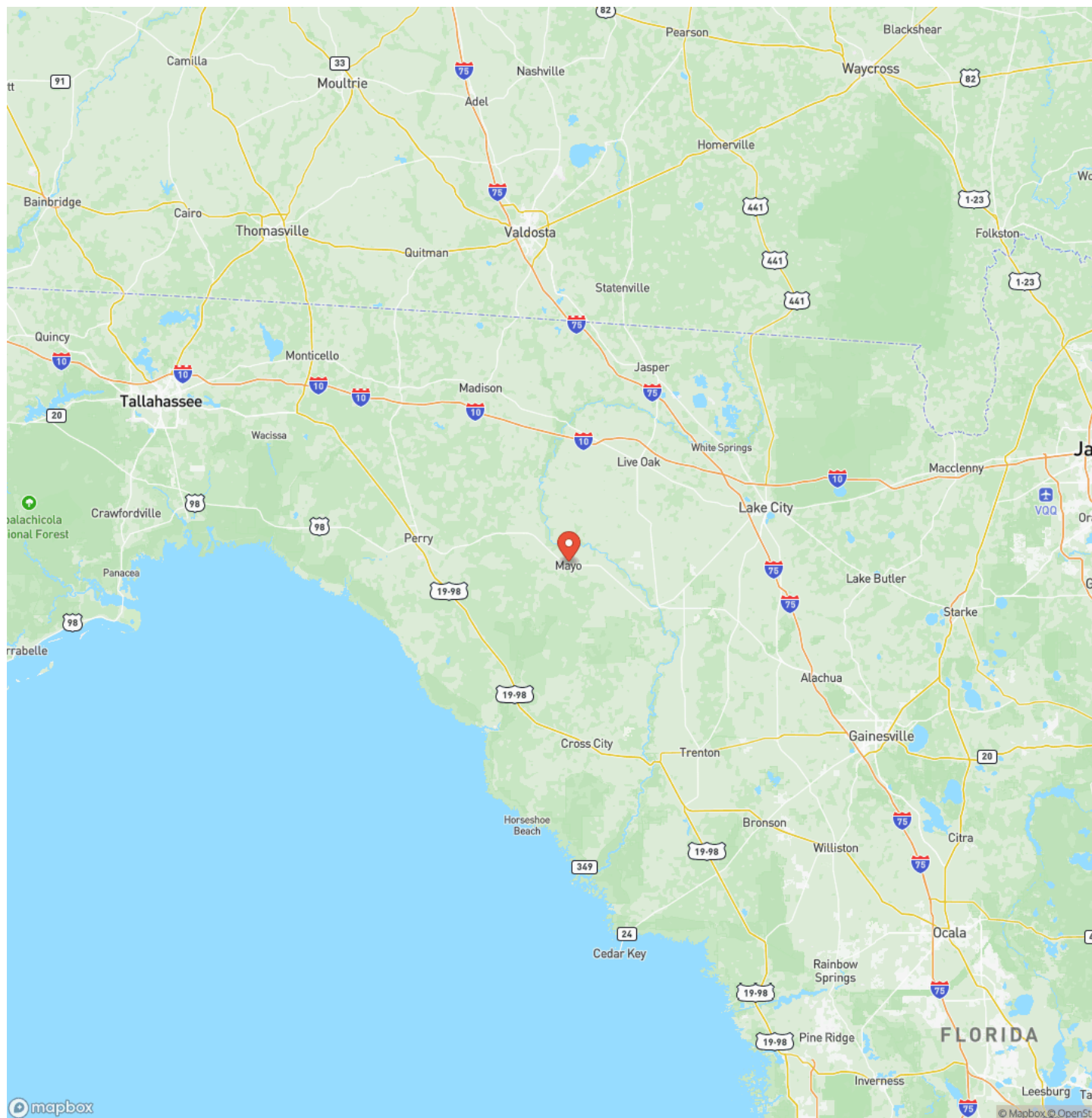
Locator Map



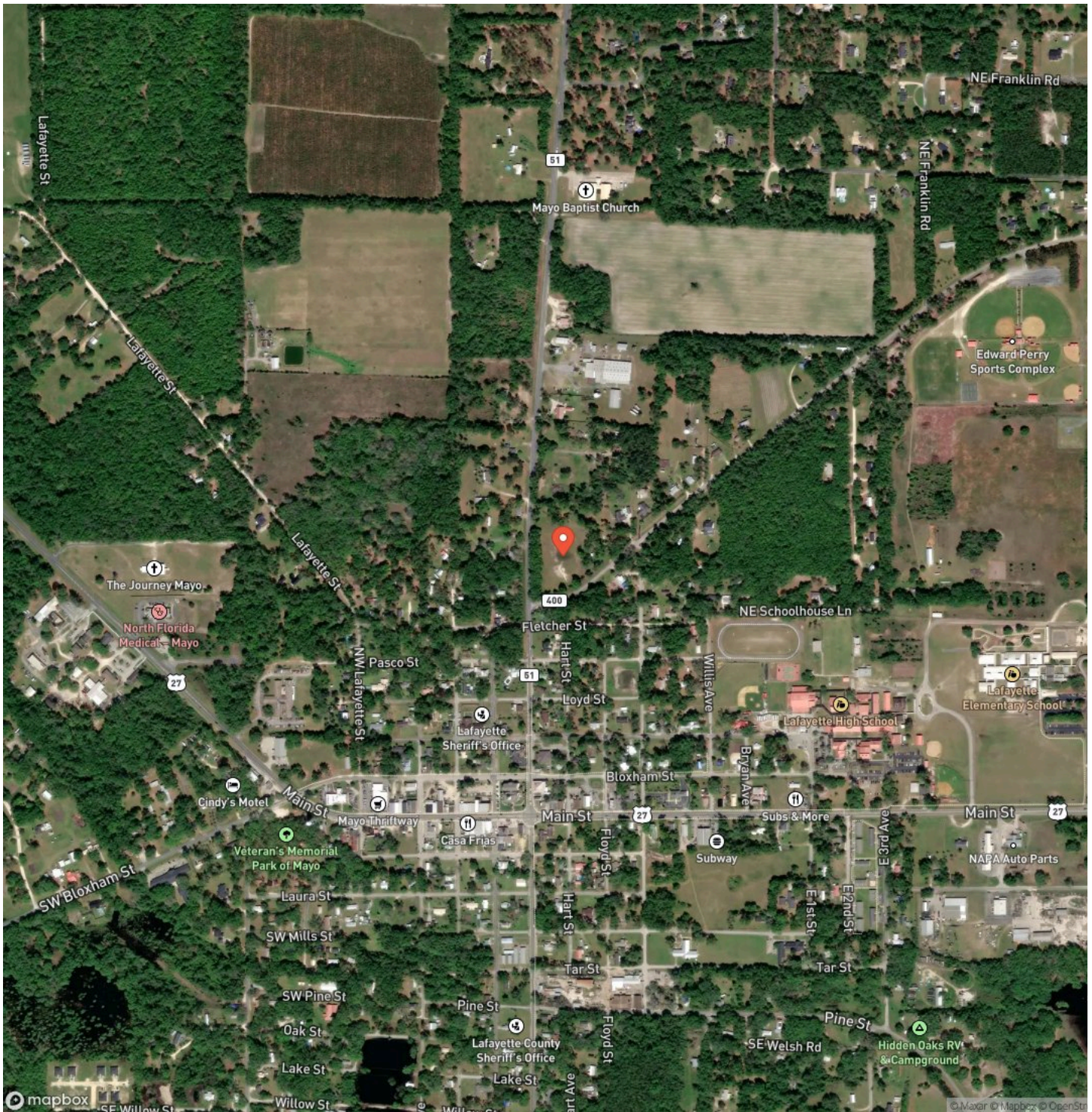
