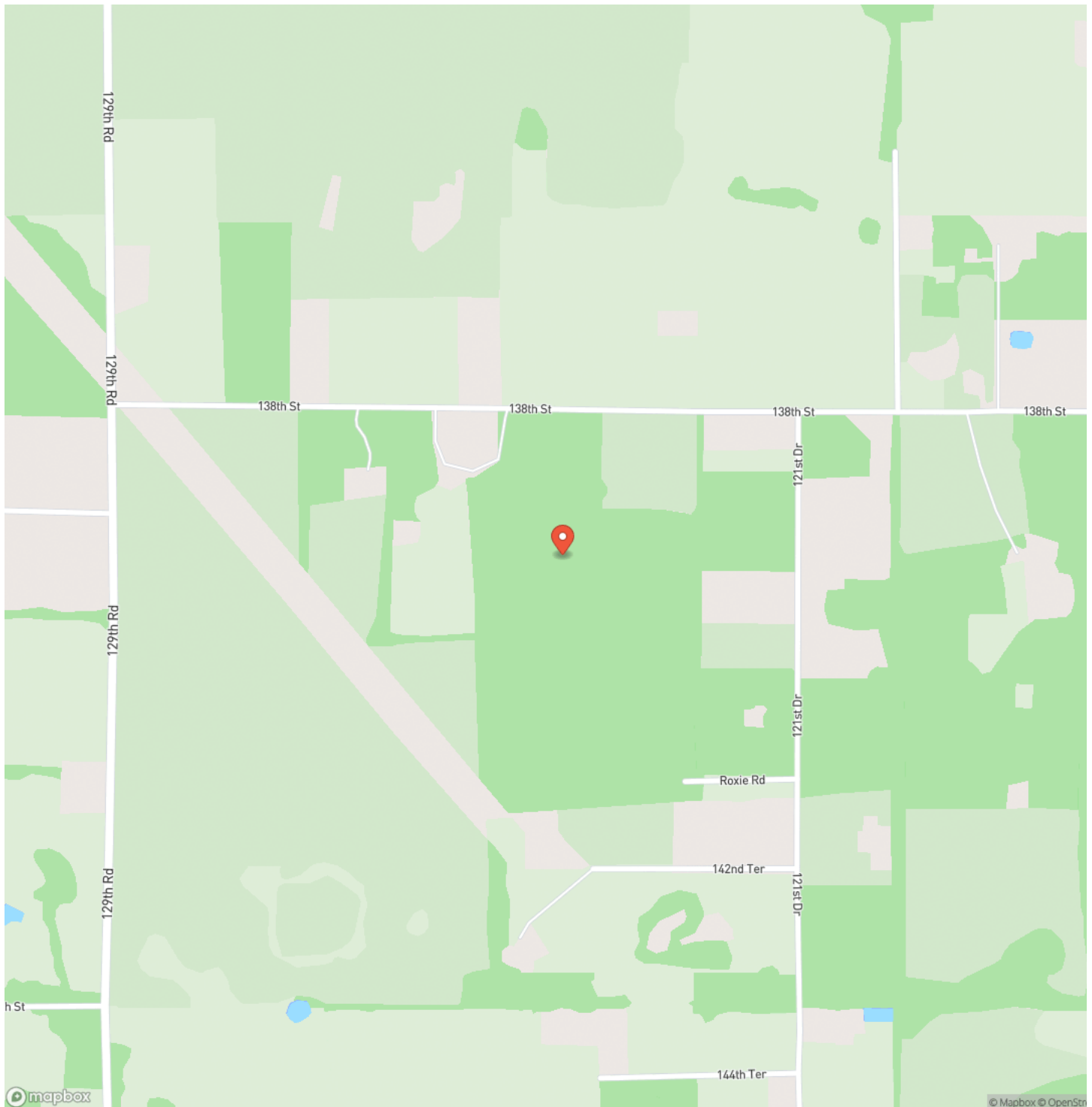

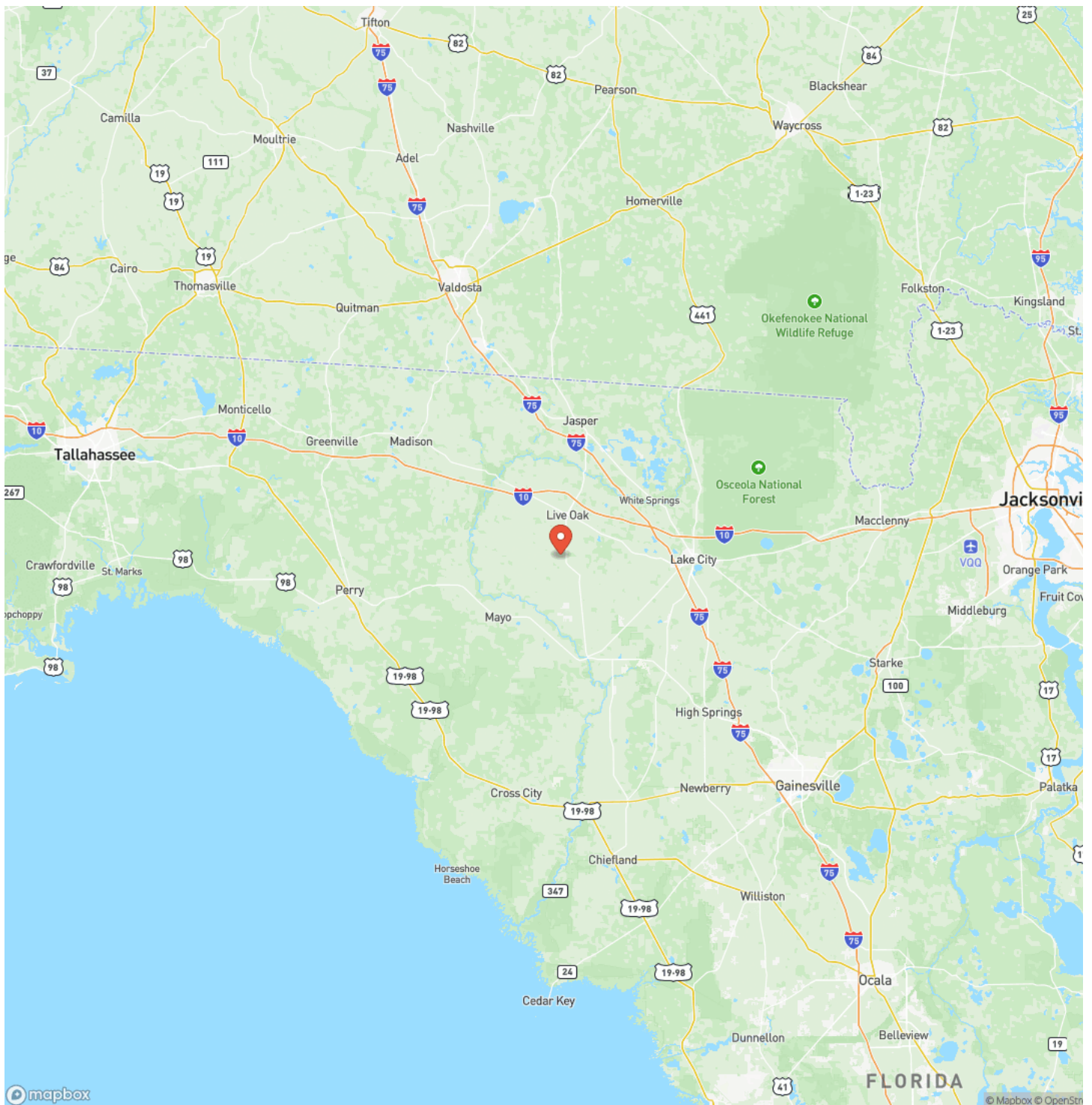

Locator Map

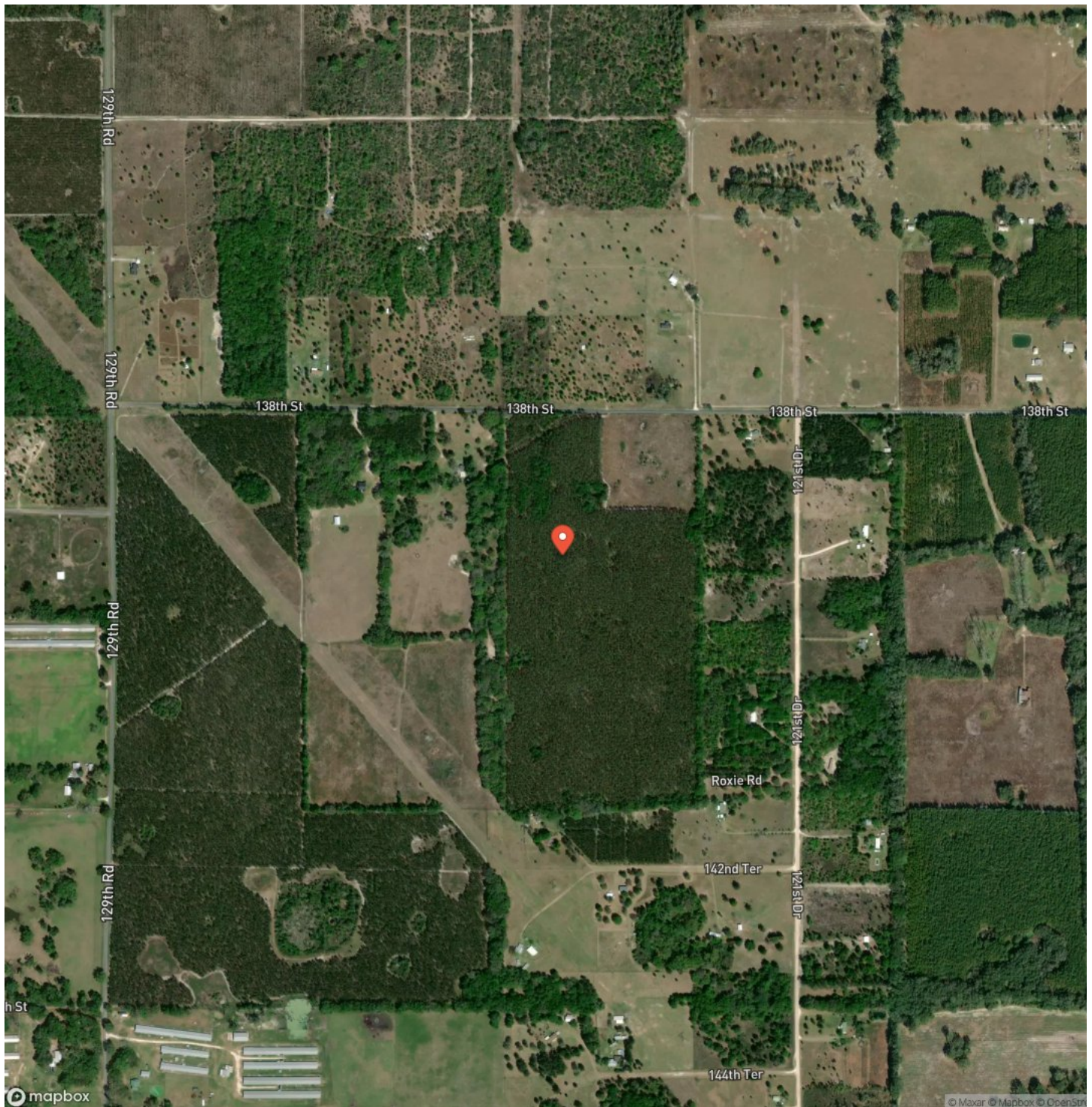
