Locator Map

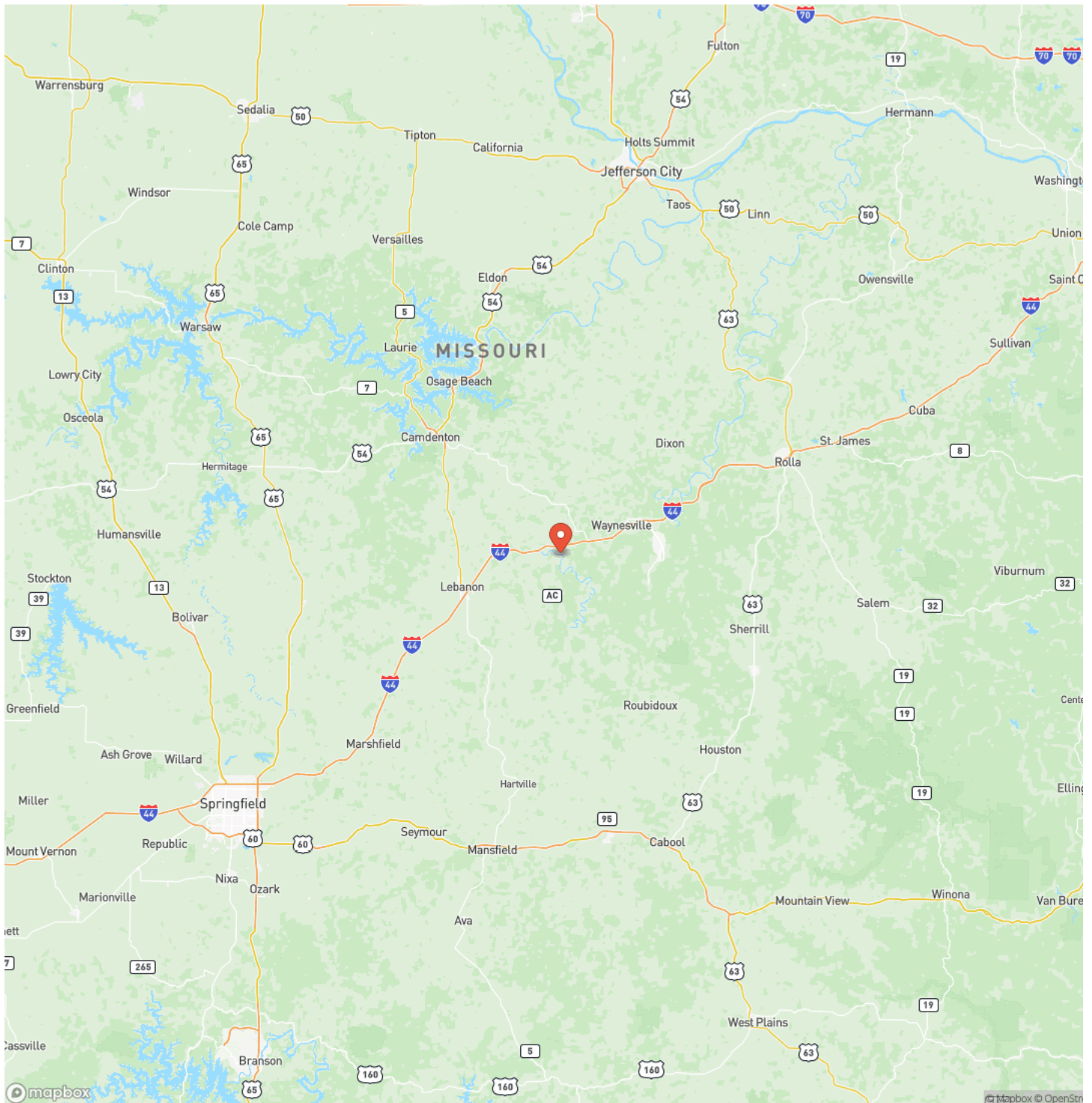
