### **PROPERTY DESCRIPTION**

Wilson Creek Ranch is one of the most diverse ranches that has been on the market in South Central Oklahoma in many years. With nearly 200' of elevation change from tall limestone ridge-tops down oak laden canyons into big hardwood bottom. There is an older two-story ranch cabin perched atop a scenic overlook with 270 degree views to East, South and West, as well as a newly remodeled foreman's home and large barn near the front gate. There are many small ponds scattered across the ranch, but the real water potential is in the lake building sites found on the property. These range from just a normal pond in the 1-2 acre size, all the way up to the ability to construct a 10 to 25 acre large and deep lake. The potential lake sites are the upper tributary creeks which form into Wilson Creek, a direct tributary to Lake Texoma. This area near Lake Murray with many thousands of acres timber and cover on large landholdings is known for holding and producing exceptional whitetail deer.
