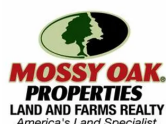

Mecklenburg County was organized on March 1, 1765, after splitting from Lunenburg County in 1764 by an act of the Virginia General Assembly. As settlement expanded and the population grew, the legislature divided Lunenburg into three counties: Lunenburg, Charlotte, and Mecklenburg. The county was named in honor of Charlotte of Mecklenburg-Strelitz, a British queen of German origin.

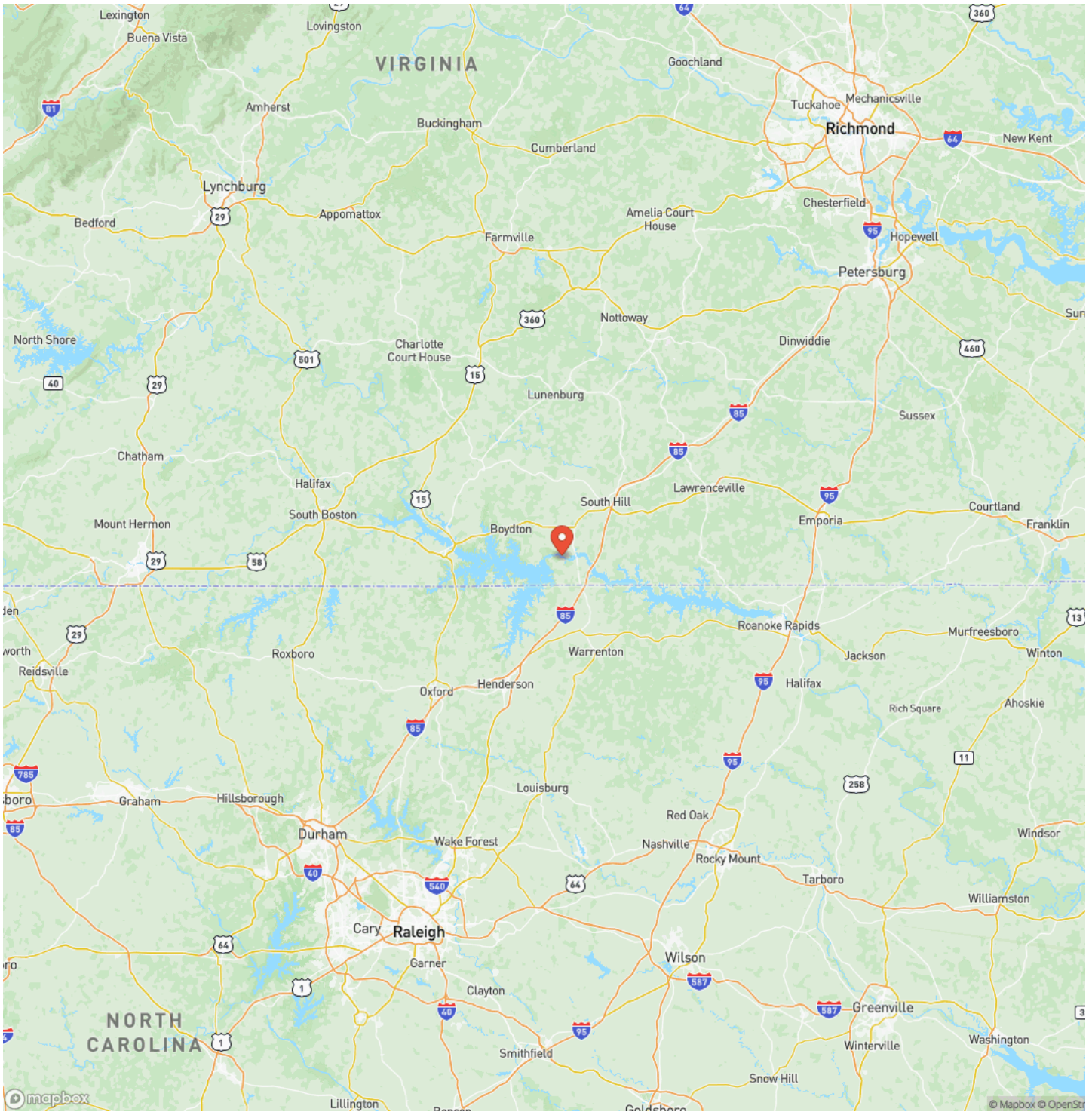


Locator Map
