A historic jail cell for safe storage and a suana for relaxation are tucked away in one of the basements to add to the hidden amenities. Two stocked ponds sit near the house, ready for fishing and relaxation, while fruit trees and meticulously landscaped grounds add to the charm of the expansive yard.

Designed for entertaining, the home features a custom cedar bar and lounge in the basement as well as a party dock on the pond—perfect gathering spaces for family and friends.

For the outdoor enthusiast, this property truly shines. A network of trails wind through mature timber, open areas along the creek provide opportunities for recreation or food plots, and the land holds a rich history with hundreds of Native American artifacts discovered here—including a rare Archaic-period single-face quartz hourglass banner stone.

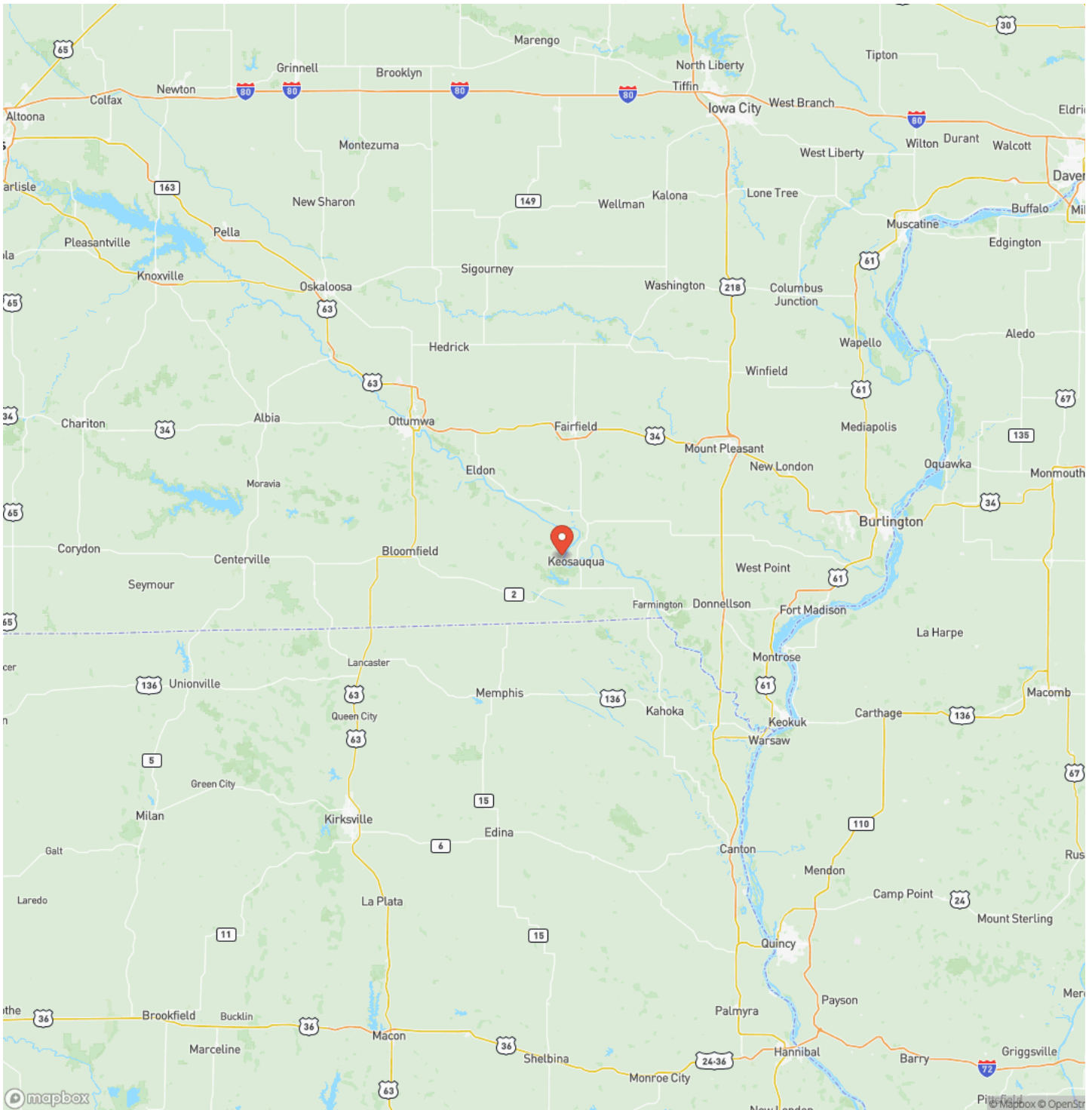
## Locator Map
