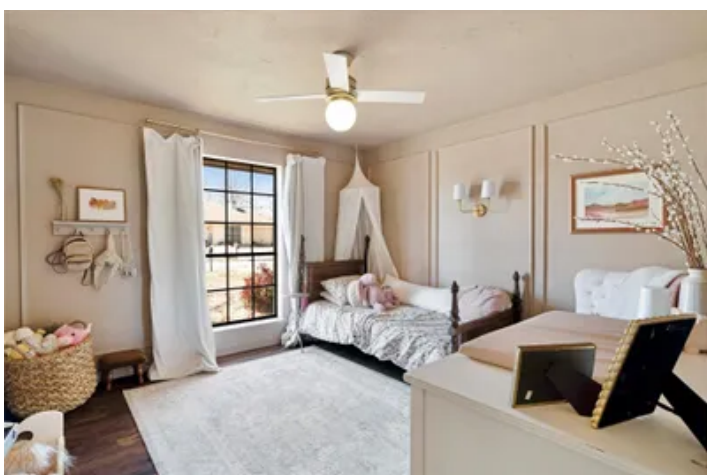

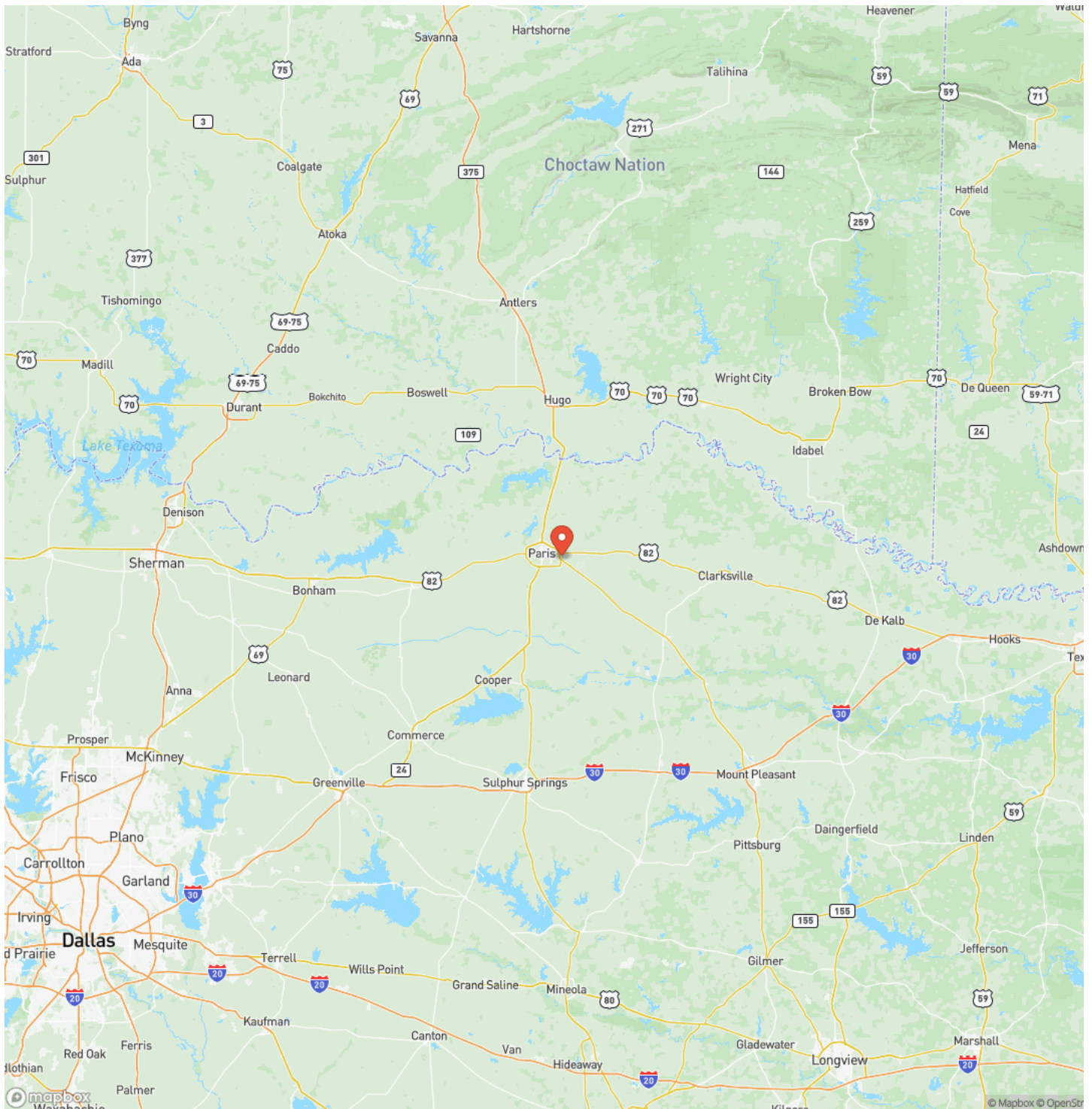


Locator Map

Locator Map

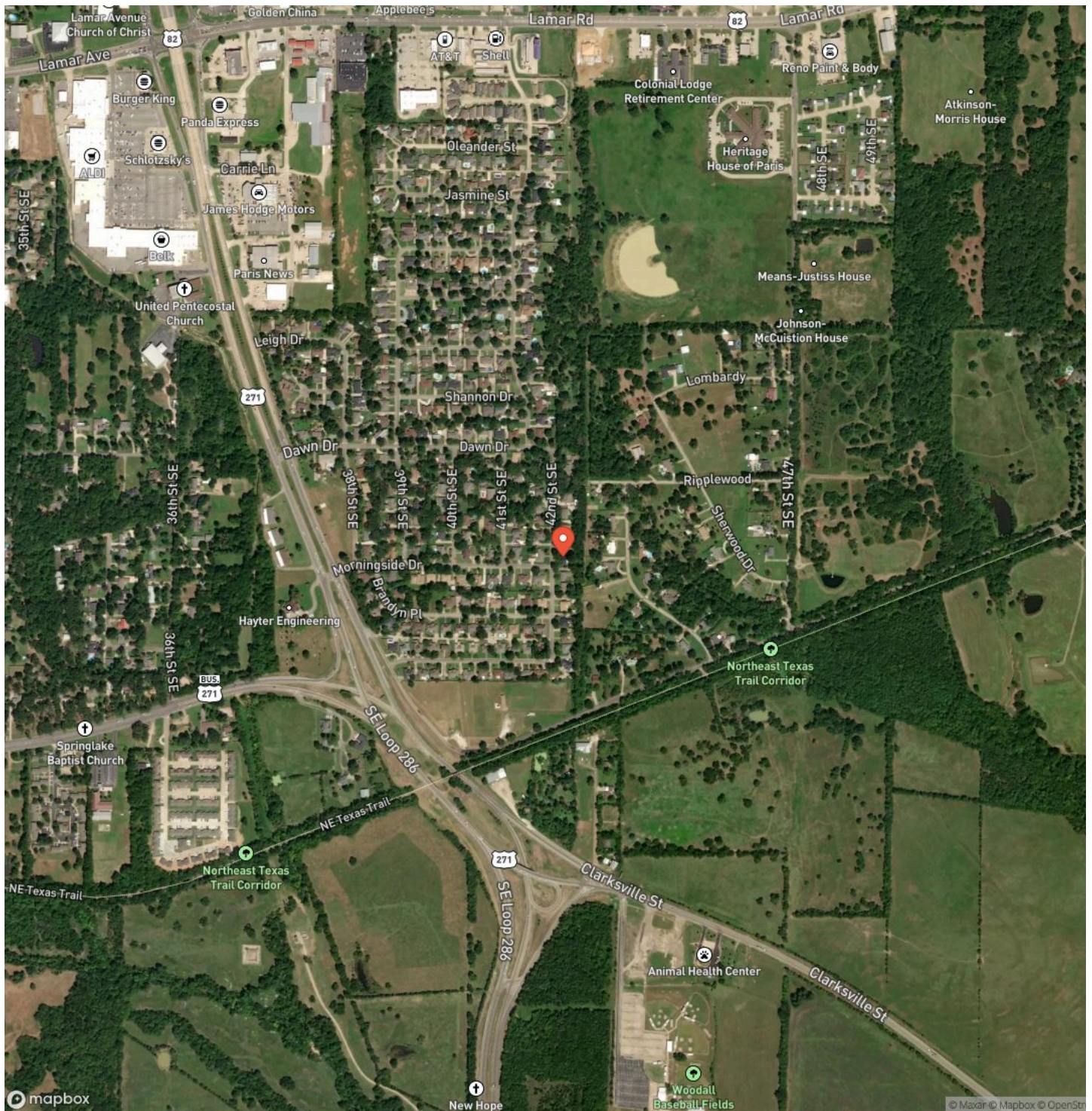
