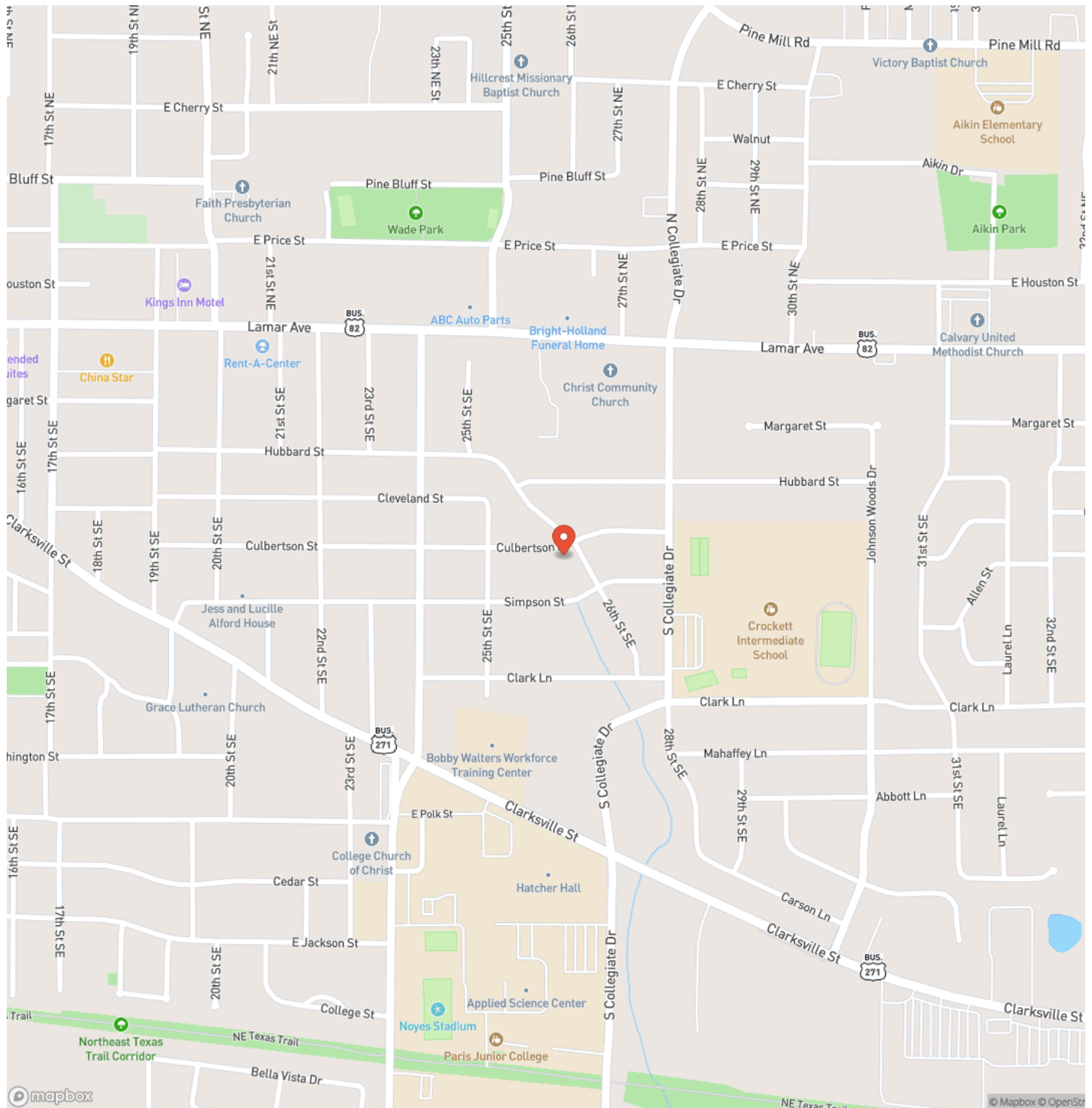

Locator Map

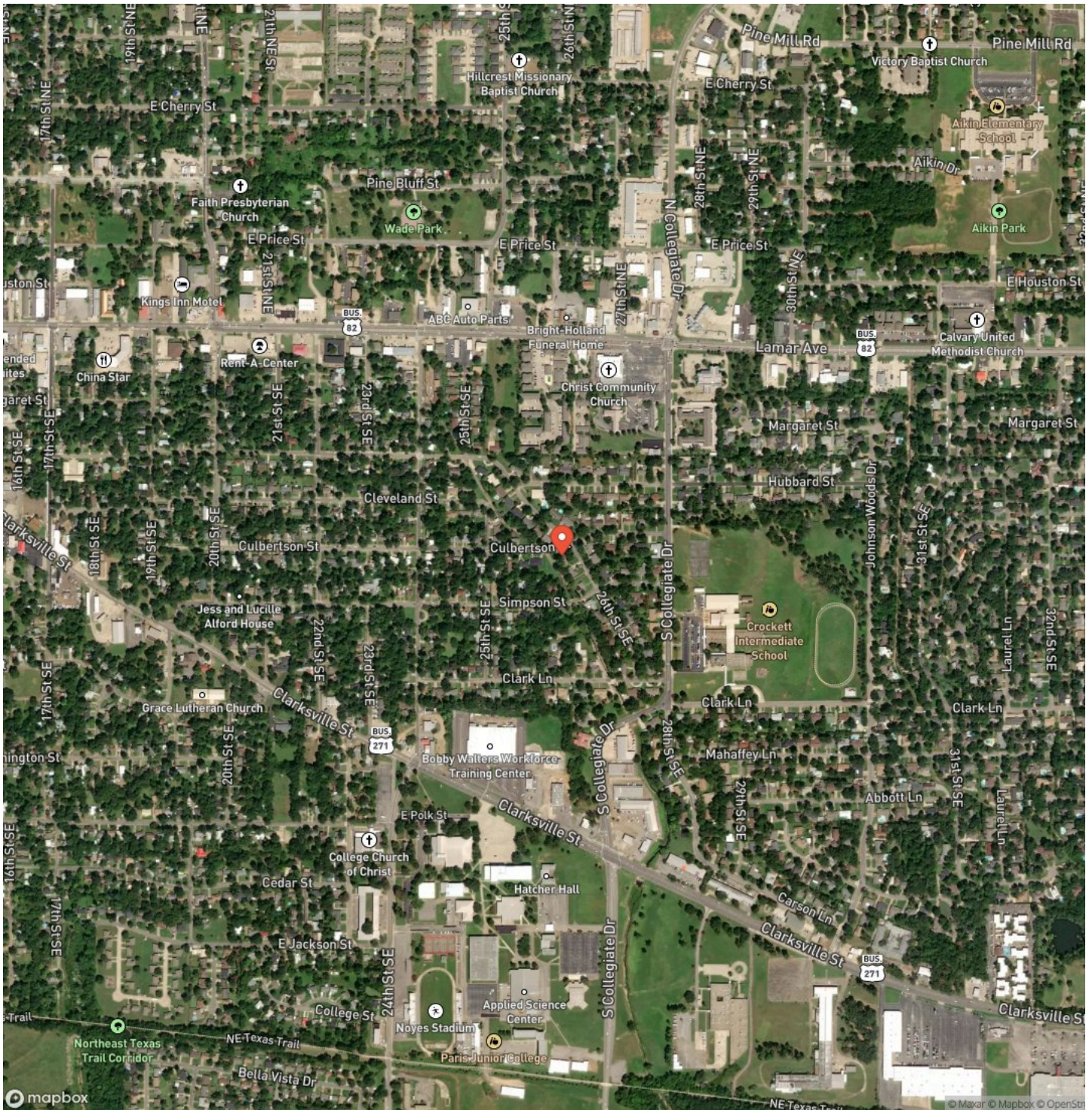
