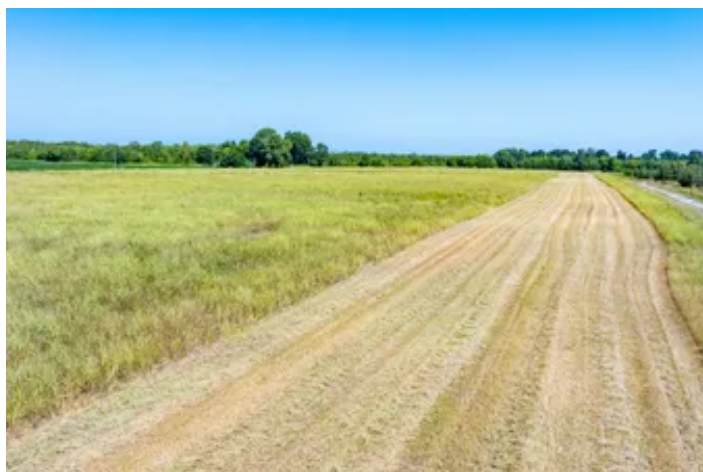

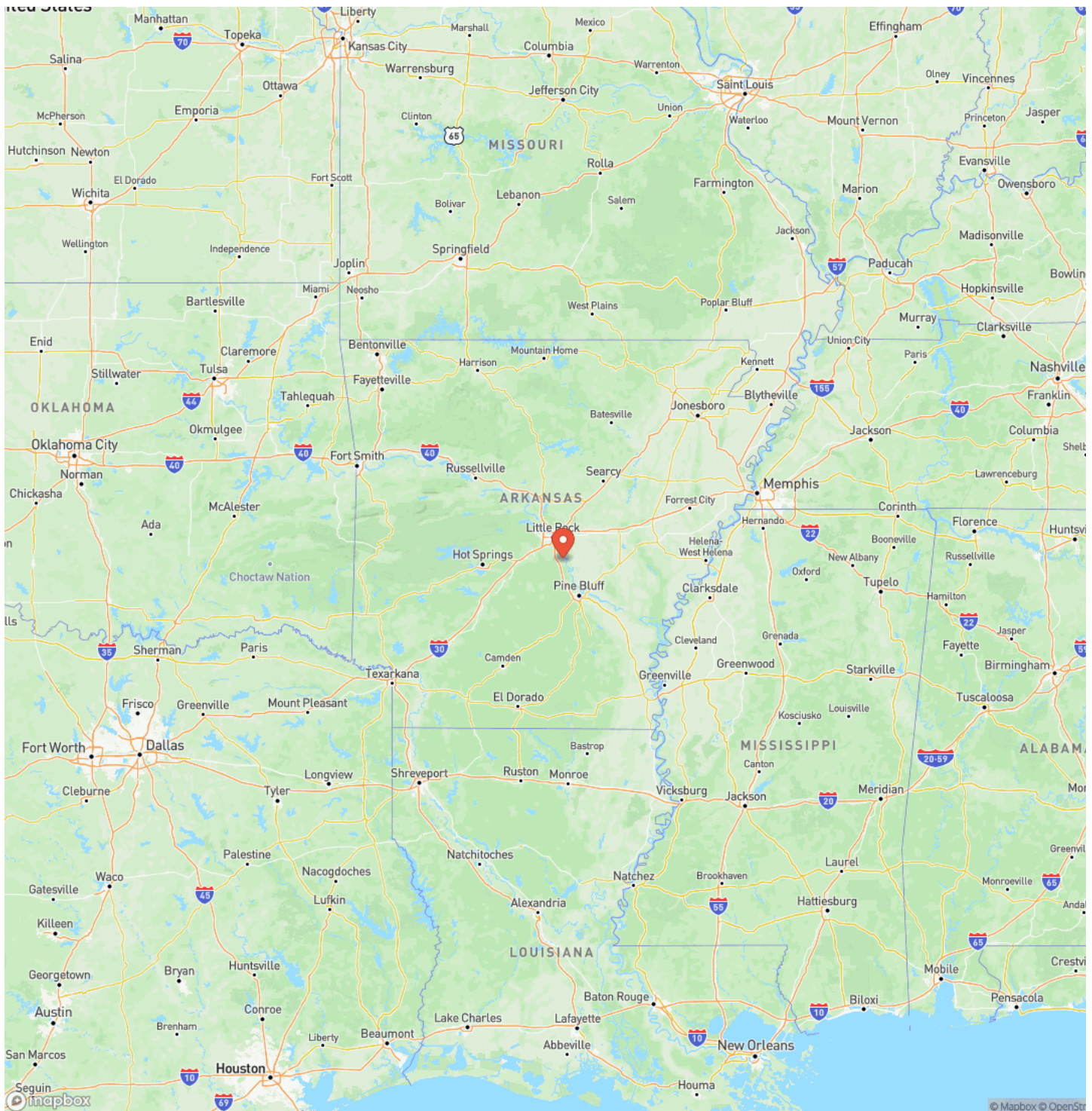

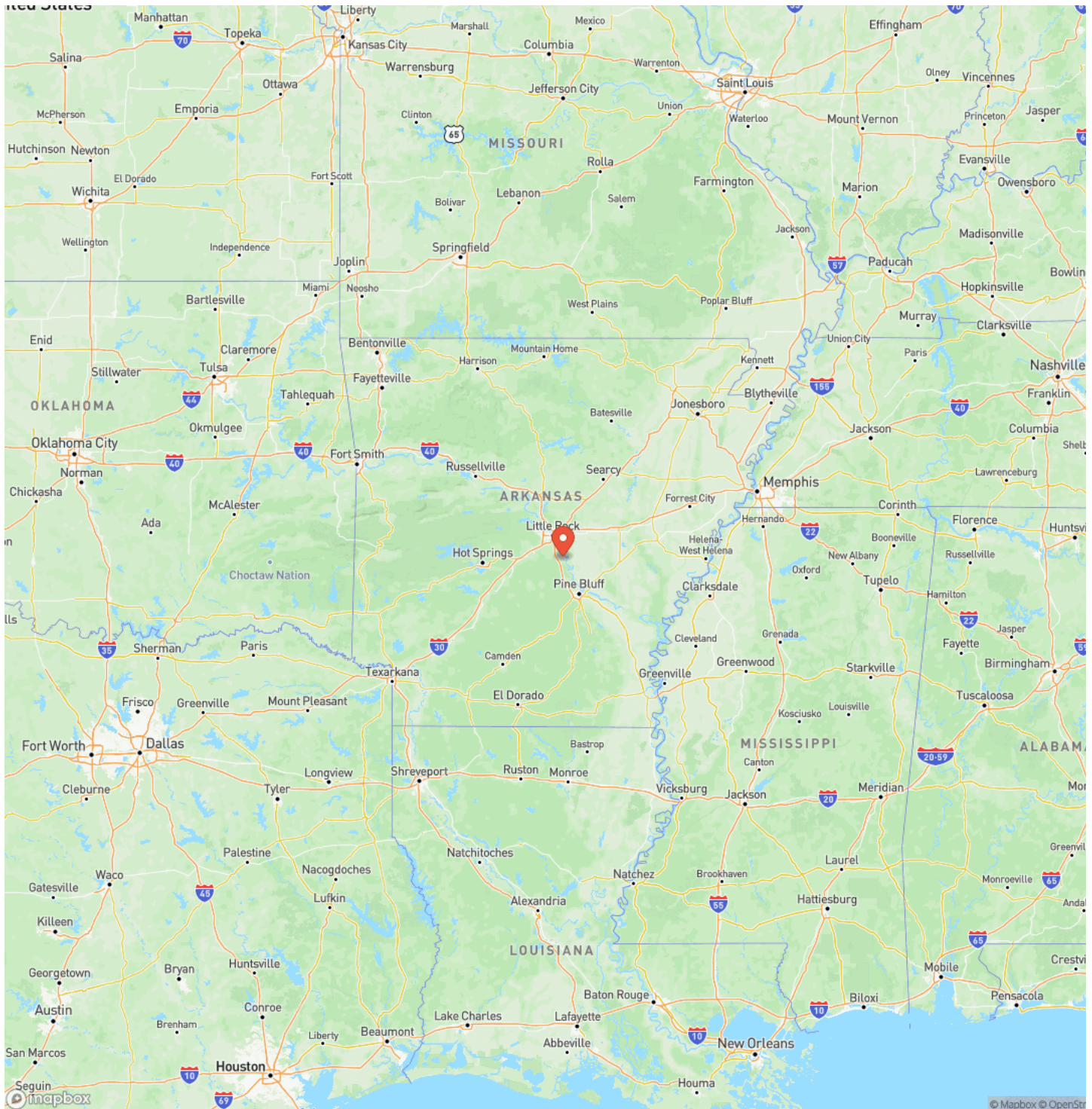

Locator Map



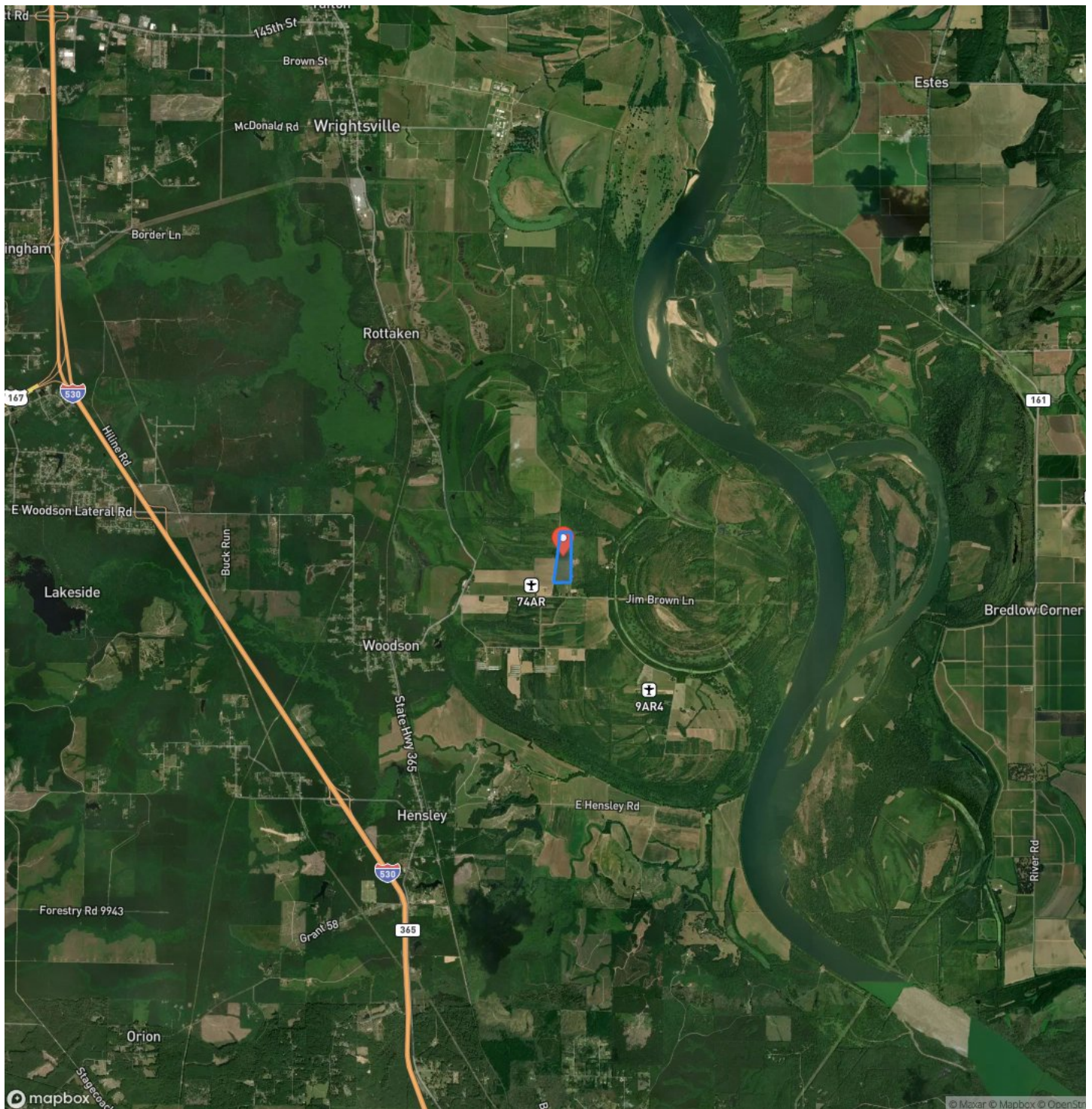
