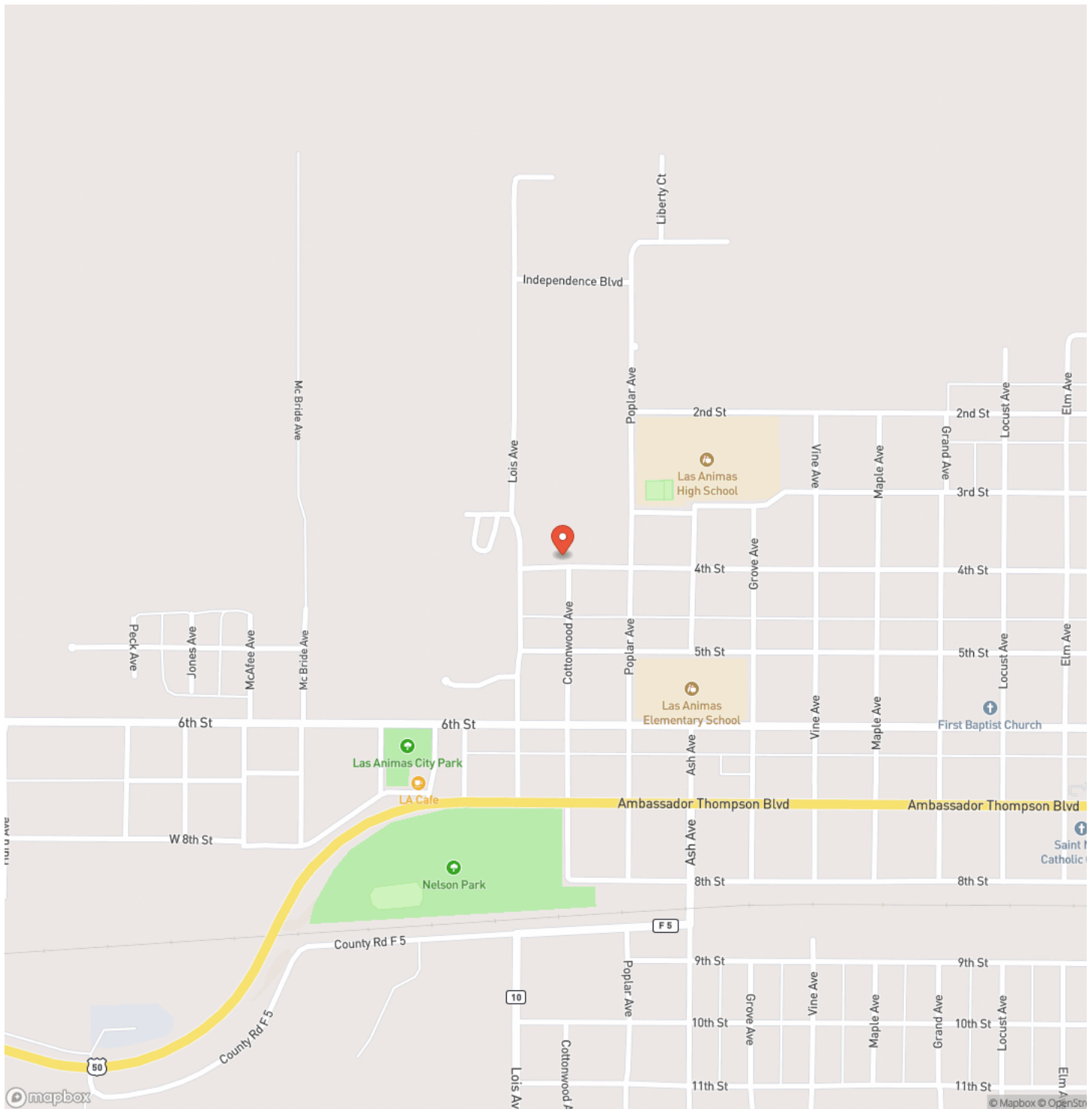
PROPERTY DESCRIPTION

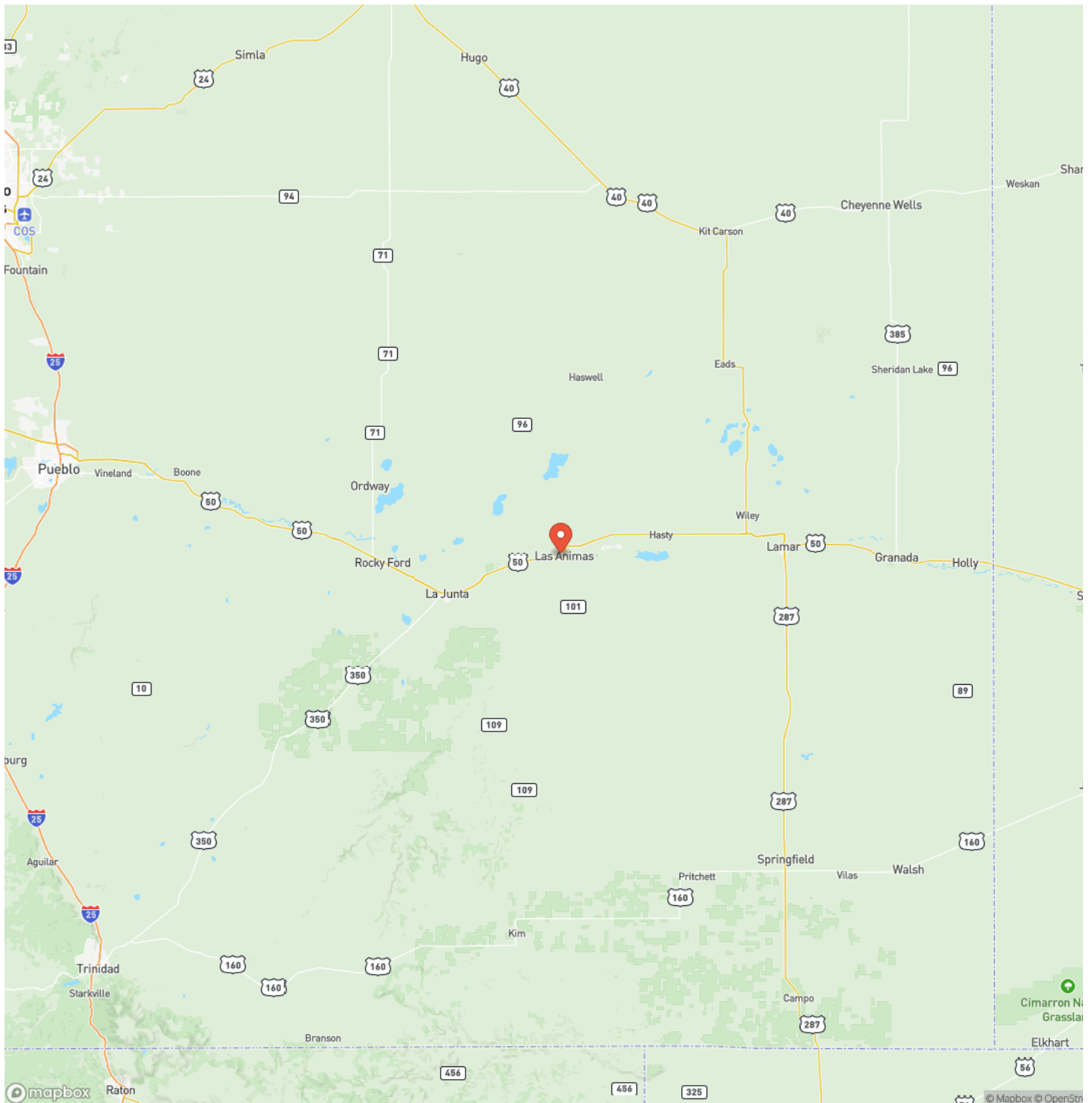
