This ranch has a vast array of native vegetation providing excellent habitat for wildlife with a dense canopy of large harwood trees, brush and browse. Trees include Live Oak, Post Oak, Blackjack Oak, Elm, Sugar Hackberry, mesquite and some Juniper. A wide variety of brush and browse within the dense hardwoods provide excellent feeding and bedding areas for wildlife.

A nice pond sits in the far NE corner of the ranch providing a constant water source for wildlife and livestock. There is a small seasonal pond and several natural drainages for additional ponds or a small lake. There is electricity and an older set of working pens at the front of the property. A well will need to be drilled for domestic water and underground water seems to be readily available with nearby wells recorded in the 300-400 ft ranch and producing +/- 20 GPM.

This is an excellent ranch for the avid hunter, outdoor explorer and enthusiast or someone looking from a quiet place in the country to build a home.
