A south-facing driveway and improved county road for year-round access. Inside, the cabin welcomes you with an open-concept living, dining, and kitchen area, a striking spiral staircase connects the two levels, adding architectural interest and charm. The main bedroom showcases French doors opening

directly to mountain views, 3/4 bath and large walk-in closet complete the second floor. The custom-built king-size bed will convey. The property includes three outbuildingstwo storage sheds plus a dedicated craft shed complete with windows, built-in shelving, and a skylight, perfect for creative pursuits, hobbies, or a private workspace. A wood picnic table and chairs invite outdoor dining under New Mexico's wide-open skies.

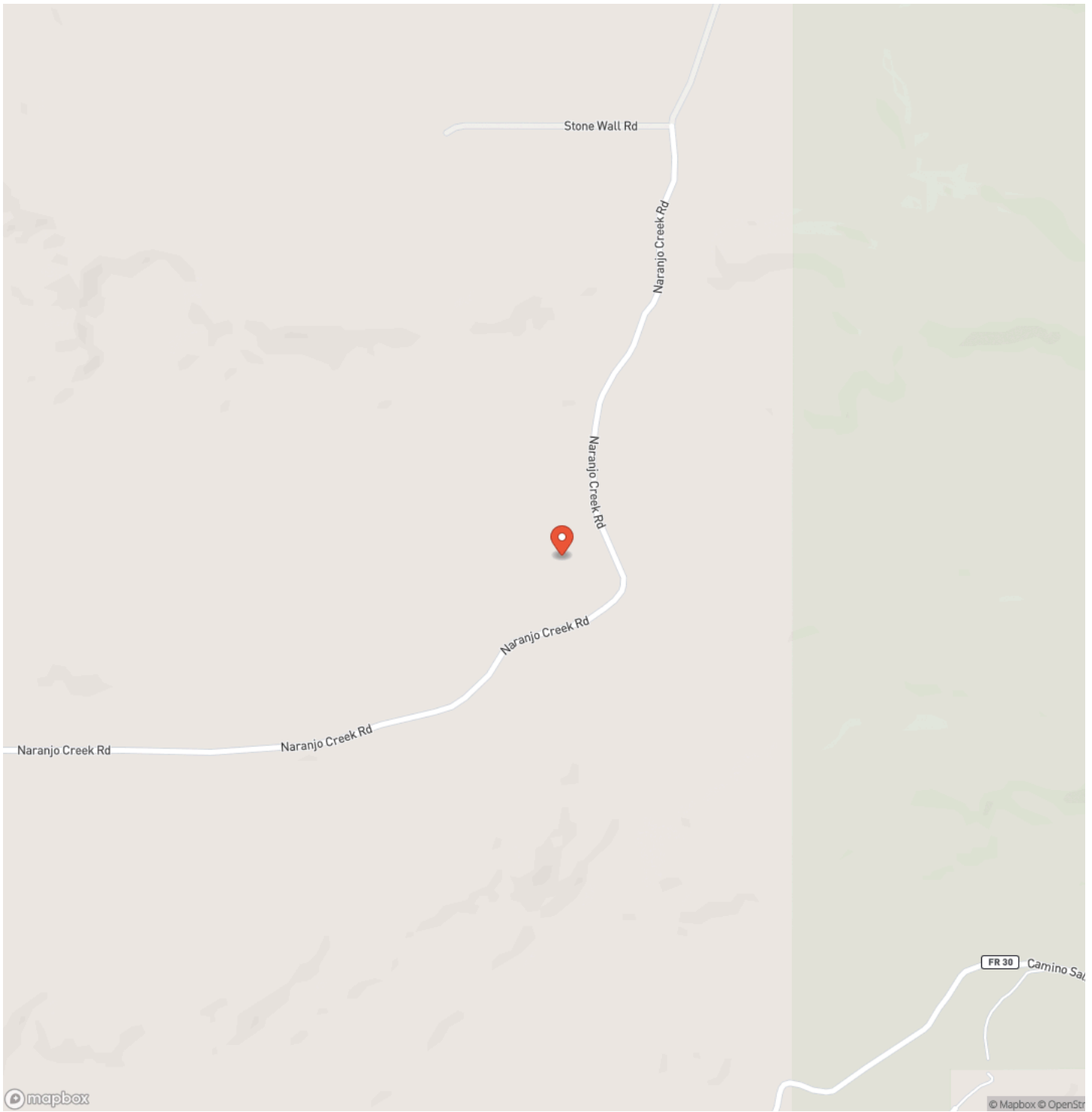

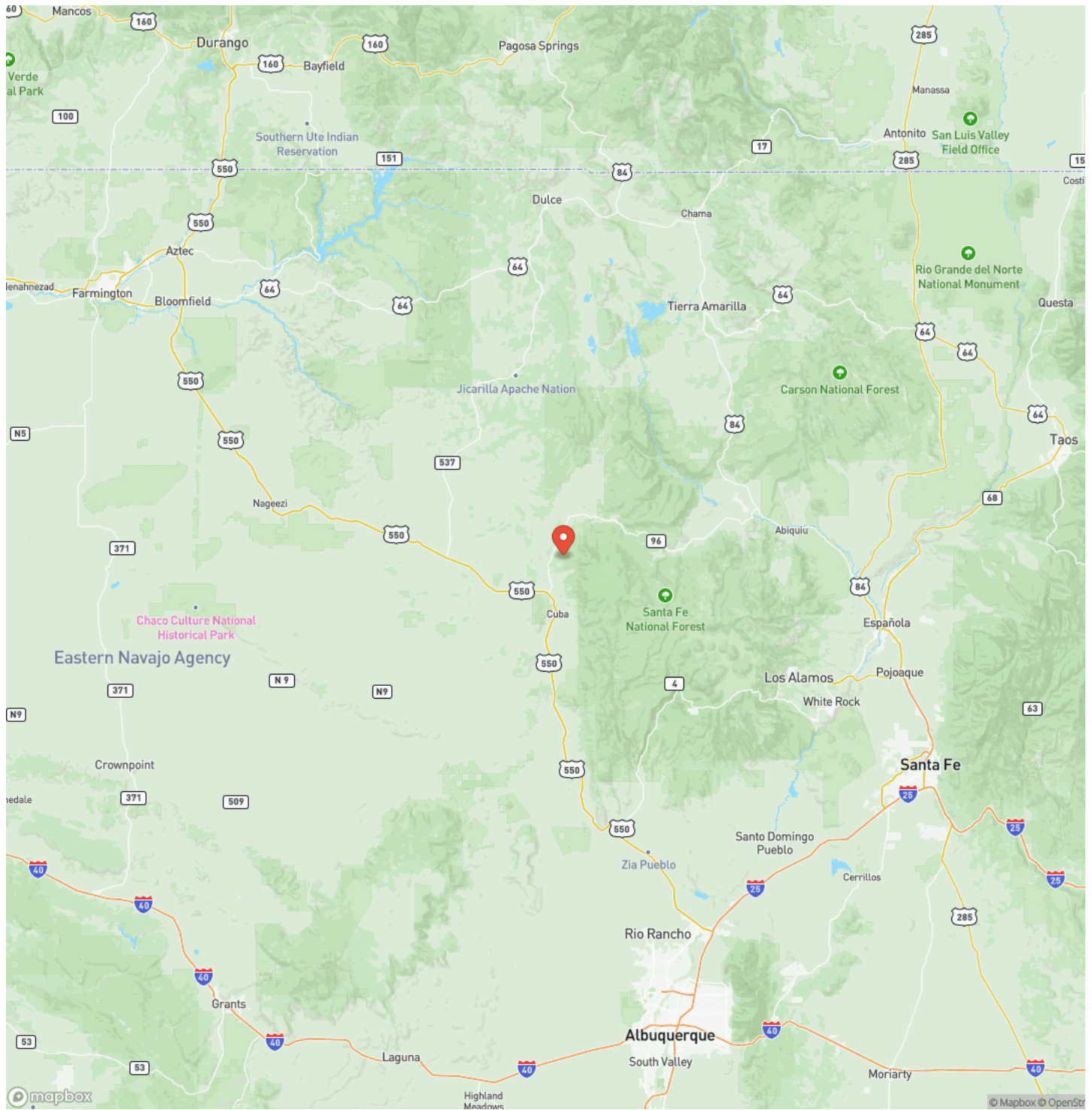


Locator Map

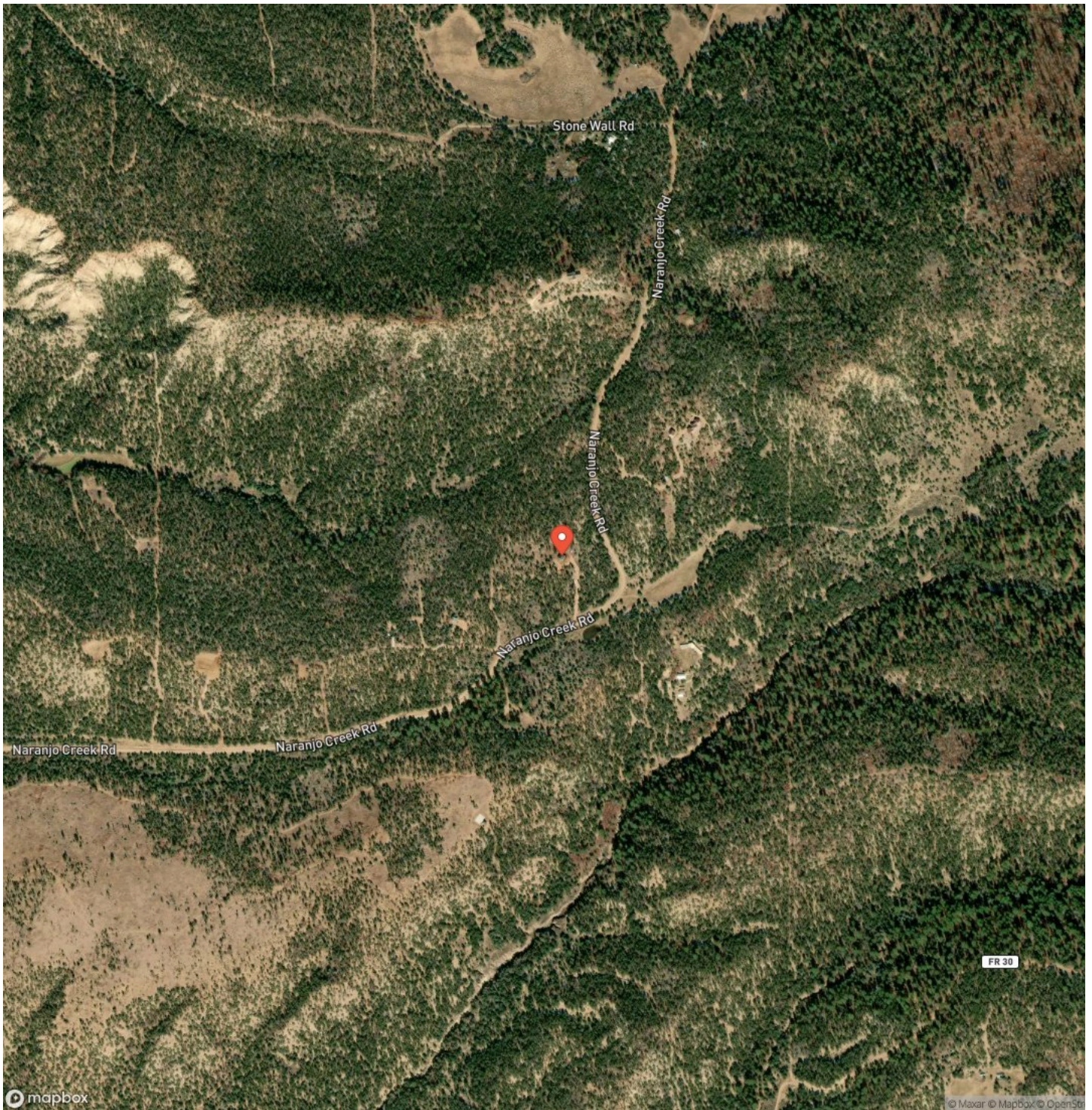
