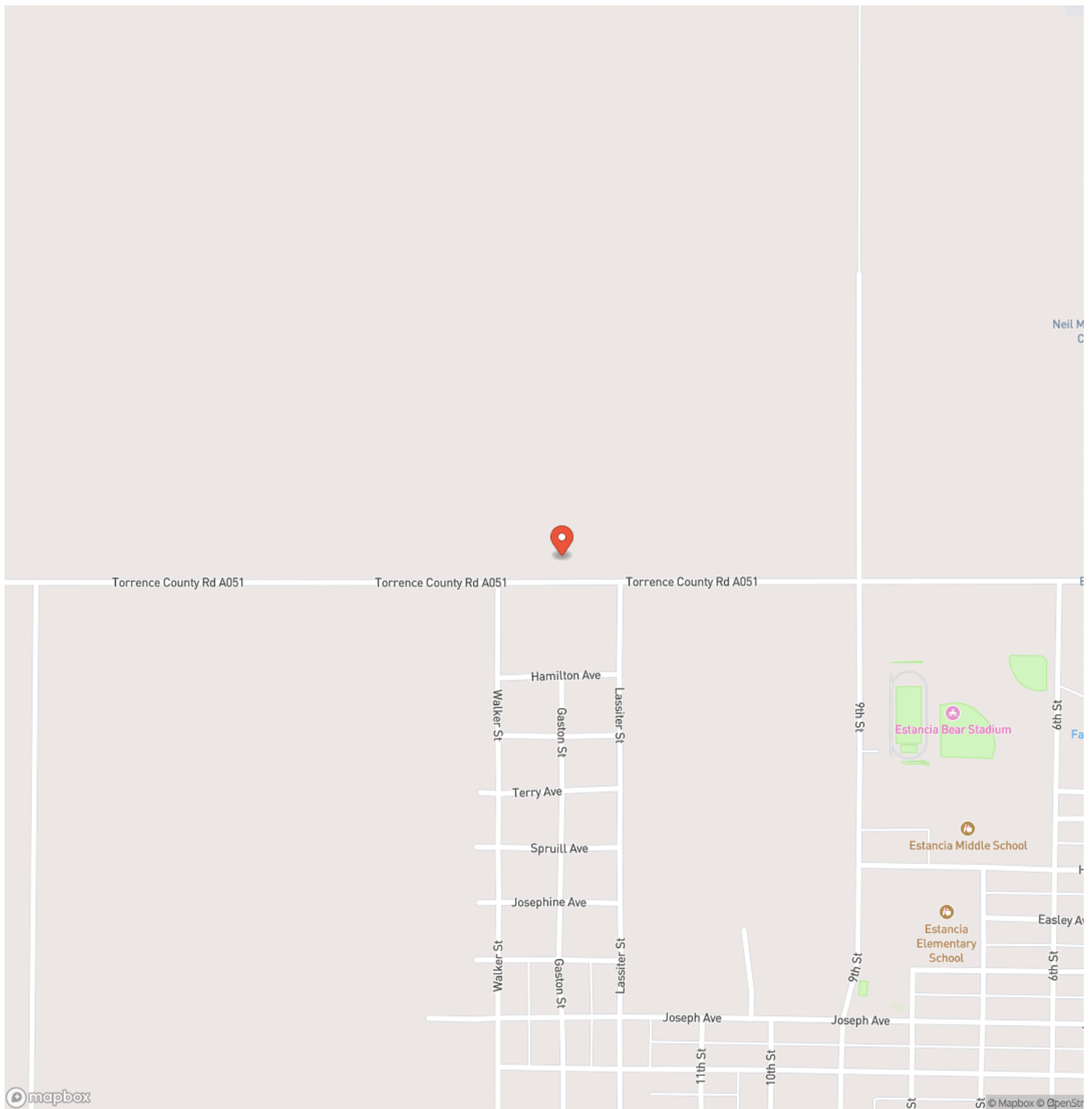
115 KW powerline and substation nearby and a small solar farm just northeast of the property add possibilities for commercial or energy development.

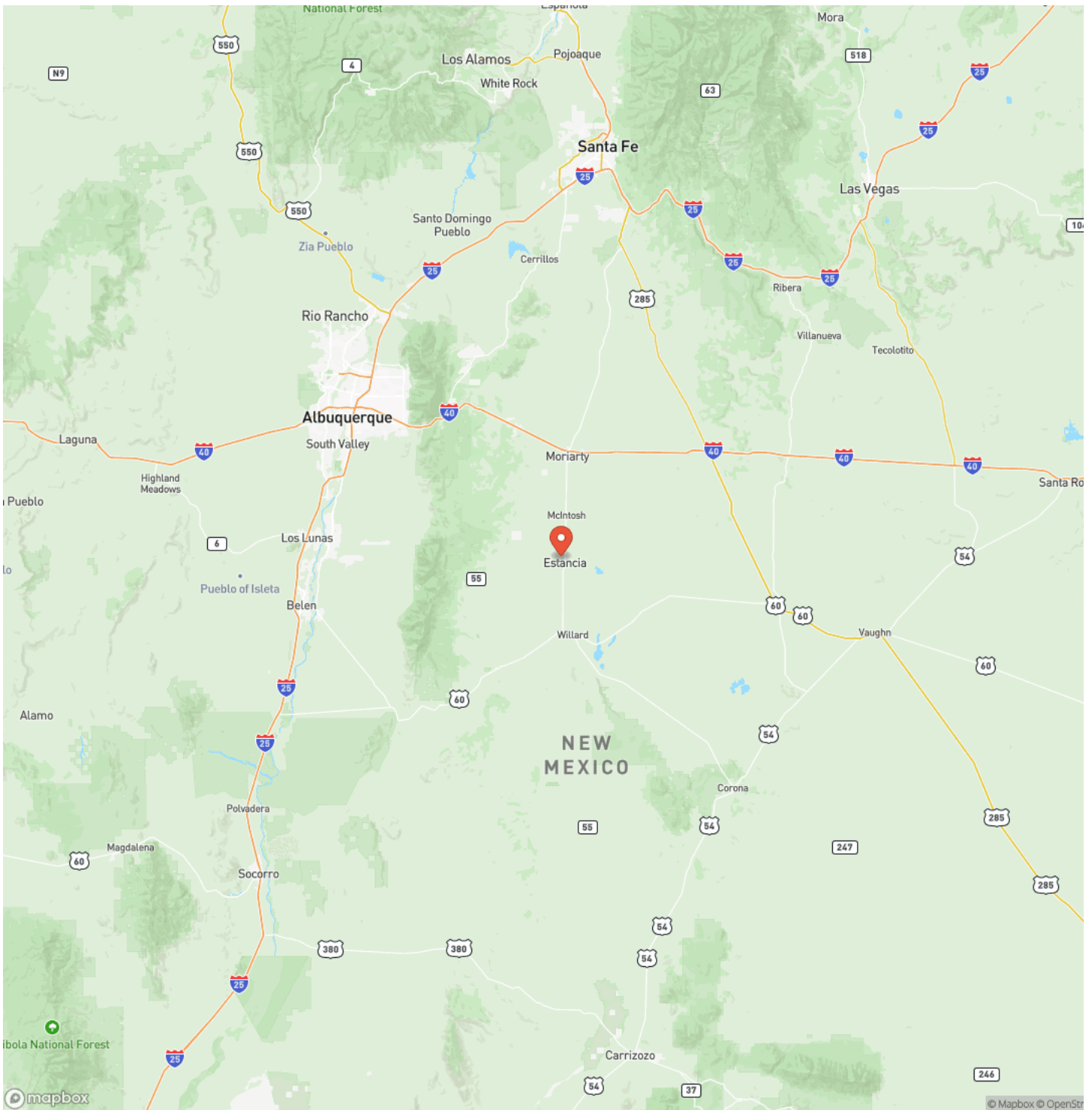

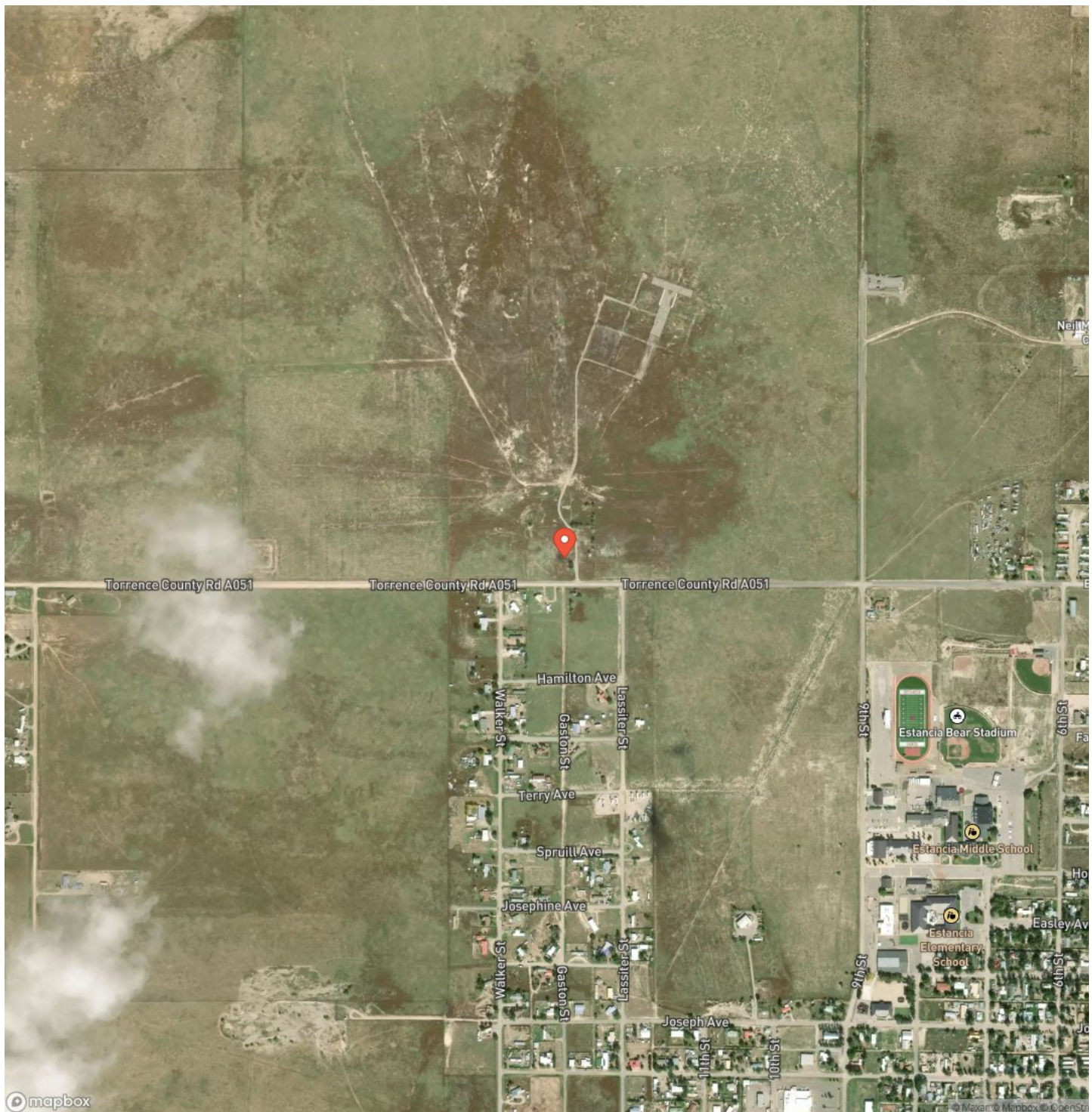
## Locator Map
