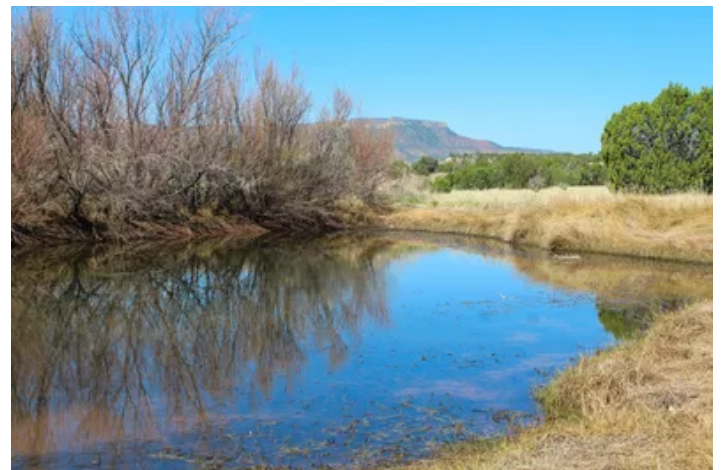

Whether you're looking to build your forever home, set up a private retreat, or invest in a property with flexibility and future potential, this 33-acre gem checks all the boxes.

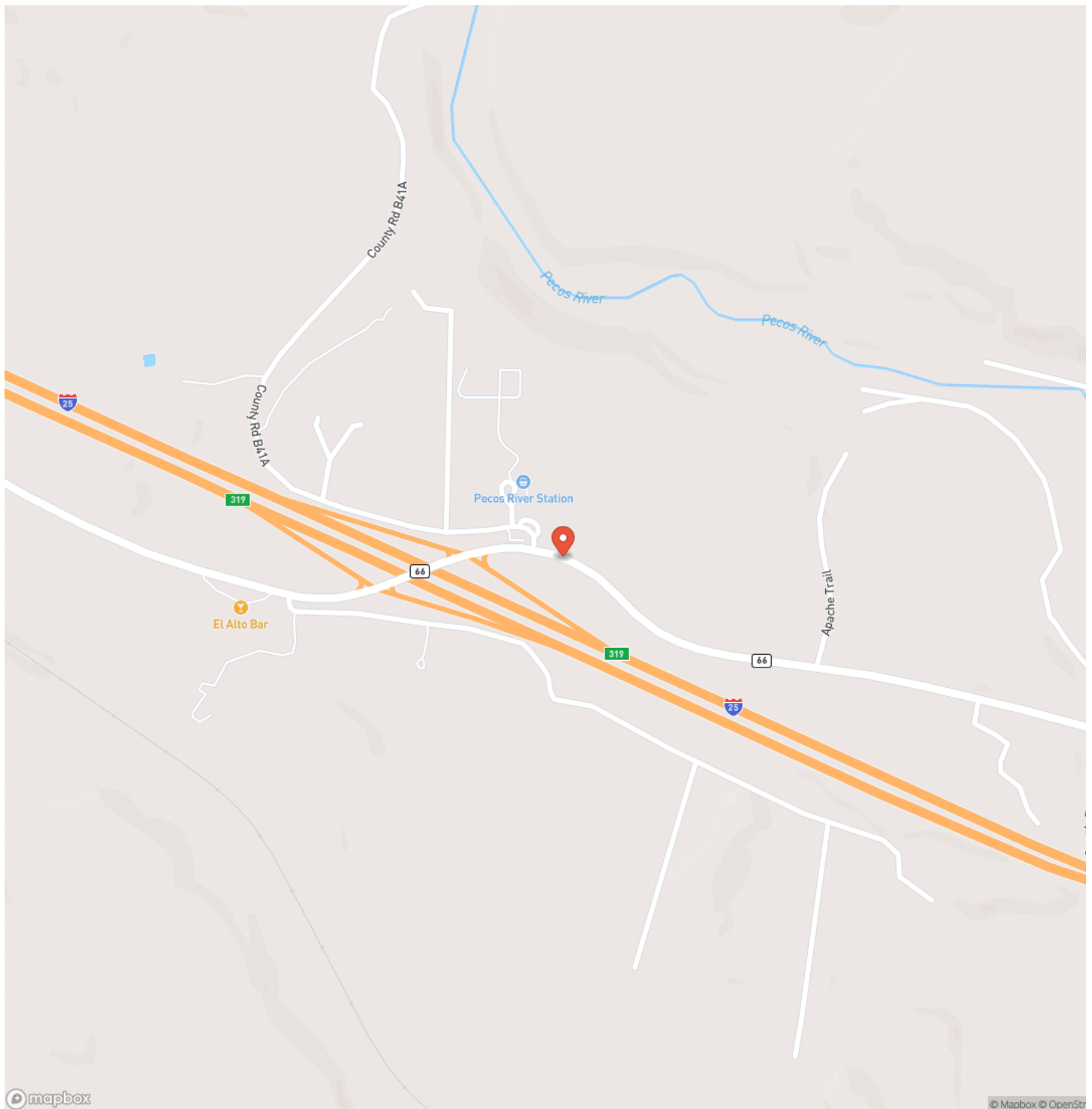

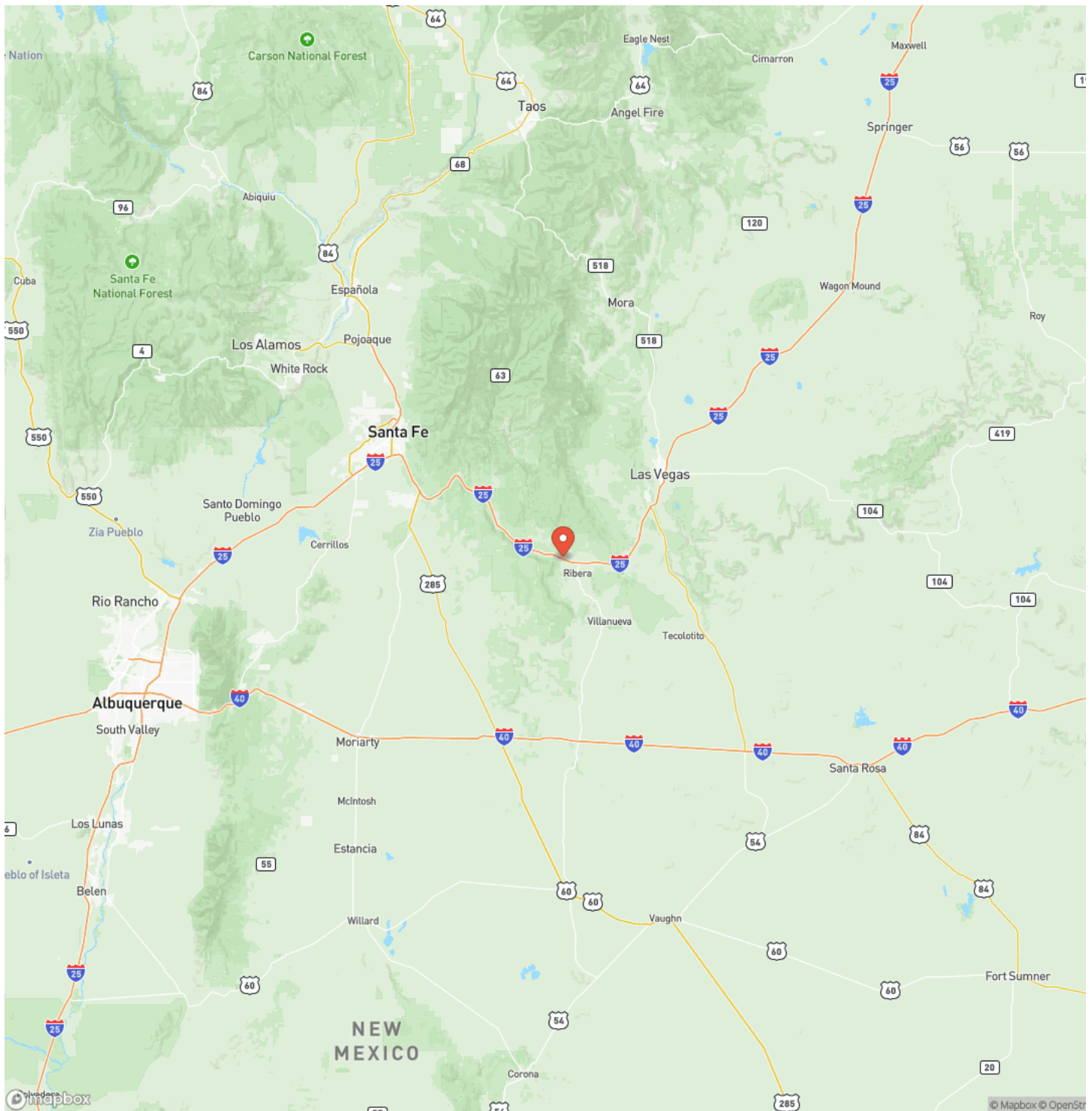
