Property has a diverse terrain from the Almagre Arroyo on the lower end to some rolling hills on the north. Mostly fenced in fair condition barbed wire. Shallow pond located in the arroyo has rushes and sedges indicating water is present most of the time. Great views. Property is currently leased for grazing and borders public land on the West and South. Santa Fe National forest less than 5 miles away. Owner believes they own part of the mineral rights. Located in Game Management Unit 5A. May be eligible for Small contributing ranches Private Land Elk Tags (EPLUS) The ranch has historically received 1 EPLUS tag.
