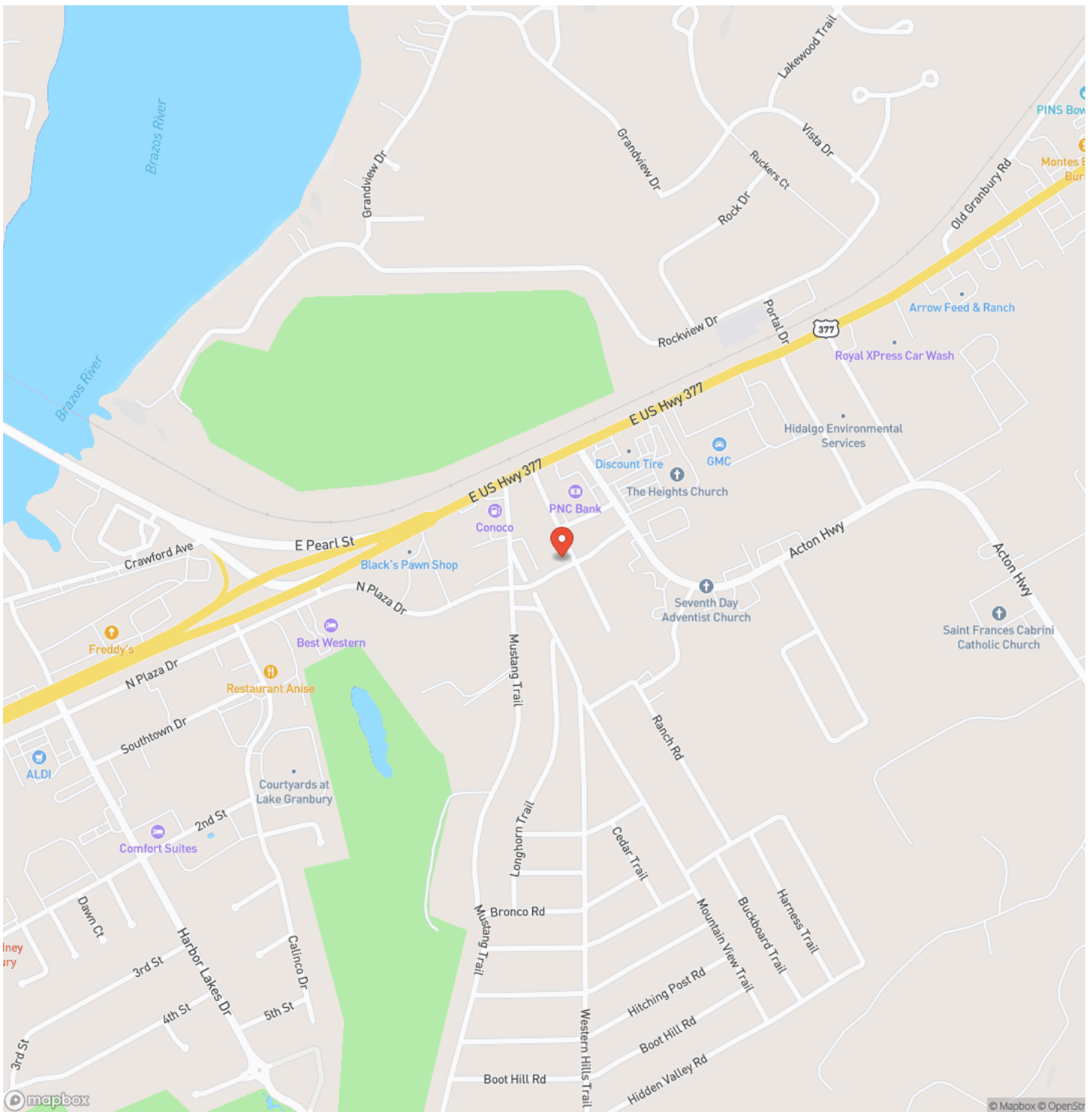




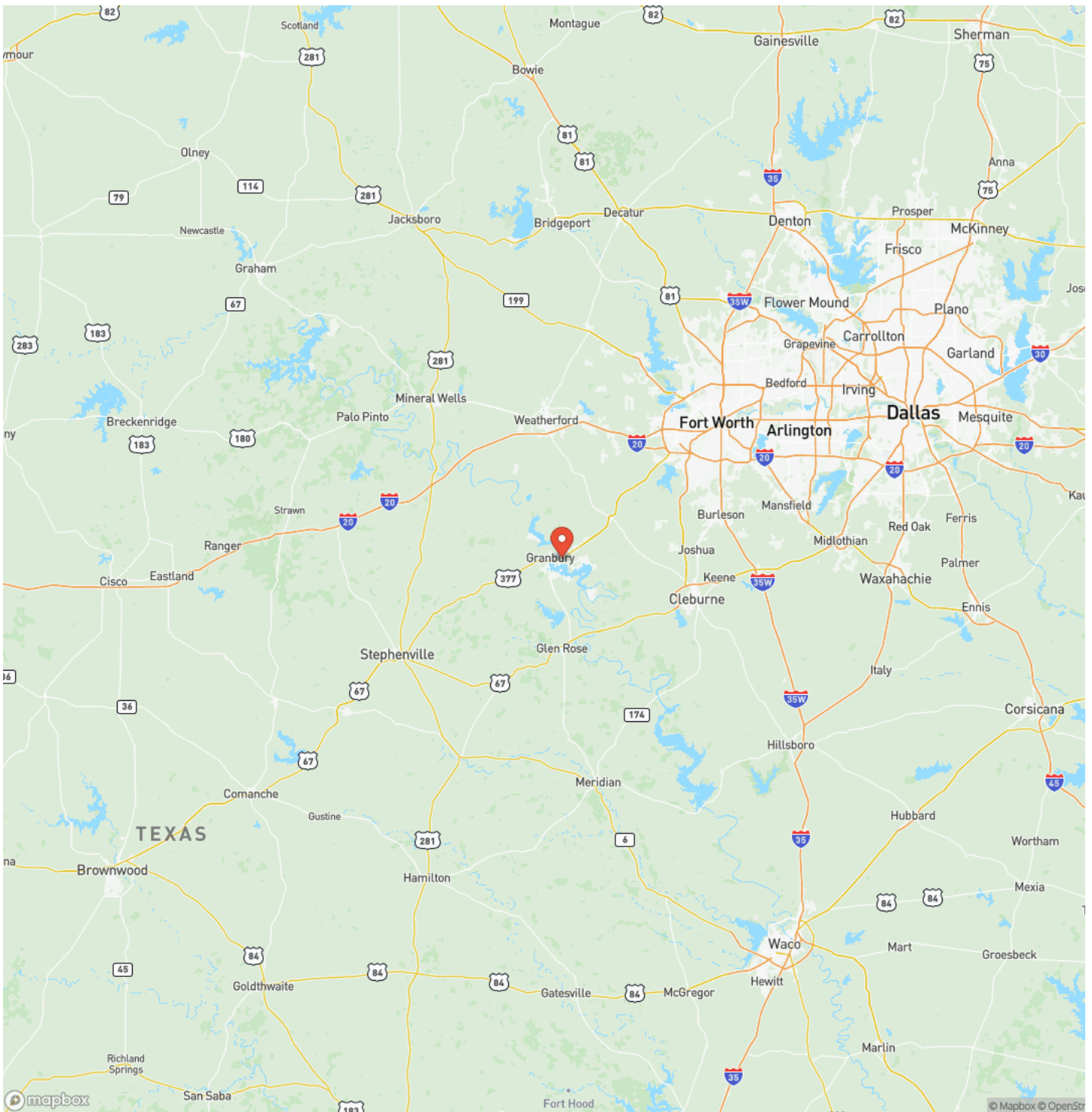

## Locator Map

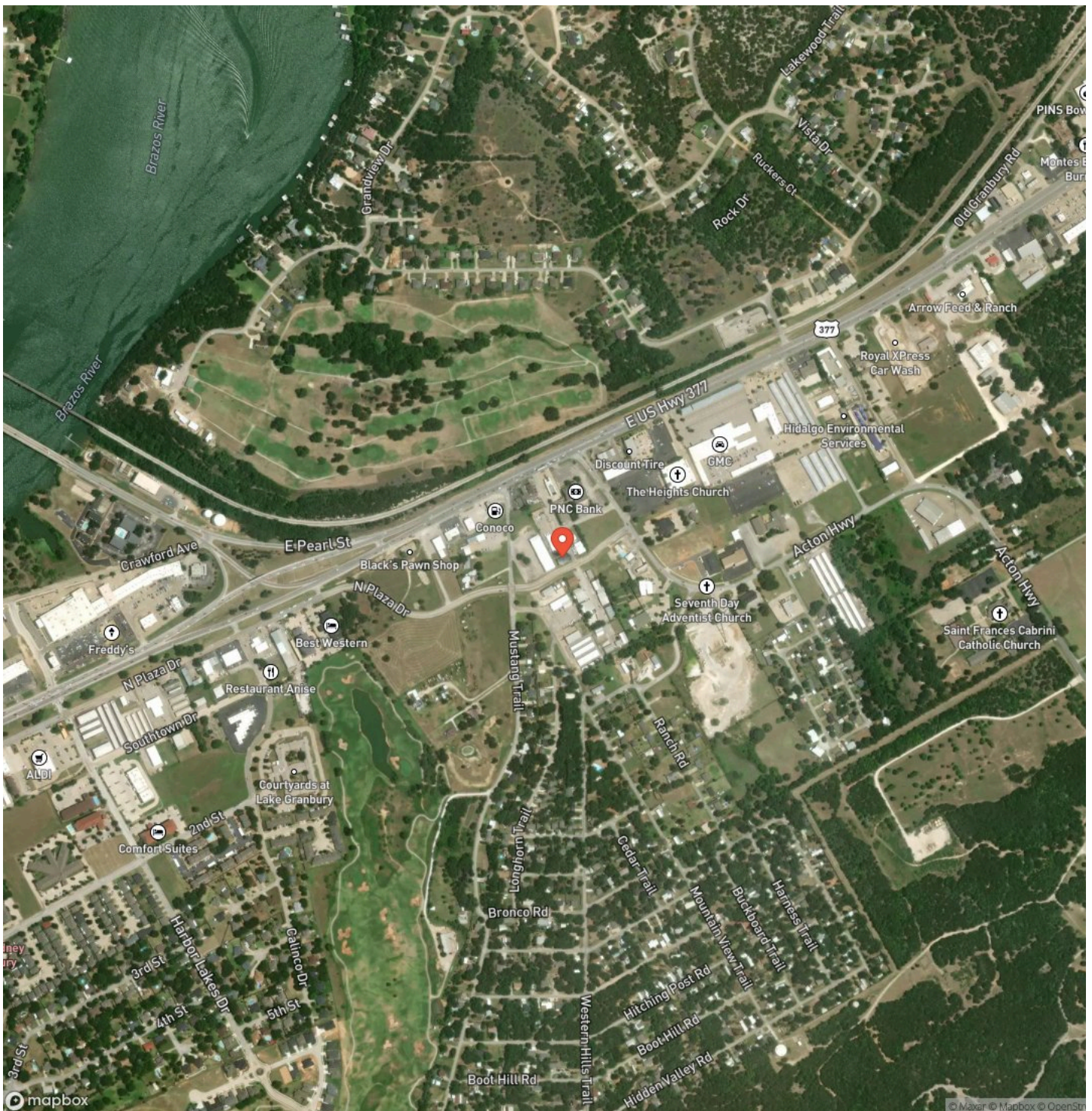
