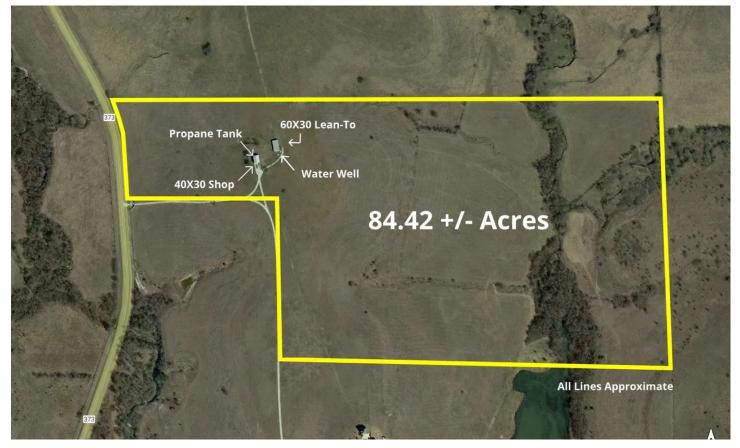

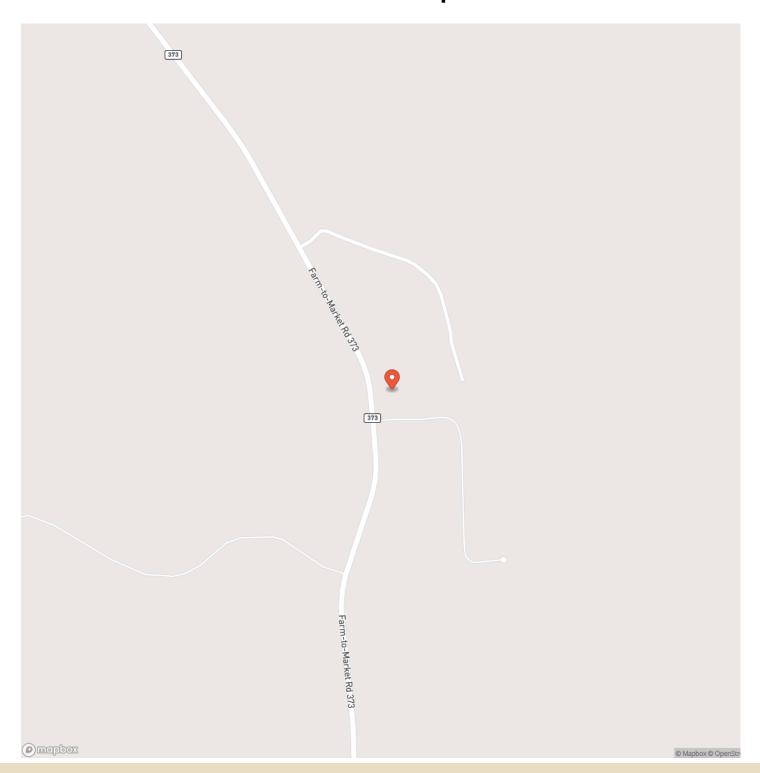






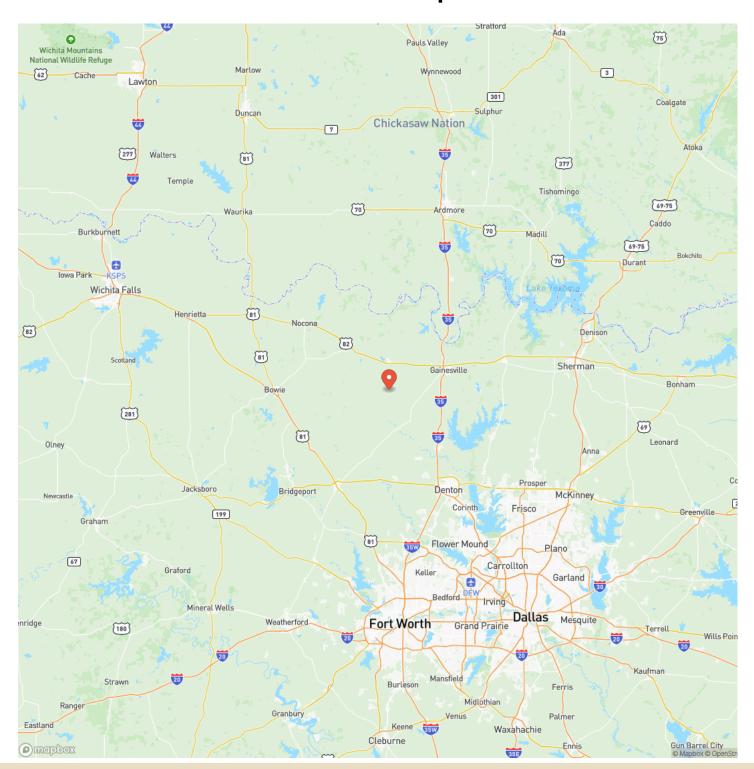


Locator Map





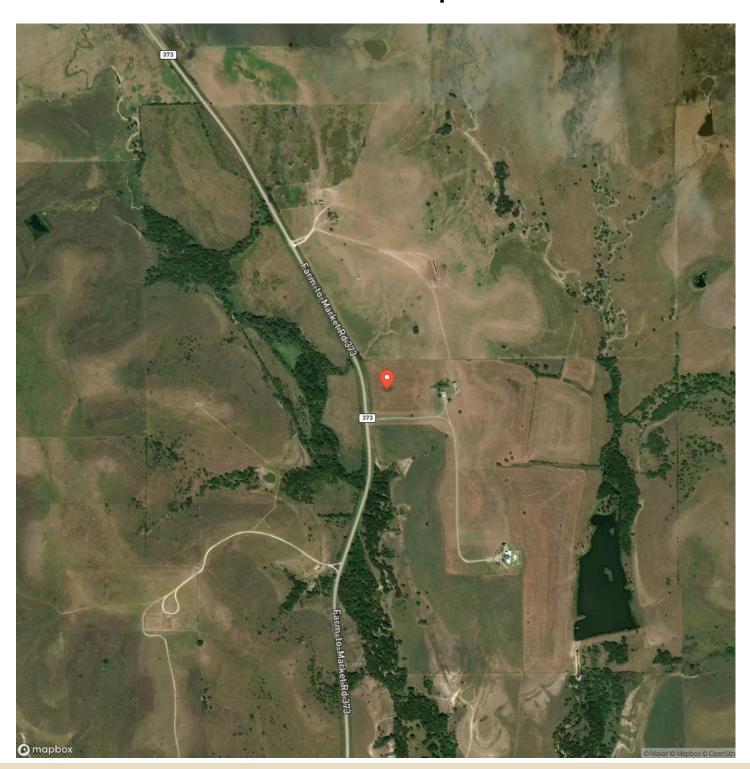
