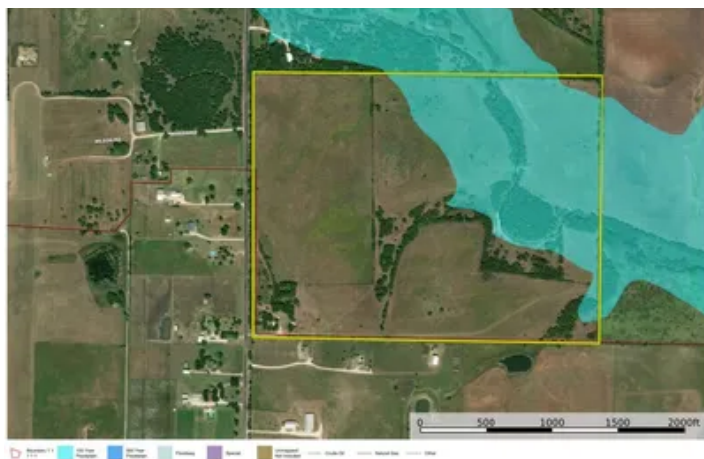

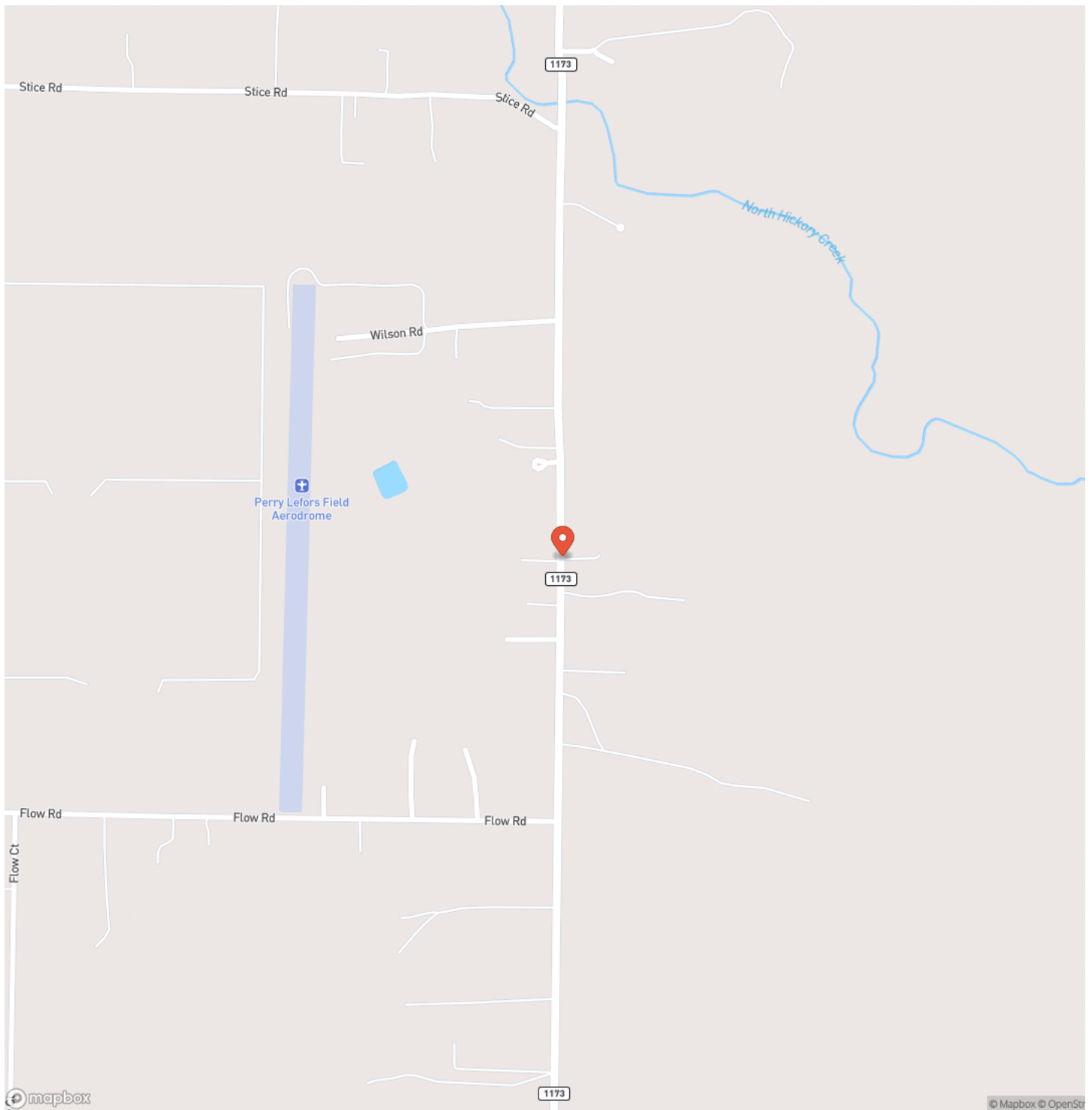
PROPERTY DESCRIPTION

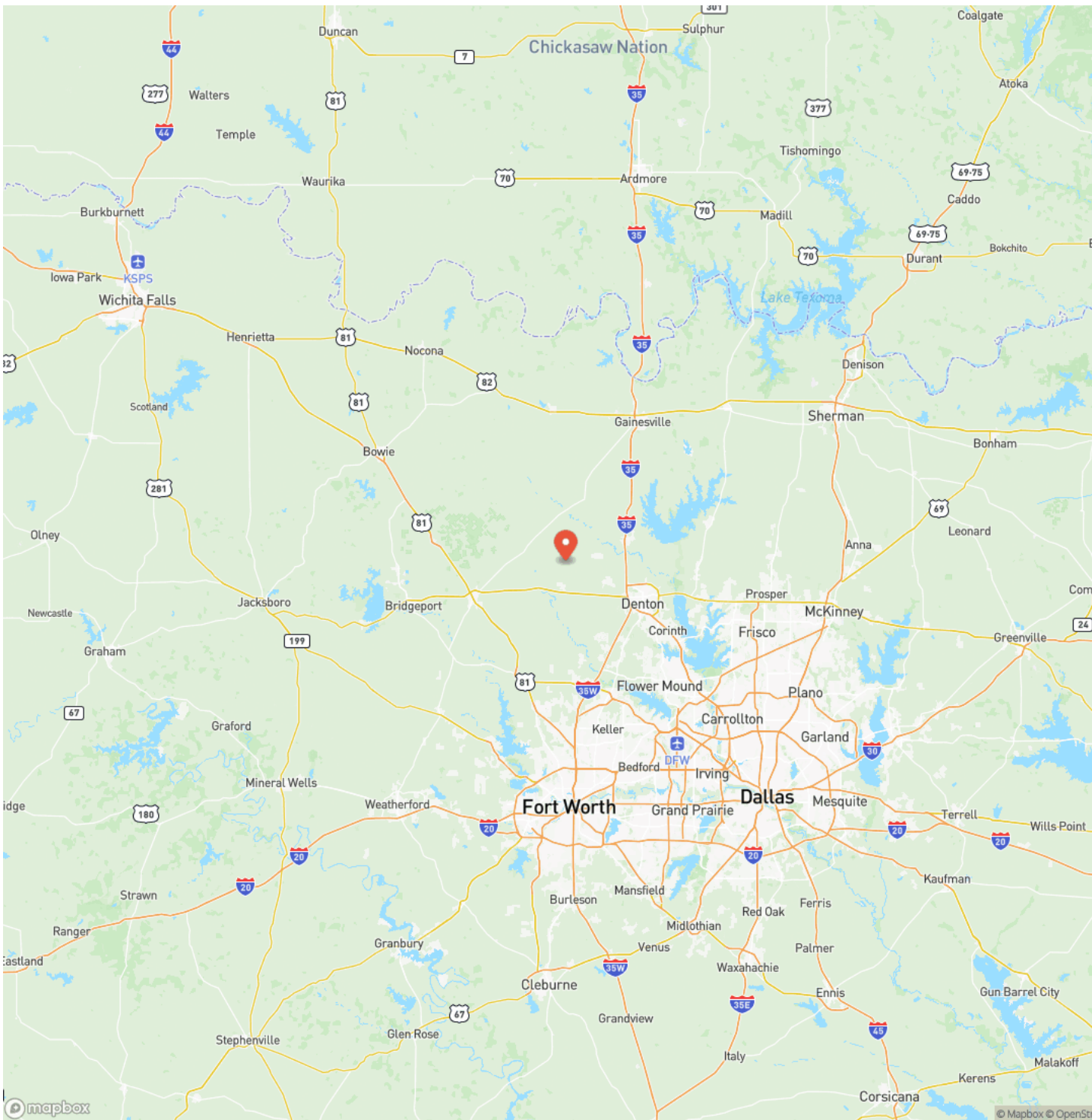




Locator Map
