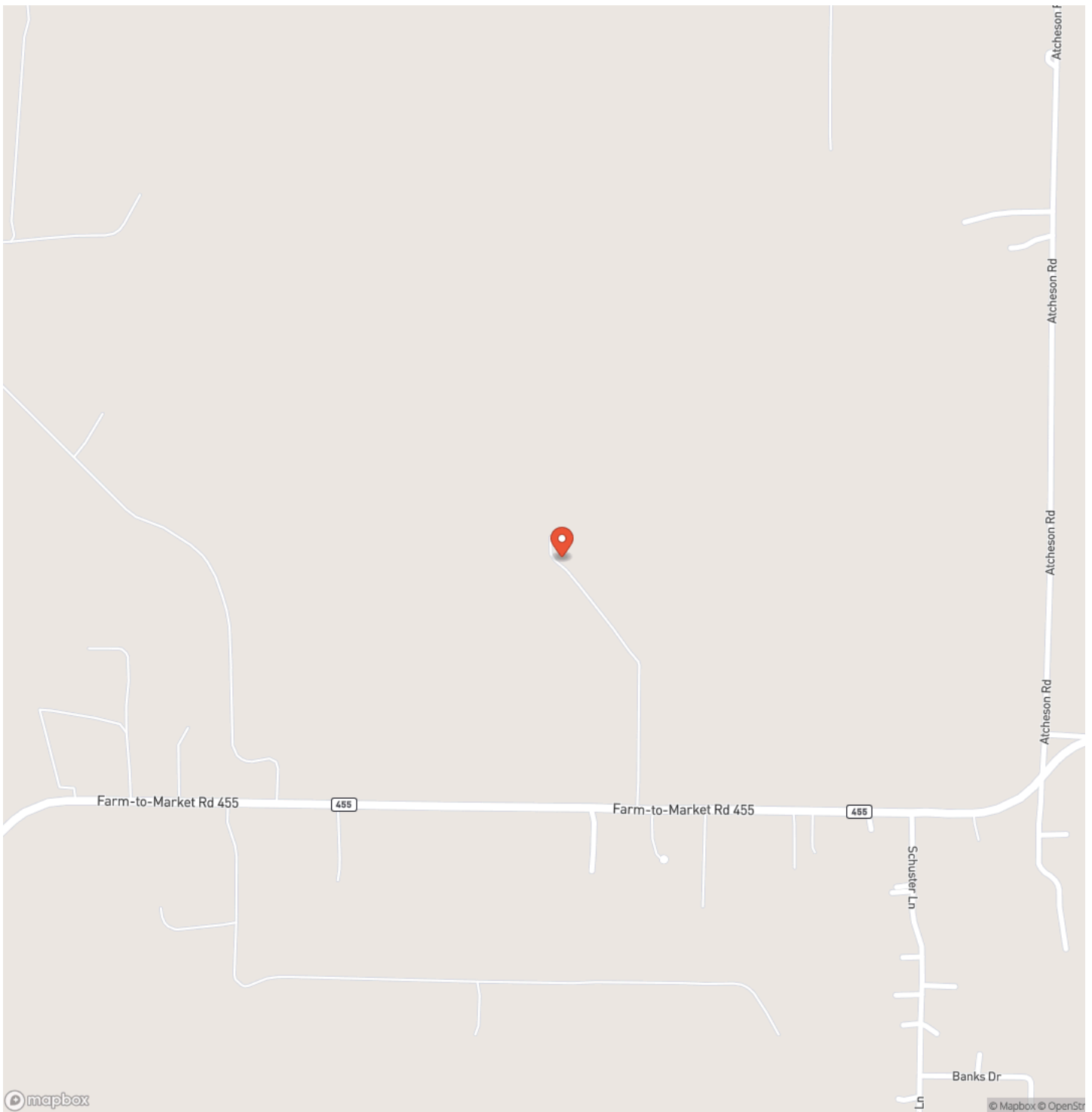

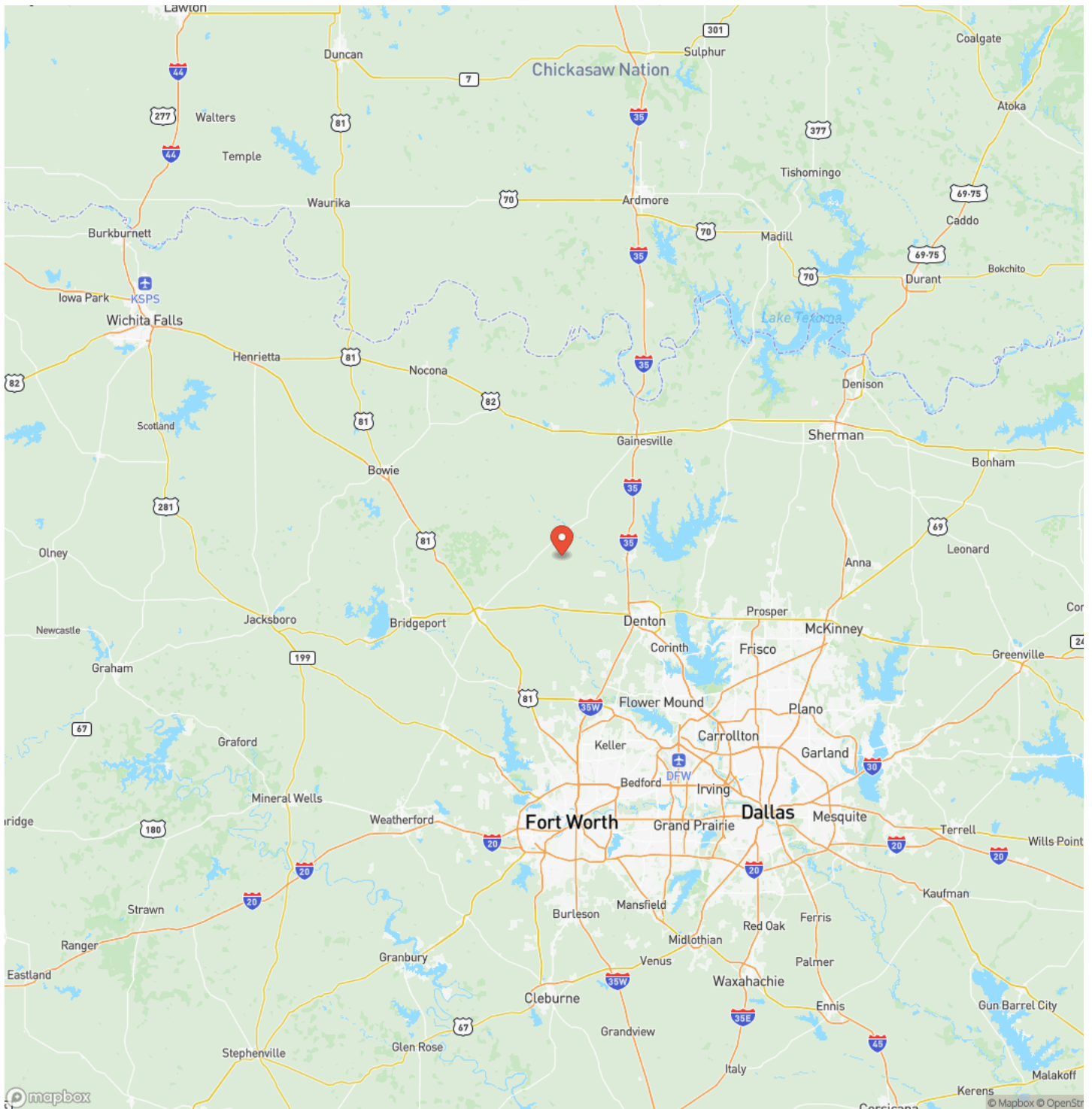


Locator Map



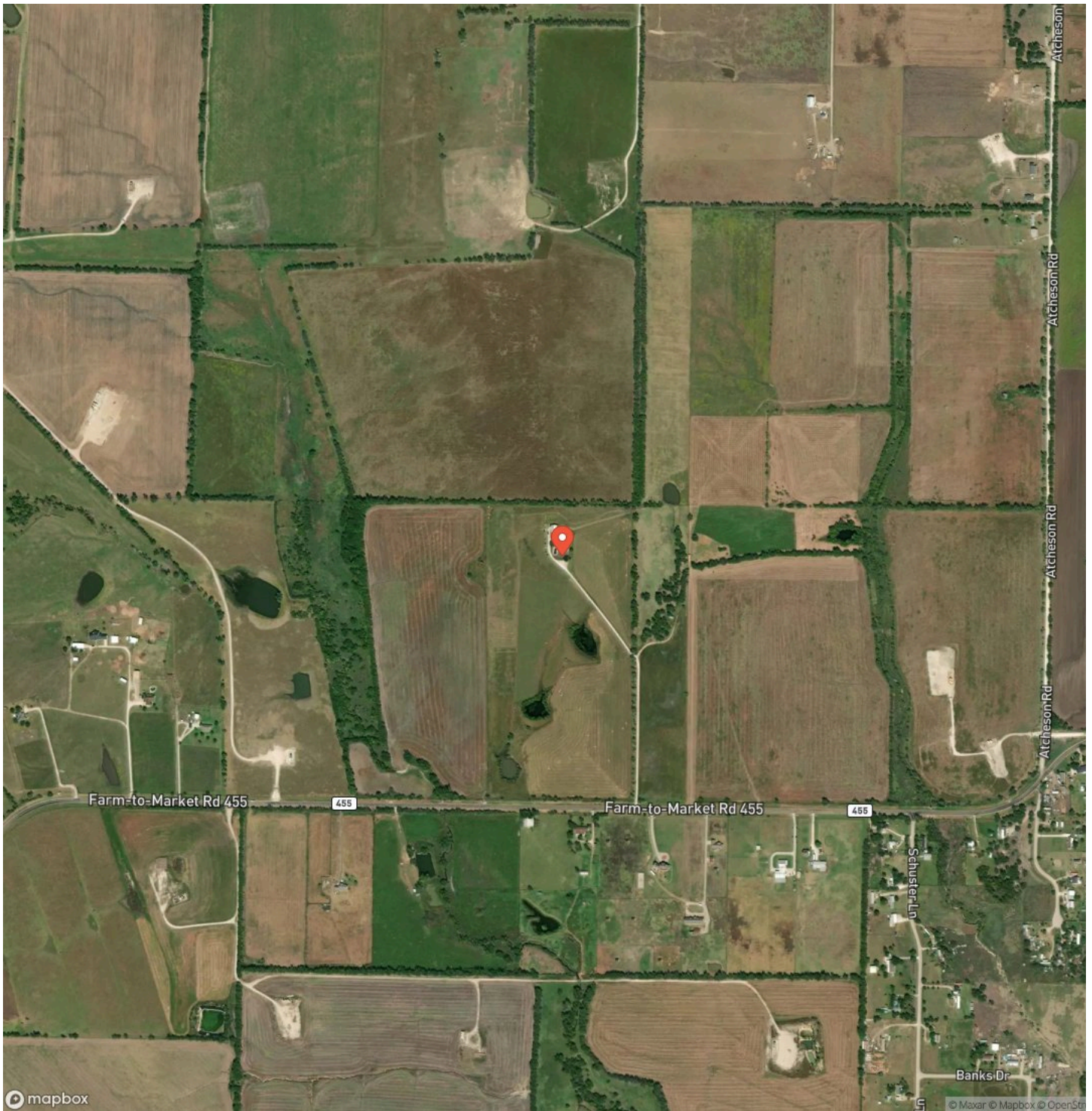
