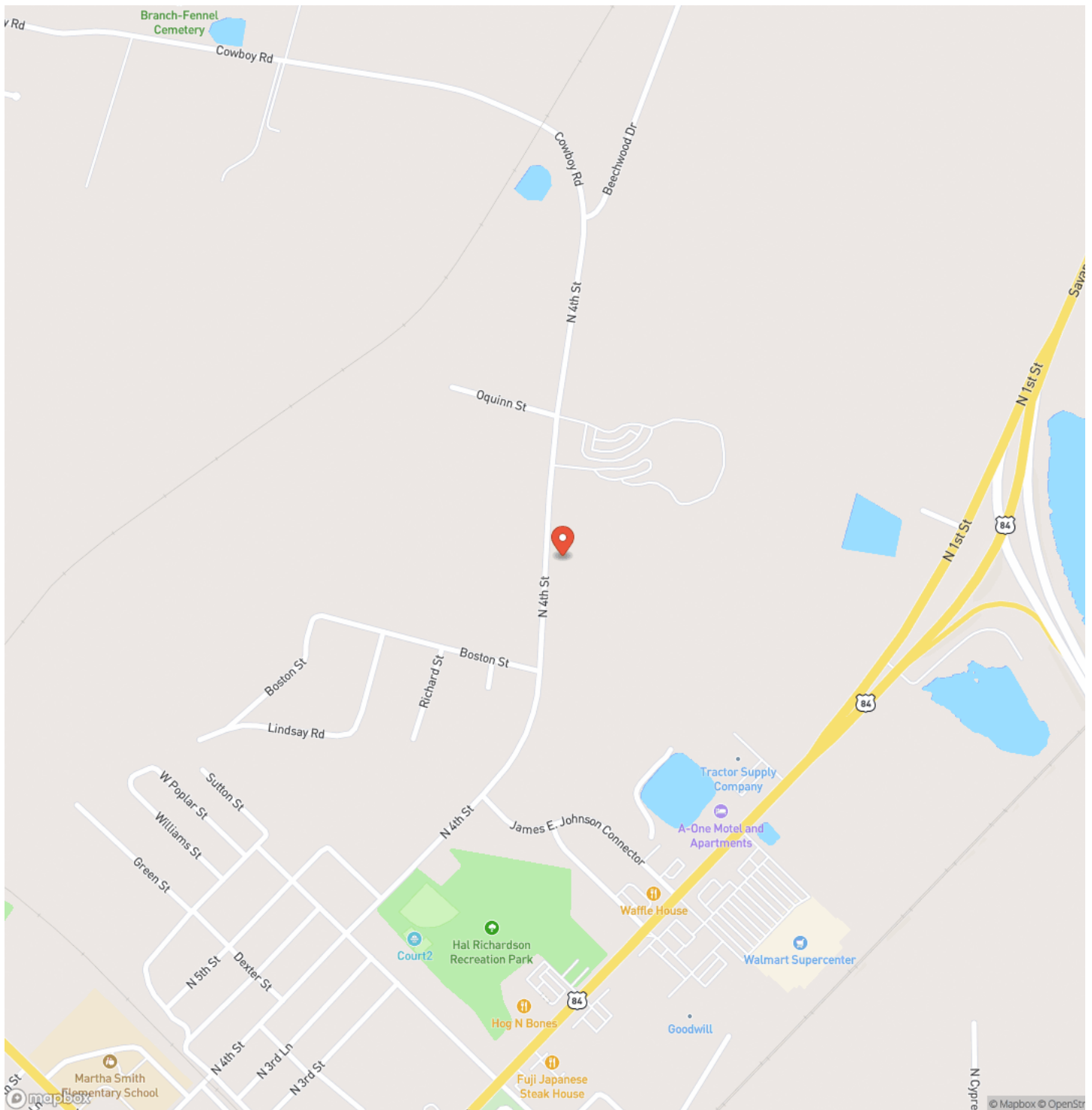

Opportunities of this scale within city limits are limited-don't miss the chance to bring a new residential community to a growing area.

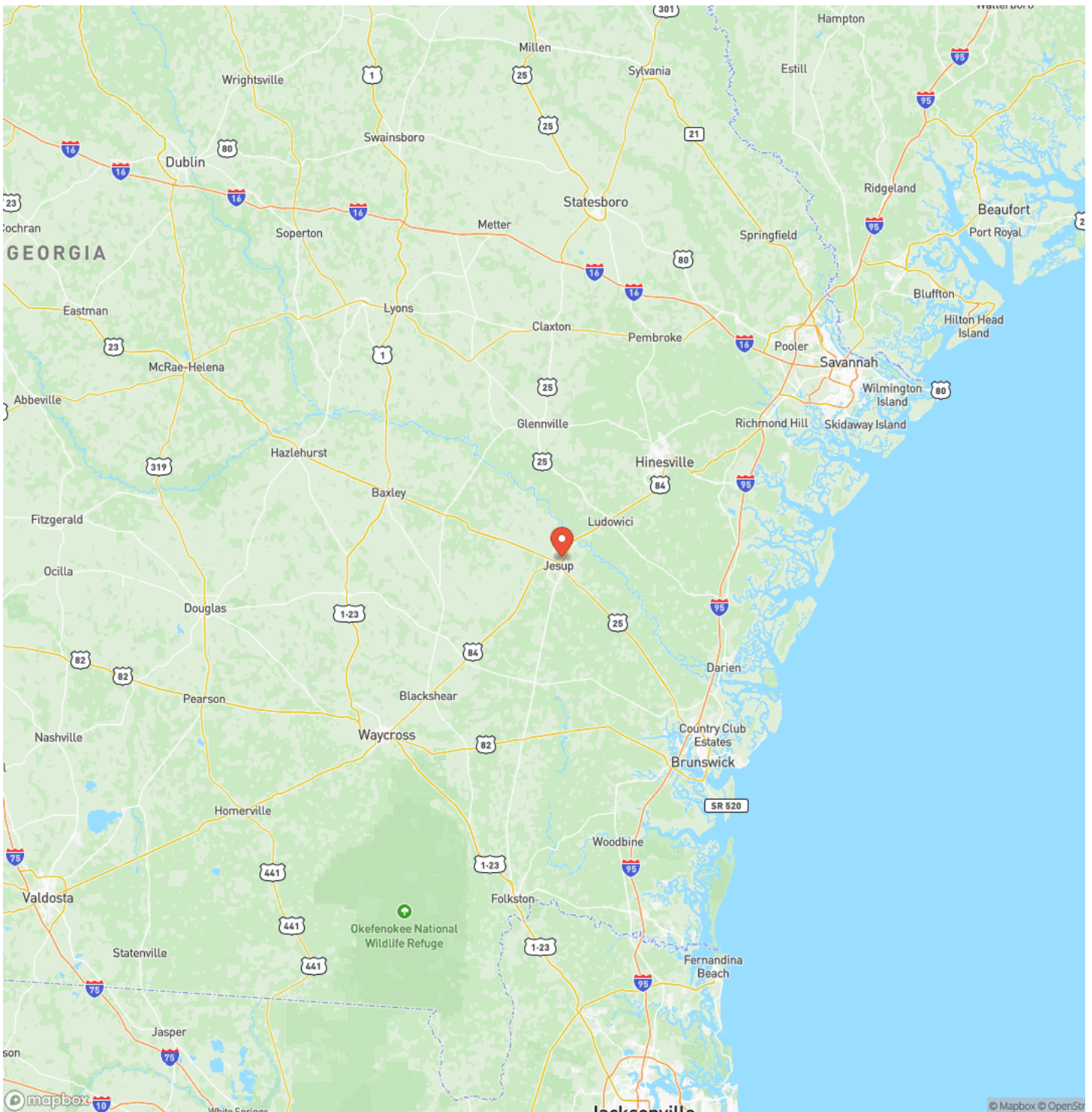

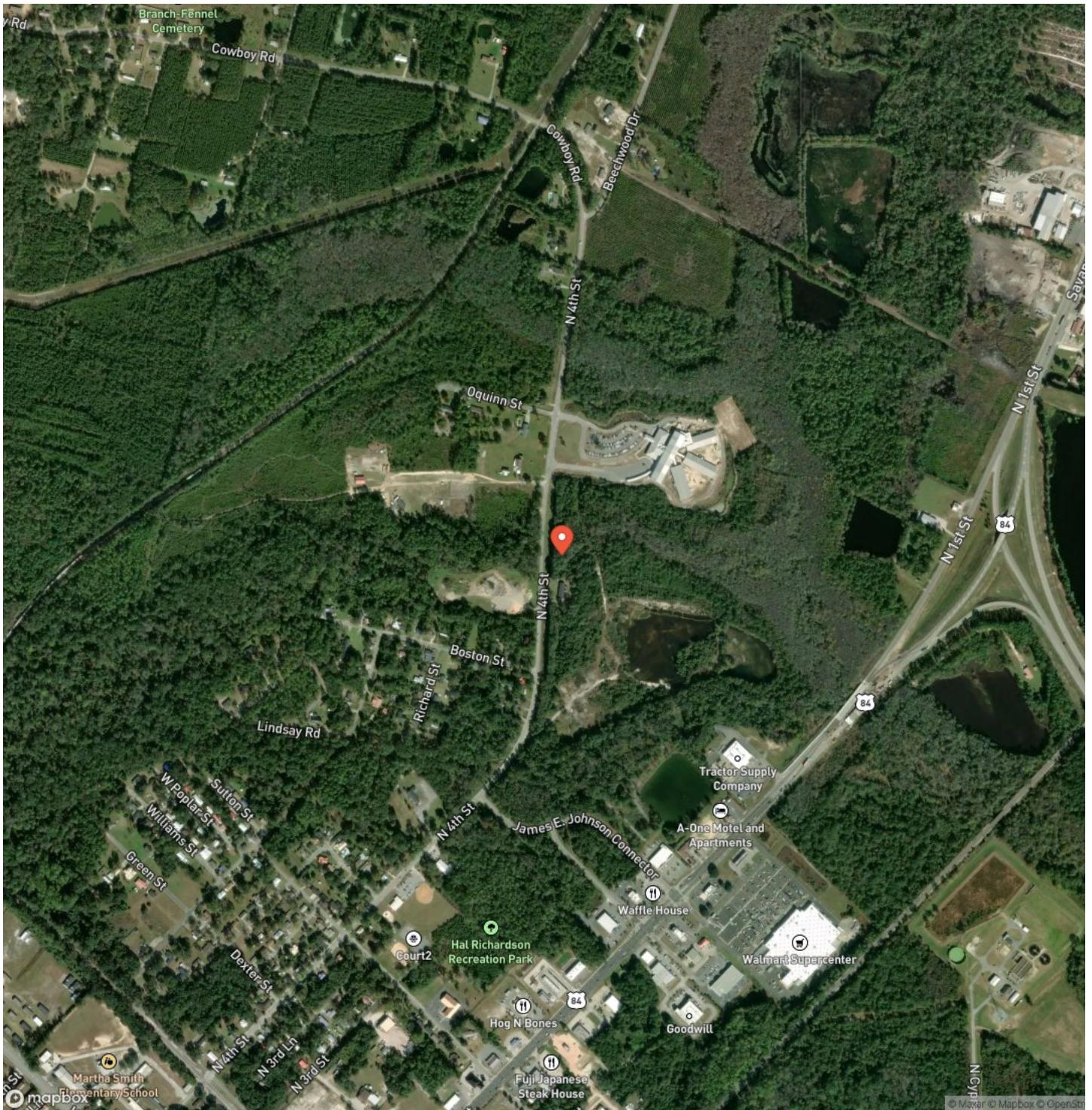
Locator Map
