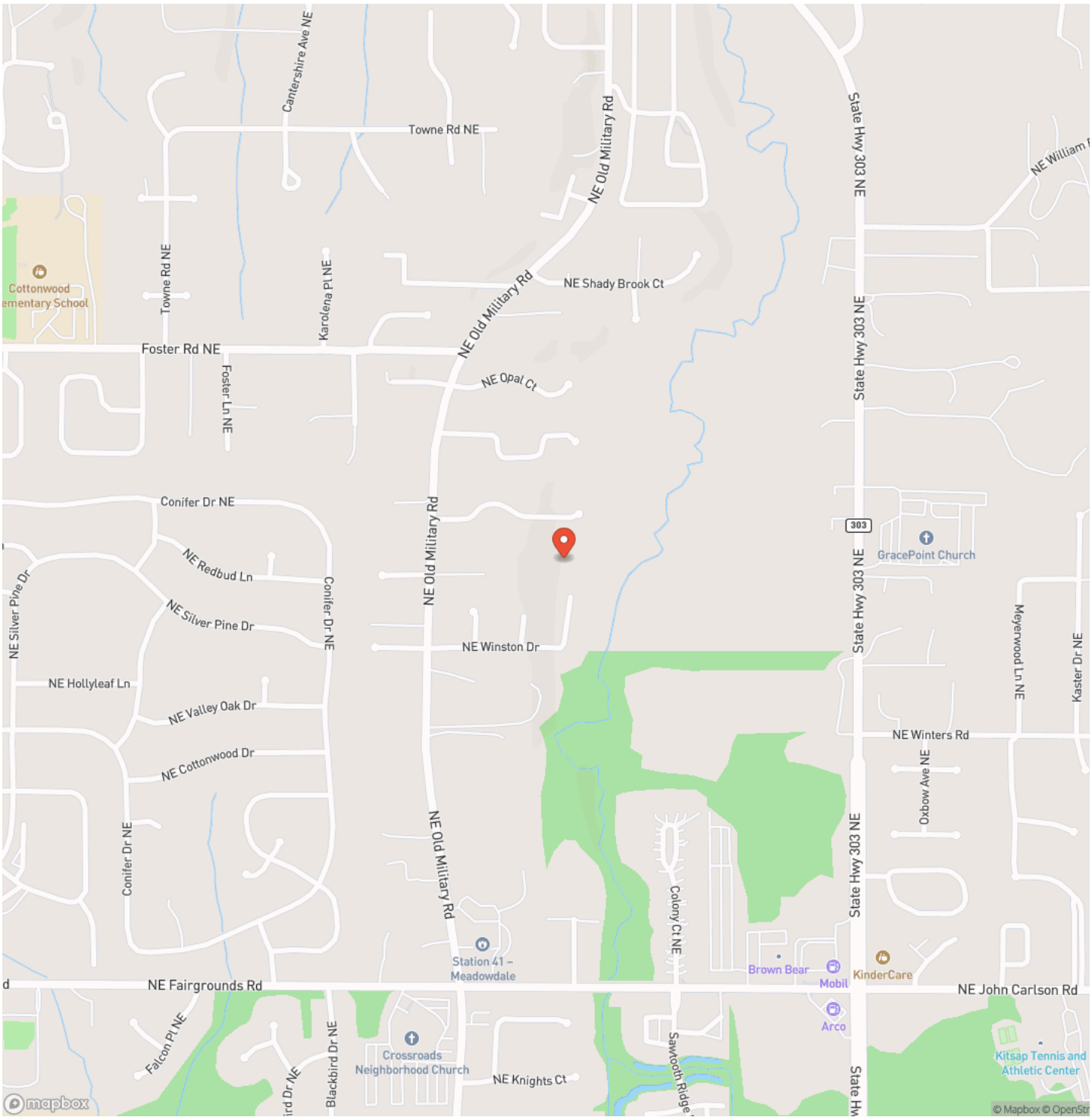

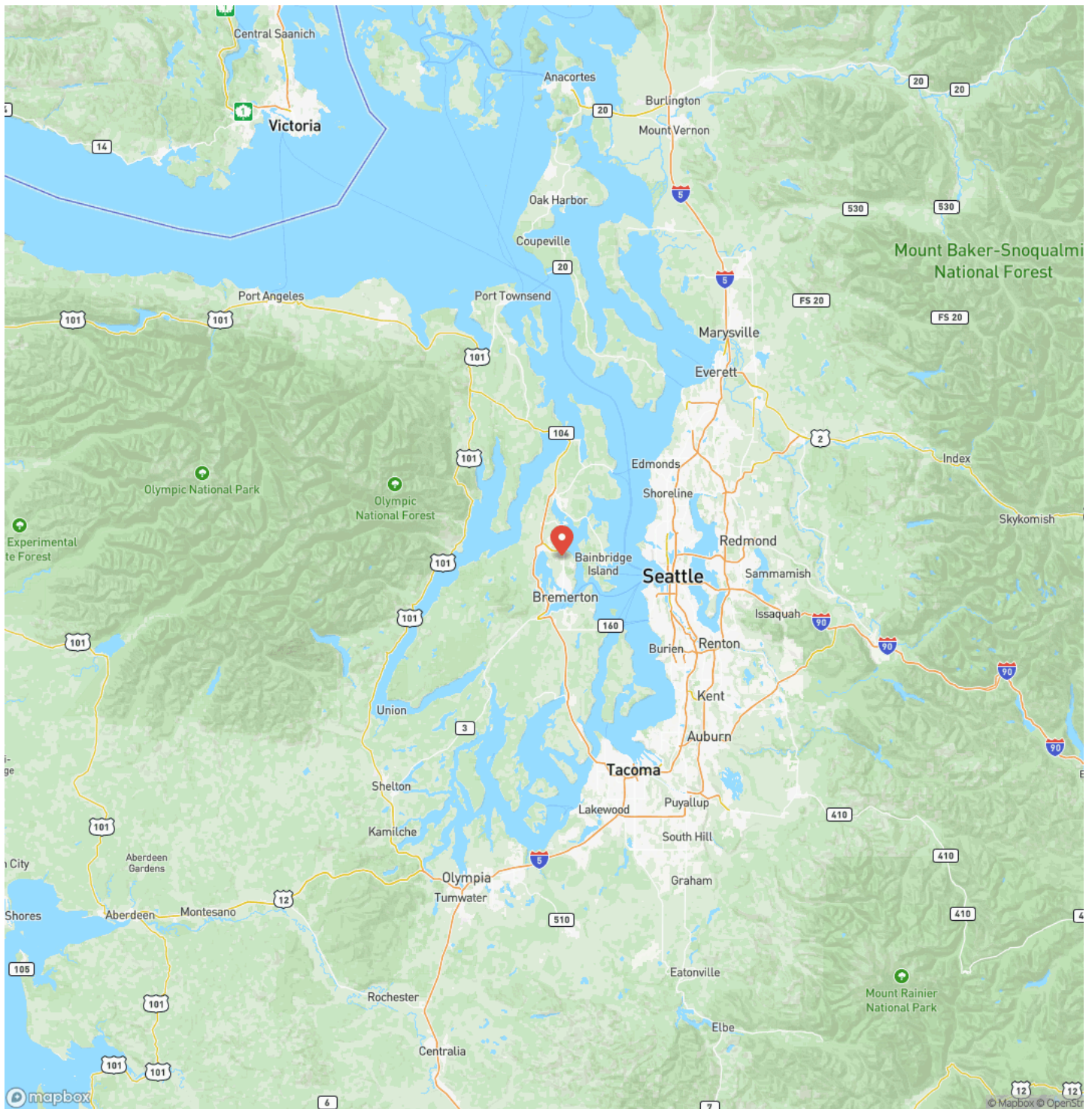


Locator Map

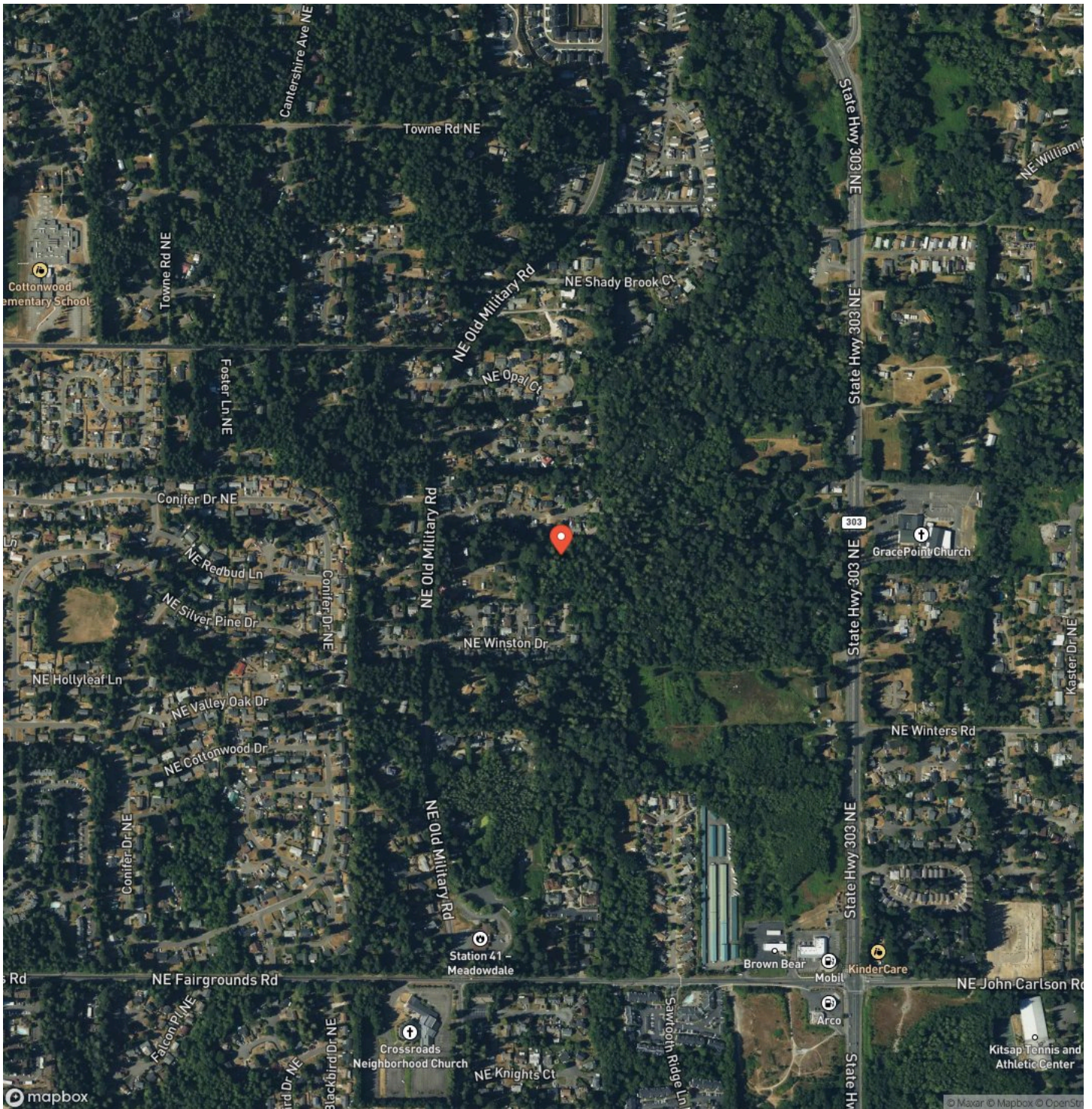
