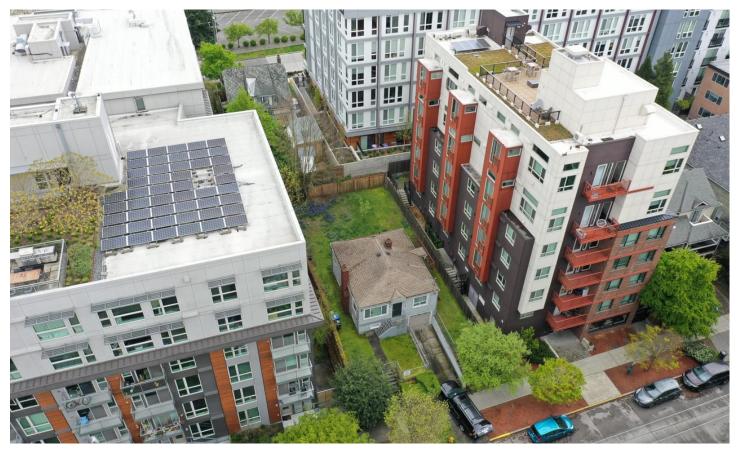

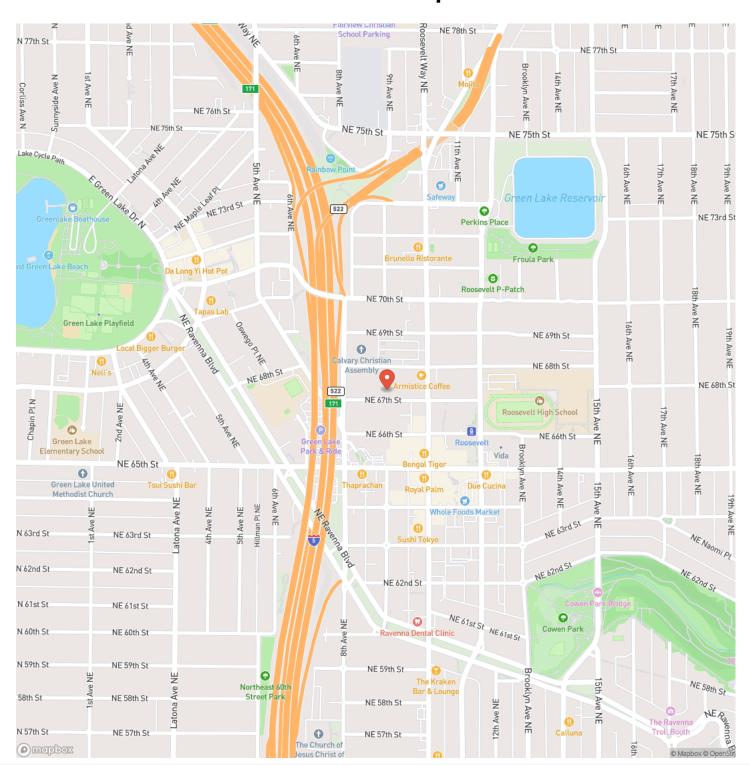






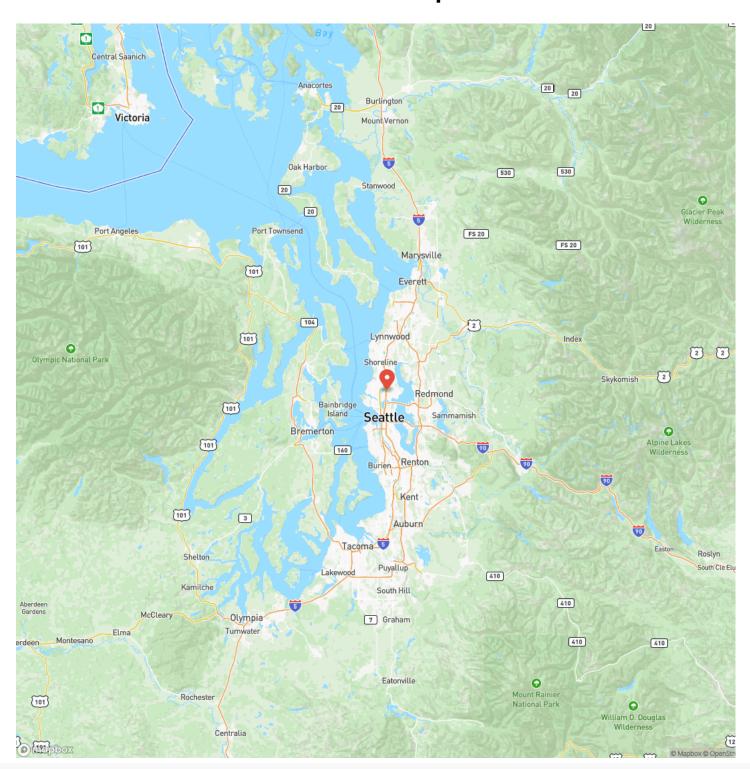


Locator Map



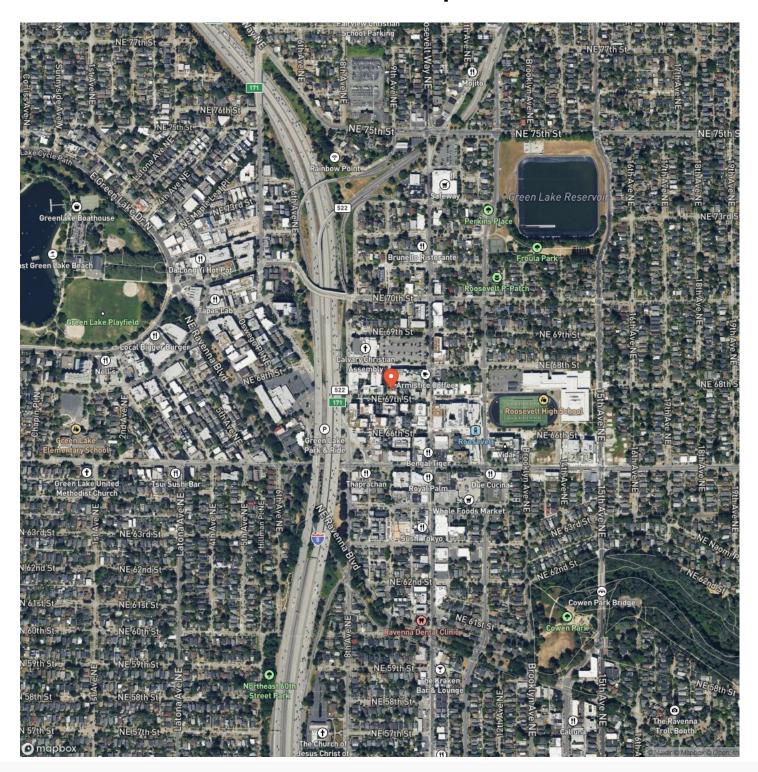


Locator Map
