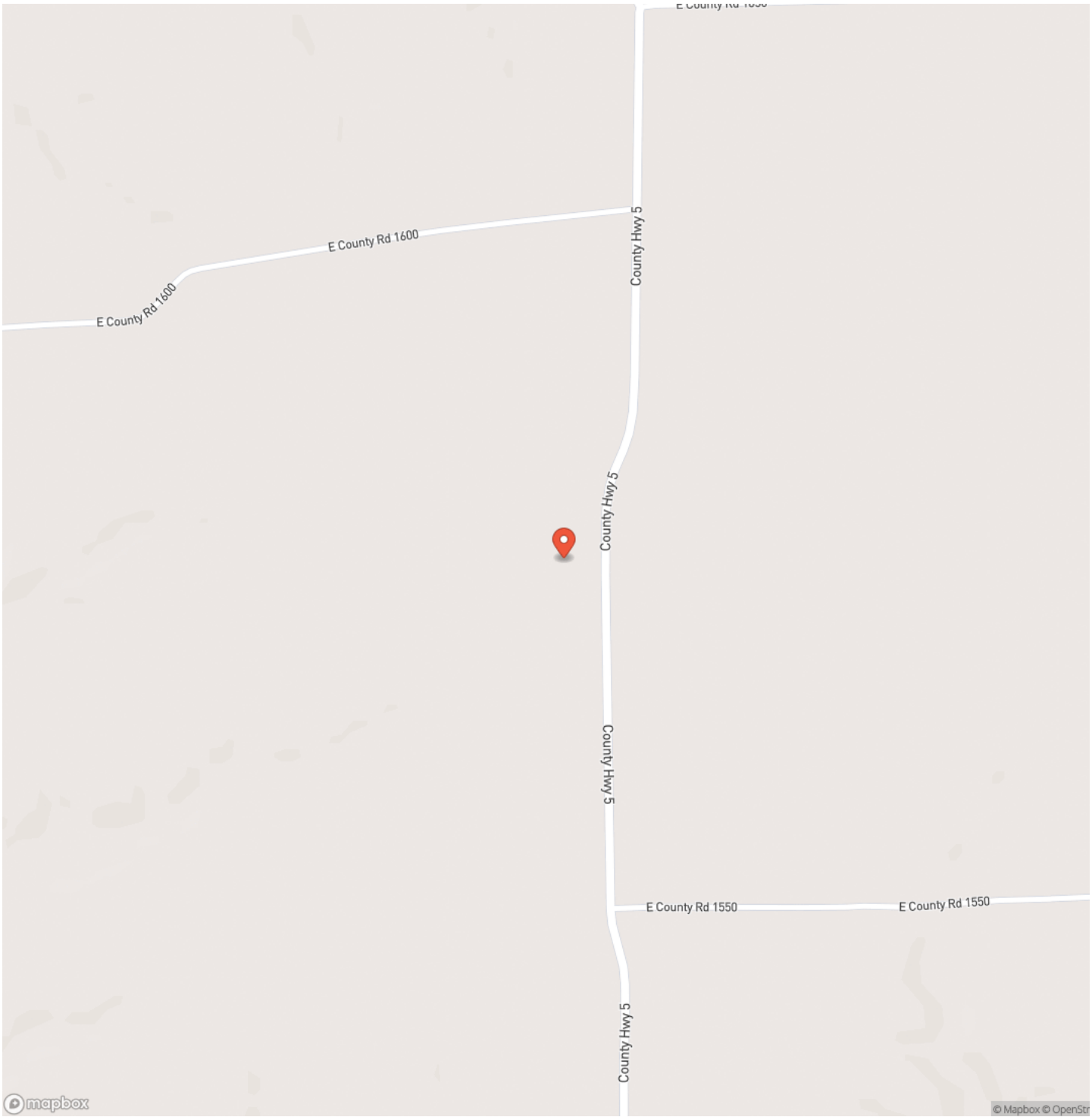
PROPERTY DESCRIPTION

The main home, originally built in 1920, provides approximately 2,850 +/- square feet of finished living space. It features five bedrooms, two full bathrooms, and an additional half bath, offering a layout that easily accommodates larger groups, extended family, or guests. The interior is designed with durability and flexibility in mind, while a full unfinished basement adds valuable storage space and room for a workshop or additional utility area. A spacious front porch creates an inviting place to relax and enjoy scenic views of the surrounding farmland and quiet countryside. The property's outbuildings significantly enhance its usability. A 30x64 three-sided pole barn, constructed in 2020, provides ample space for equipment, recreational vehicles, or storage. A separate storage shed with a concrete floor offers secure space for tools and supplies. Another standout feature is a 2,700 +/- square-foot utility building, with approximately 1,085 +/- square feet finished into private living quarters that include two bedrooms, a full bathroom with double showers, and an open-concept kitchen and living area, perfect for guests, clients, or extended family. Additionally, two prefabricated cabins with water, sewer, and electric already in place present excellent potential for conversion into rental units or private retreats. The flat, open acreage is well-suited for recreation, hobby farming, livestock, or future development. 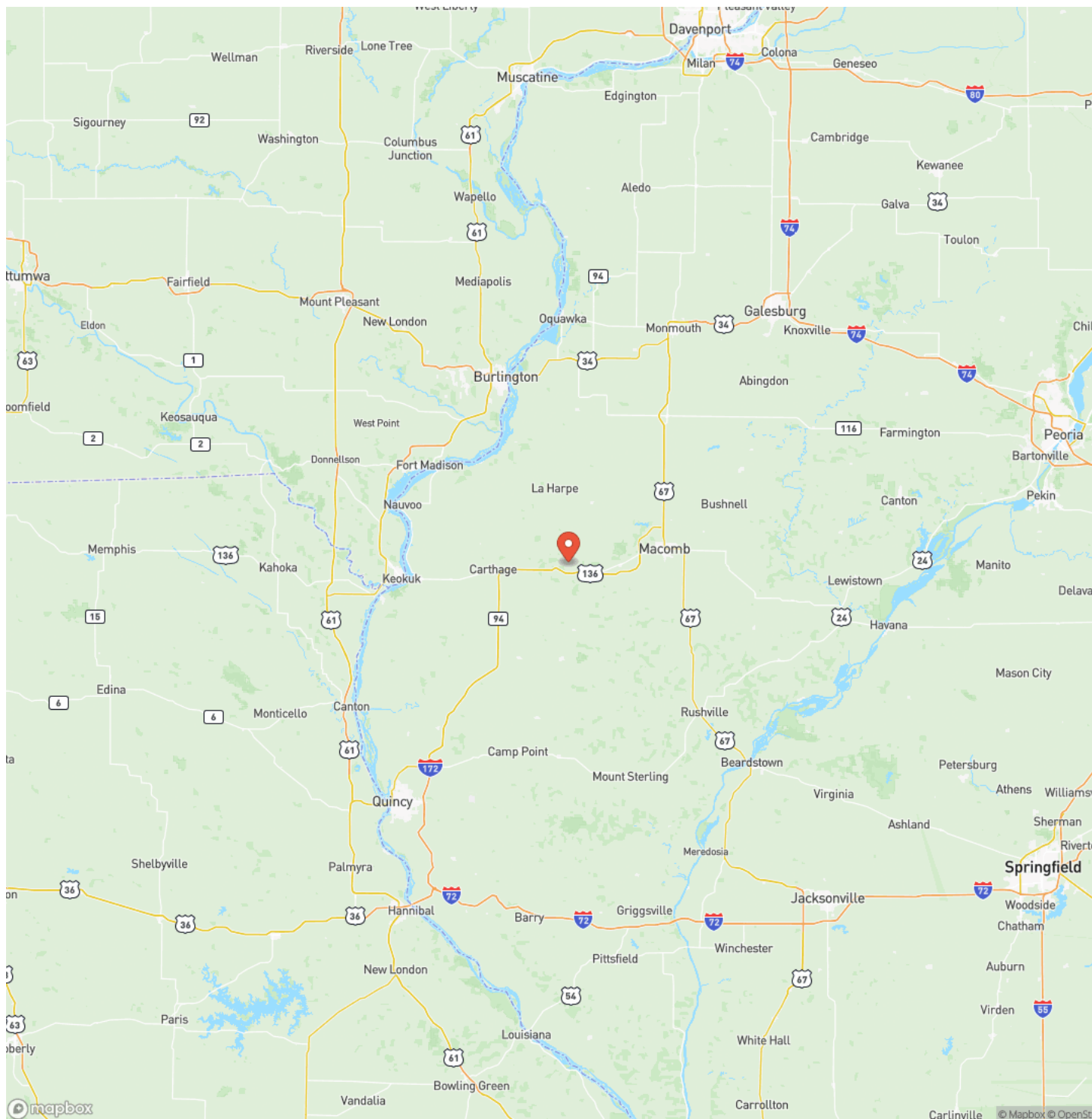
