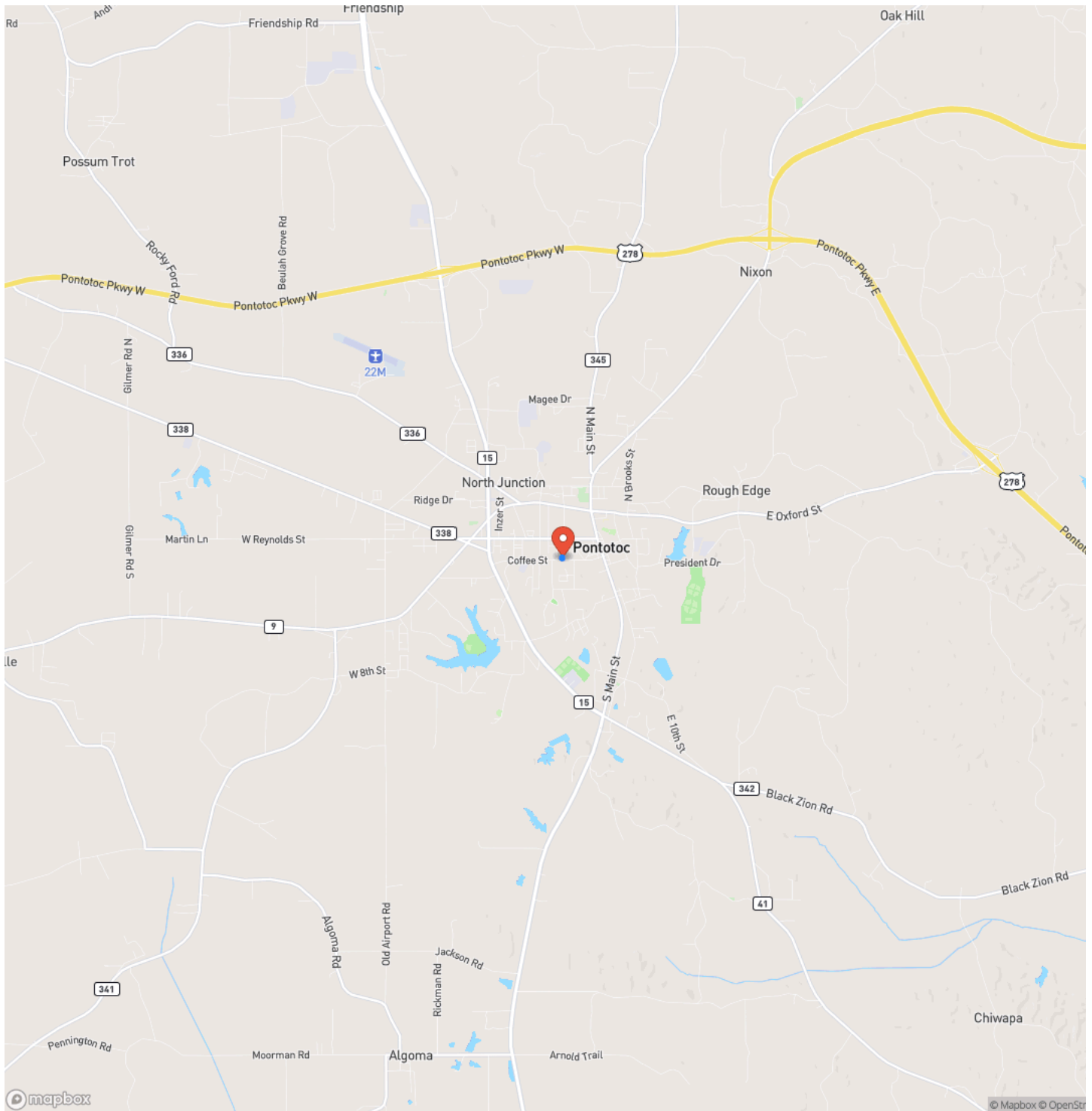

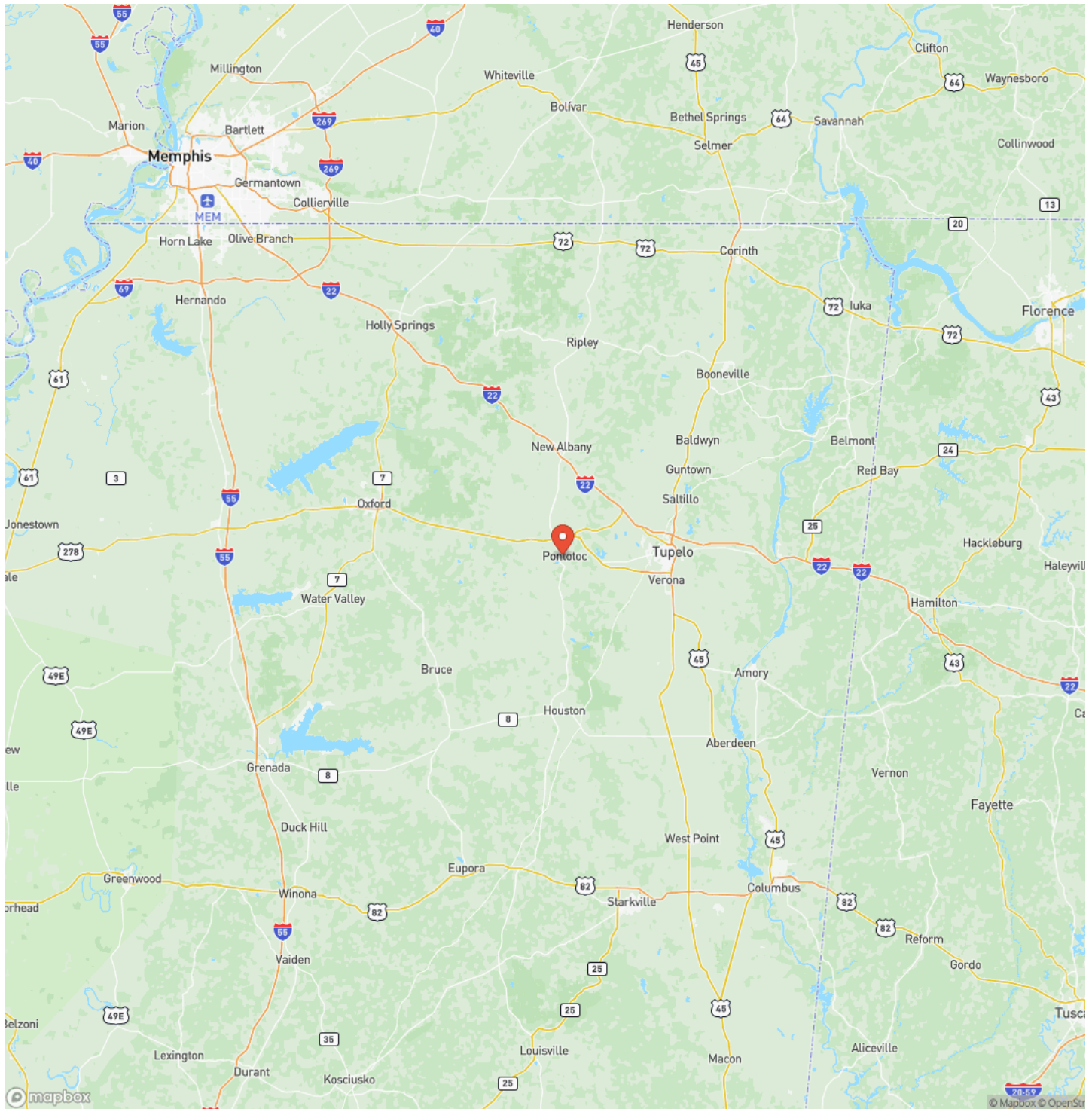


Locator Map

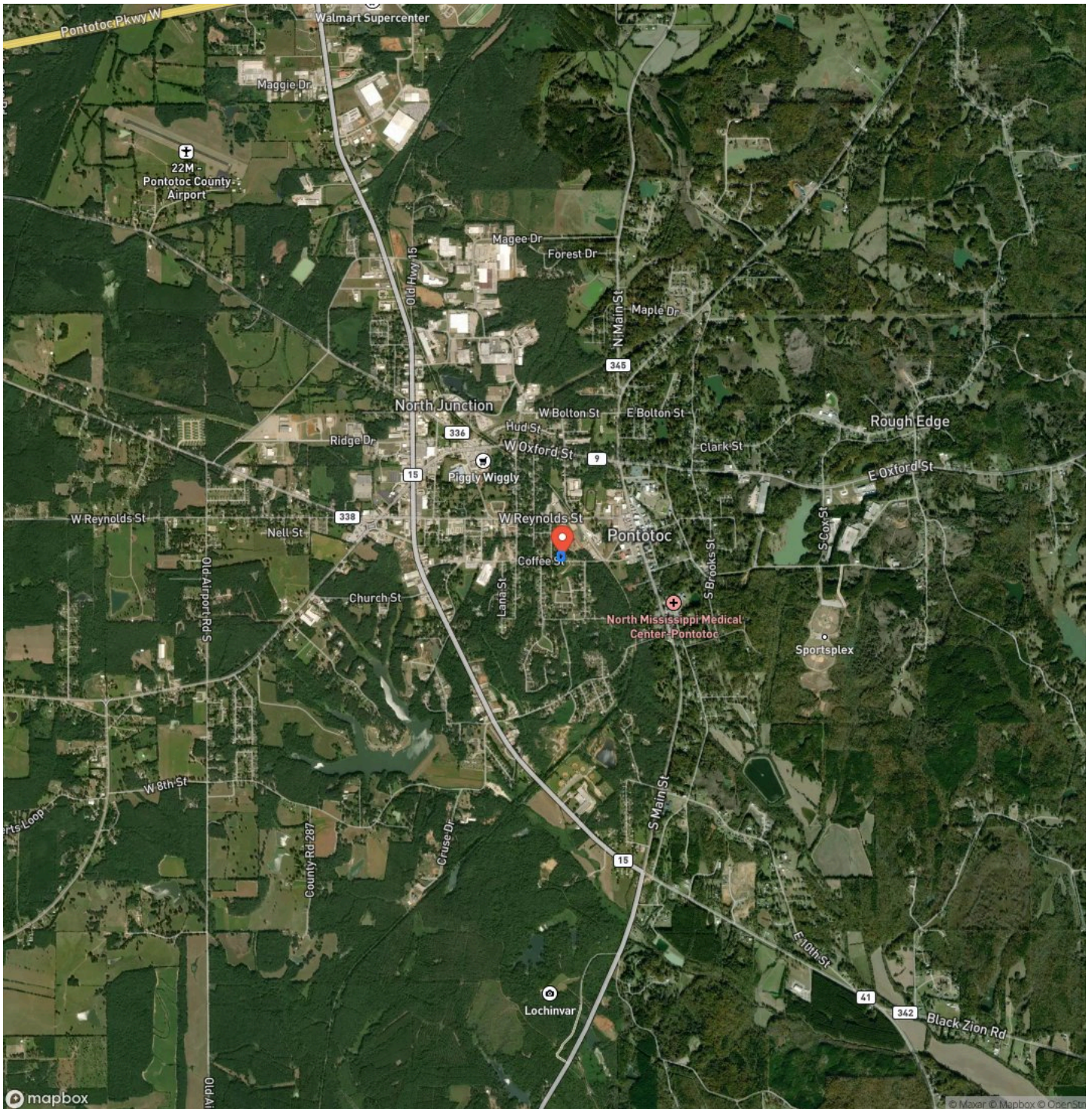
