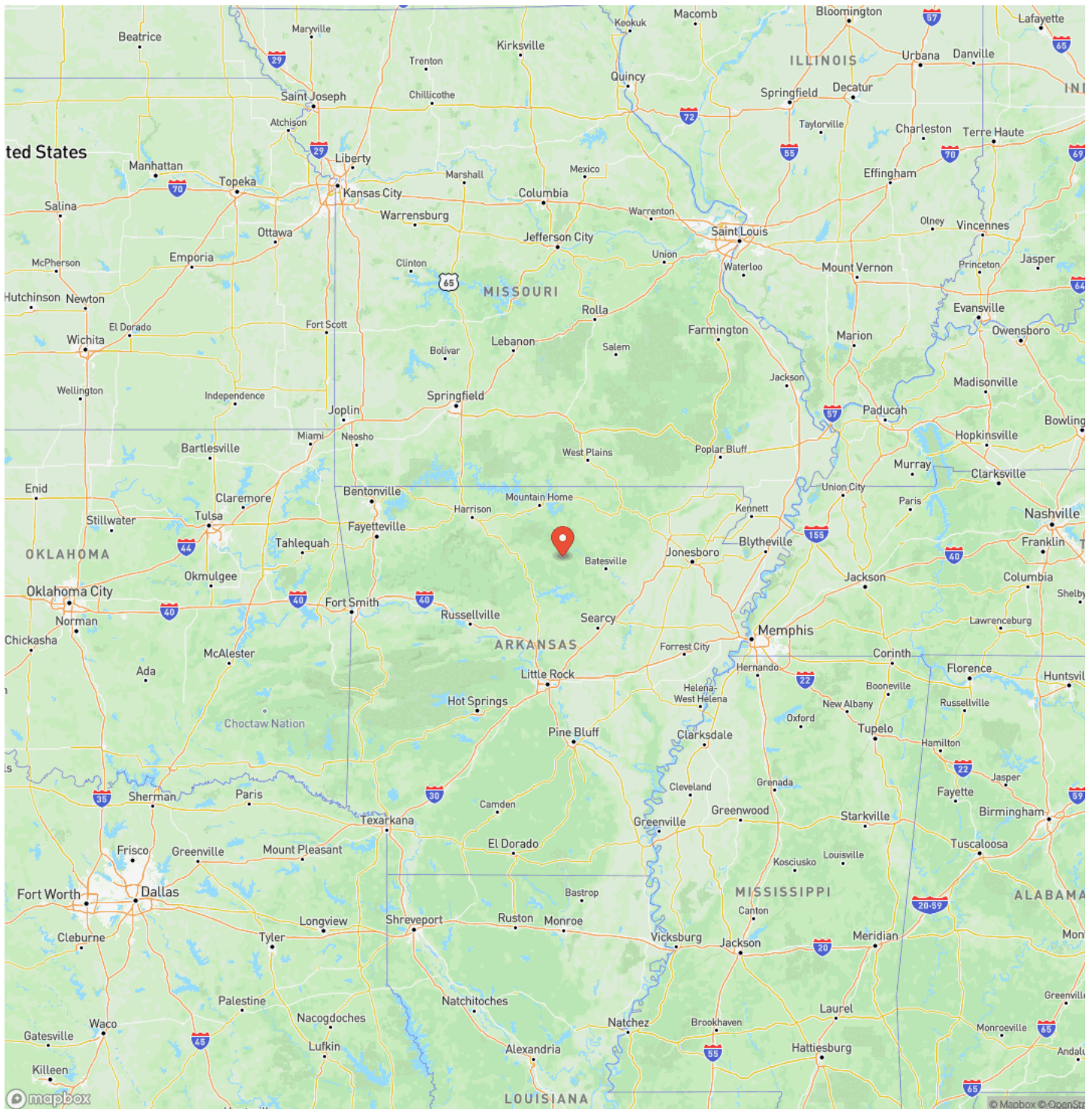

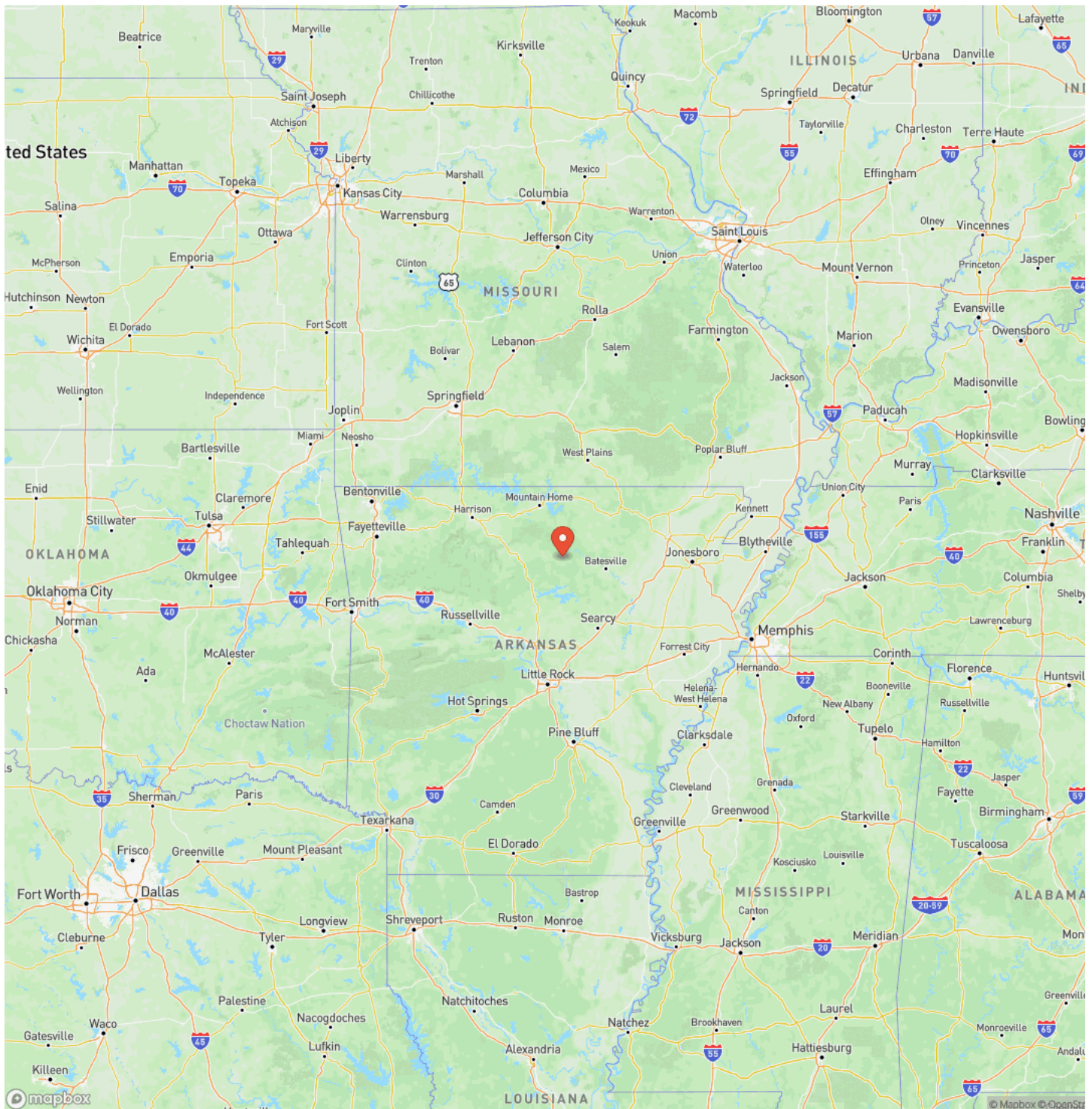

Locator Map



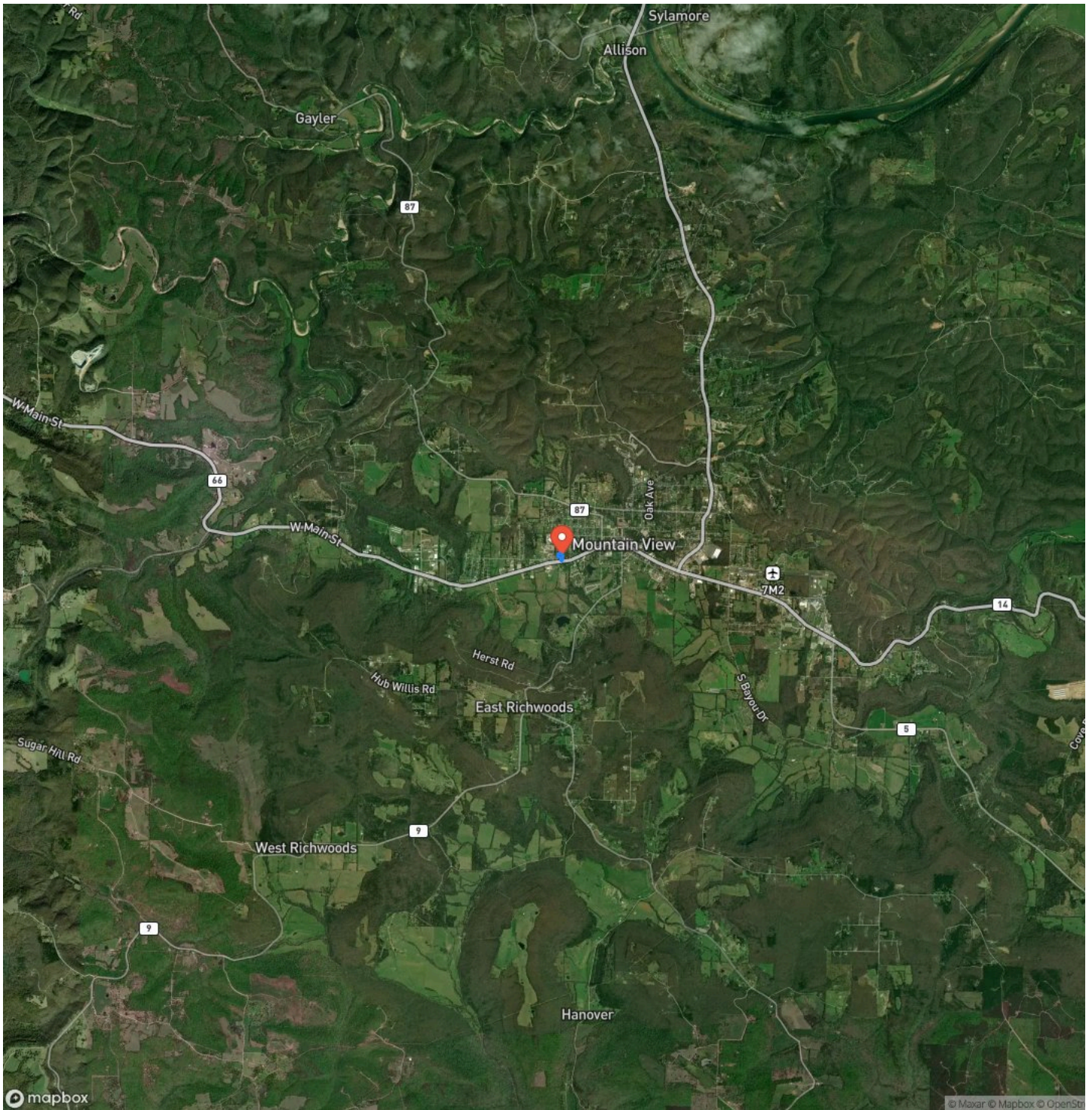
