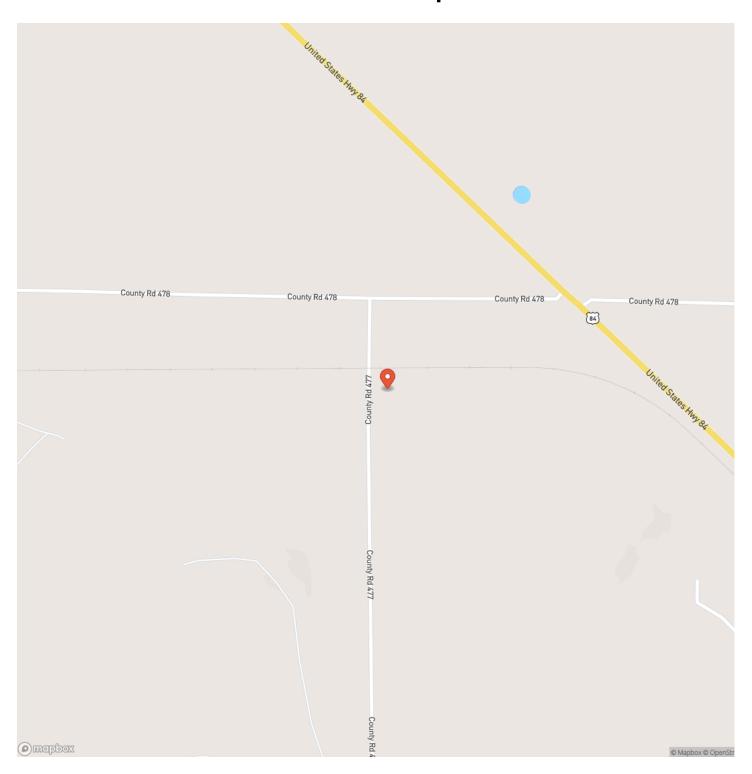

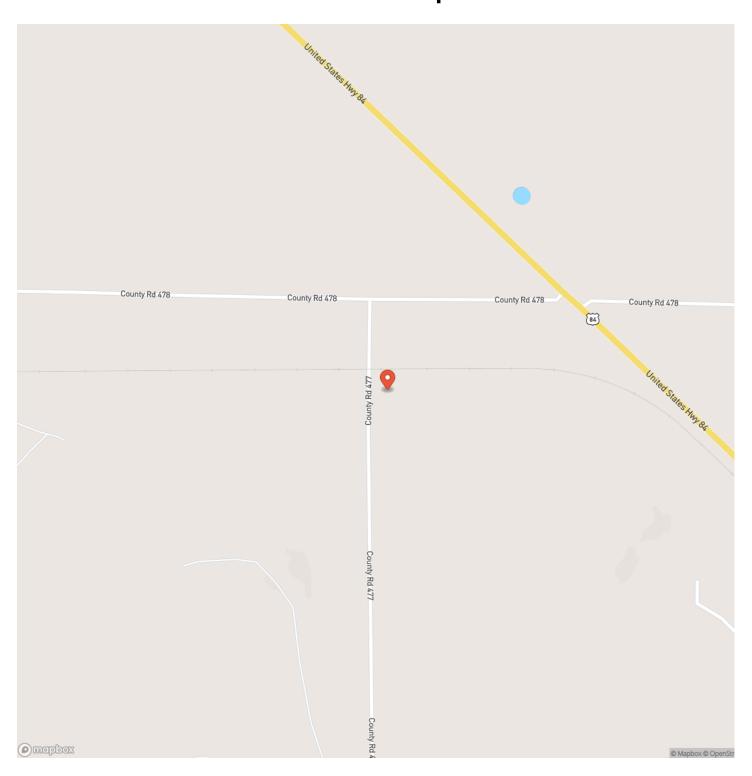


Locator Map



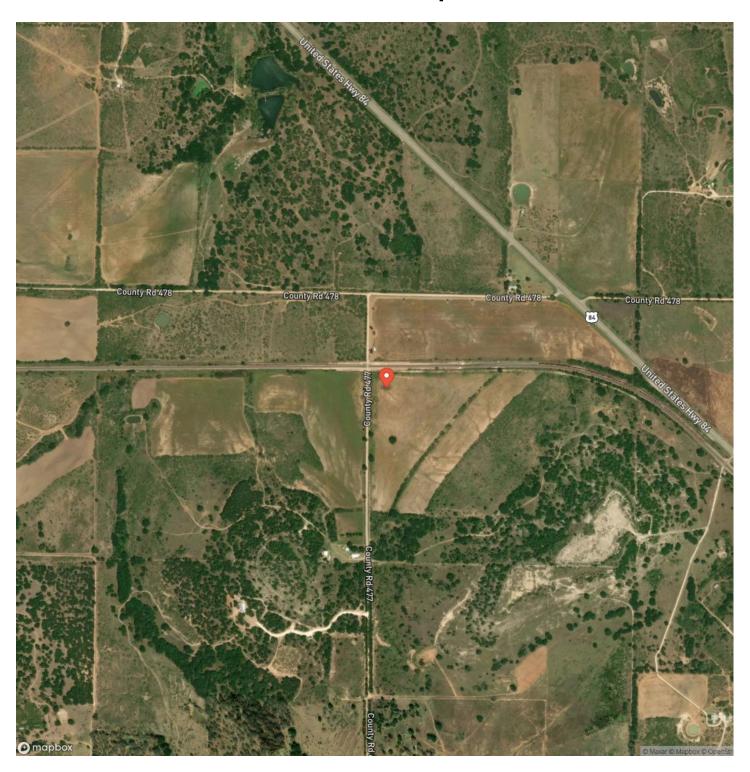
