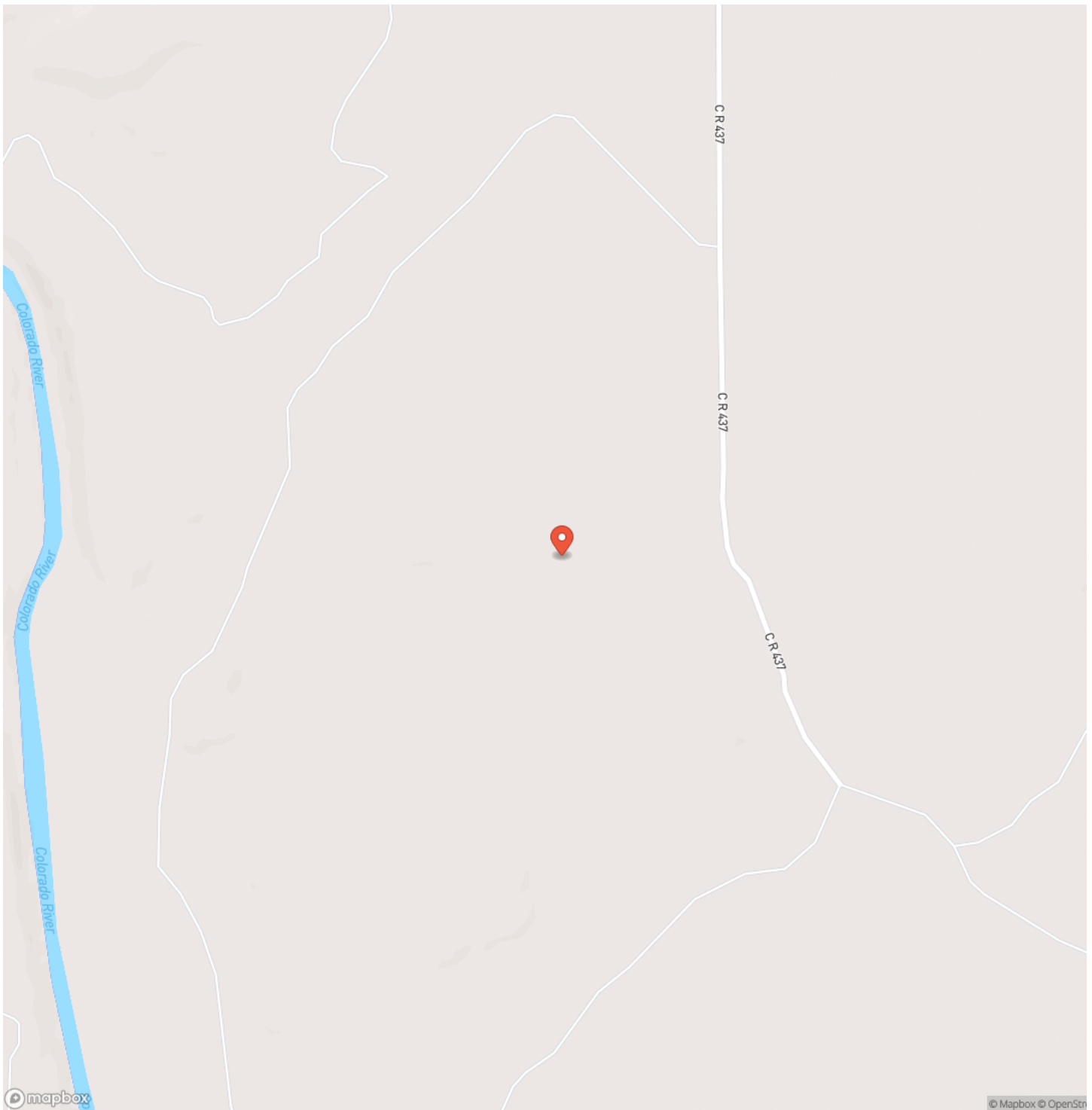

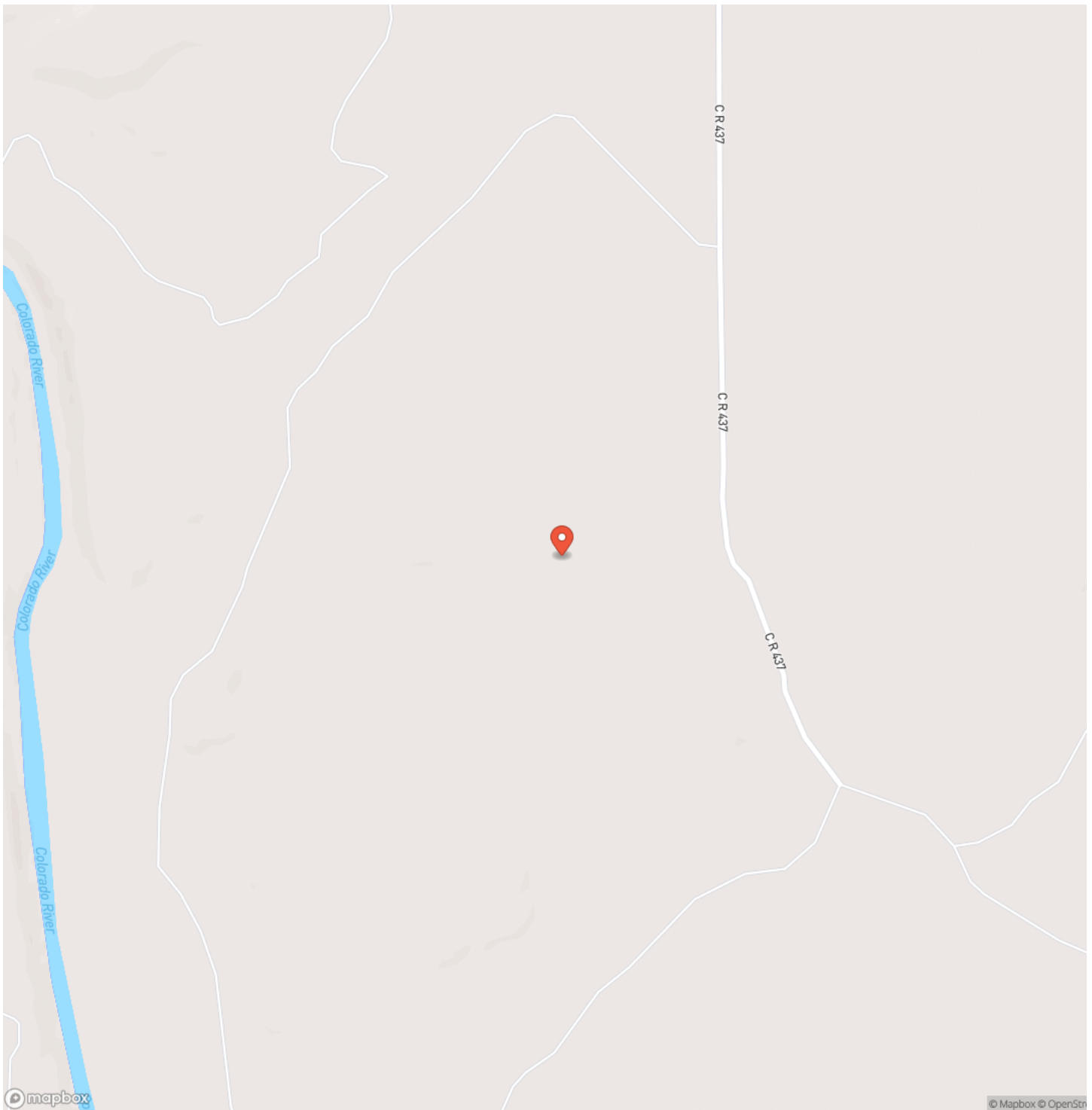
## Locator Map

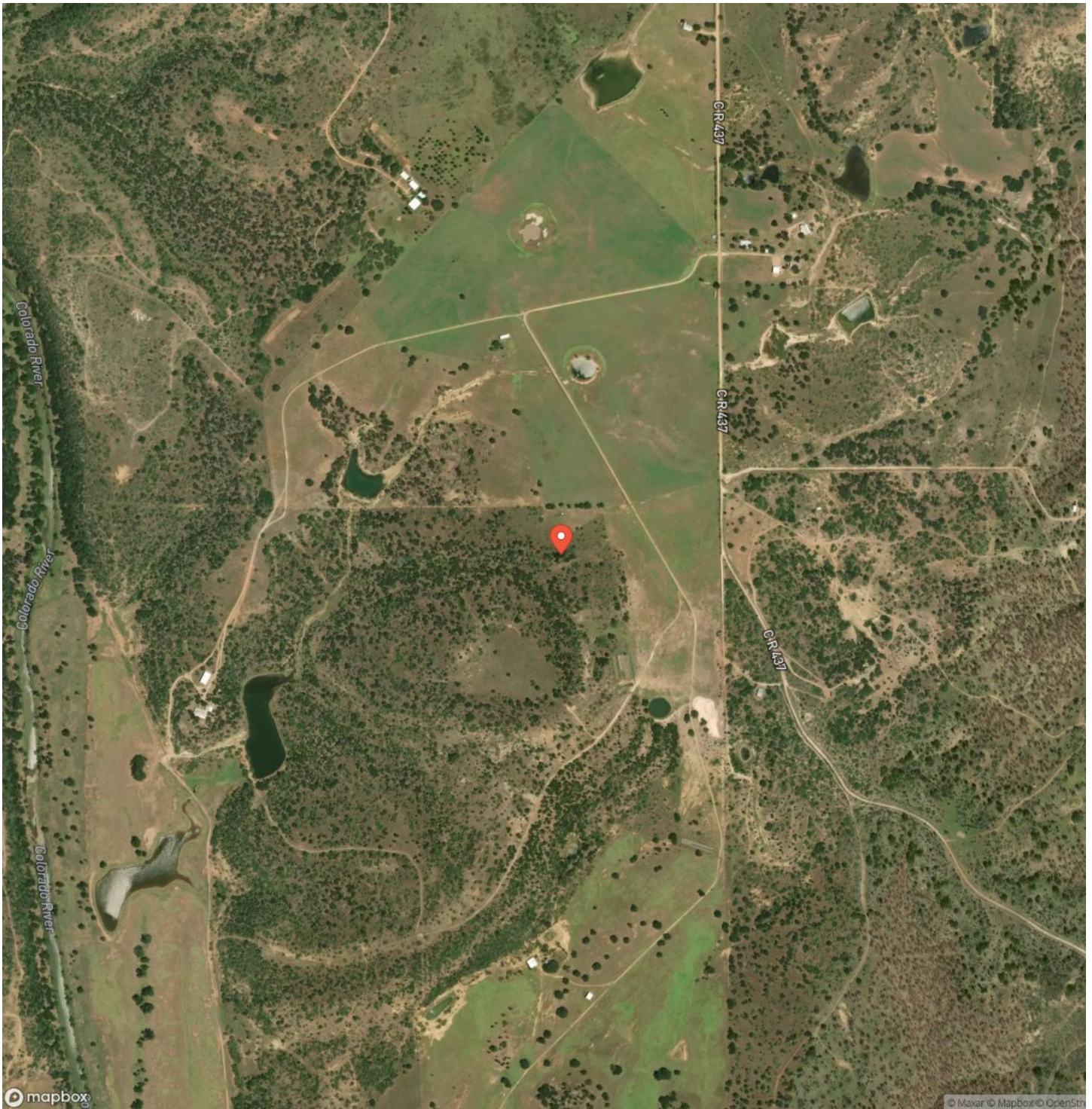
