


The owner states that the hunting is phenomenal for both turkey and deer. The property is managed for trophy bucks and features food plots and bedding areas throughout the property.

Whether you're seeking a weekend getaway or a full-time retreat, this charming log cabin offers the perfect blend of rustic allure and modern comfort.






Locator Map






Locator Map
