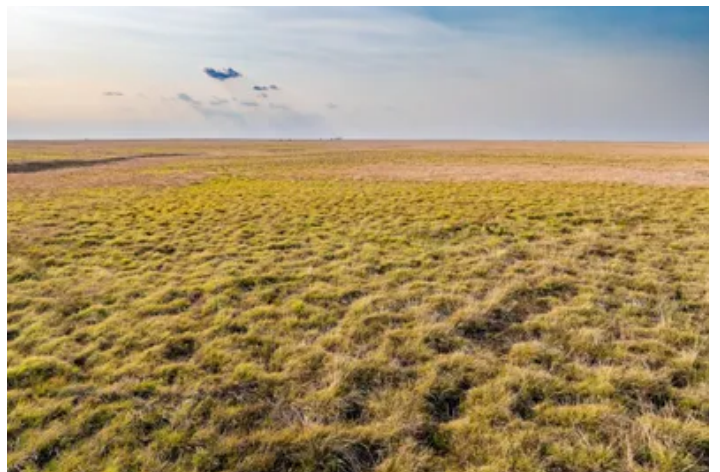

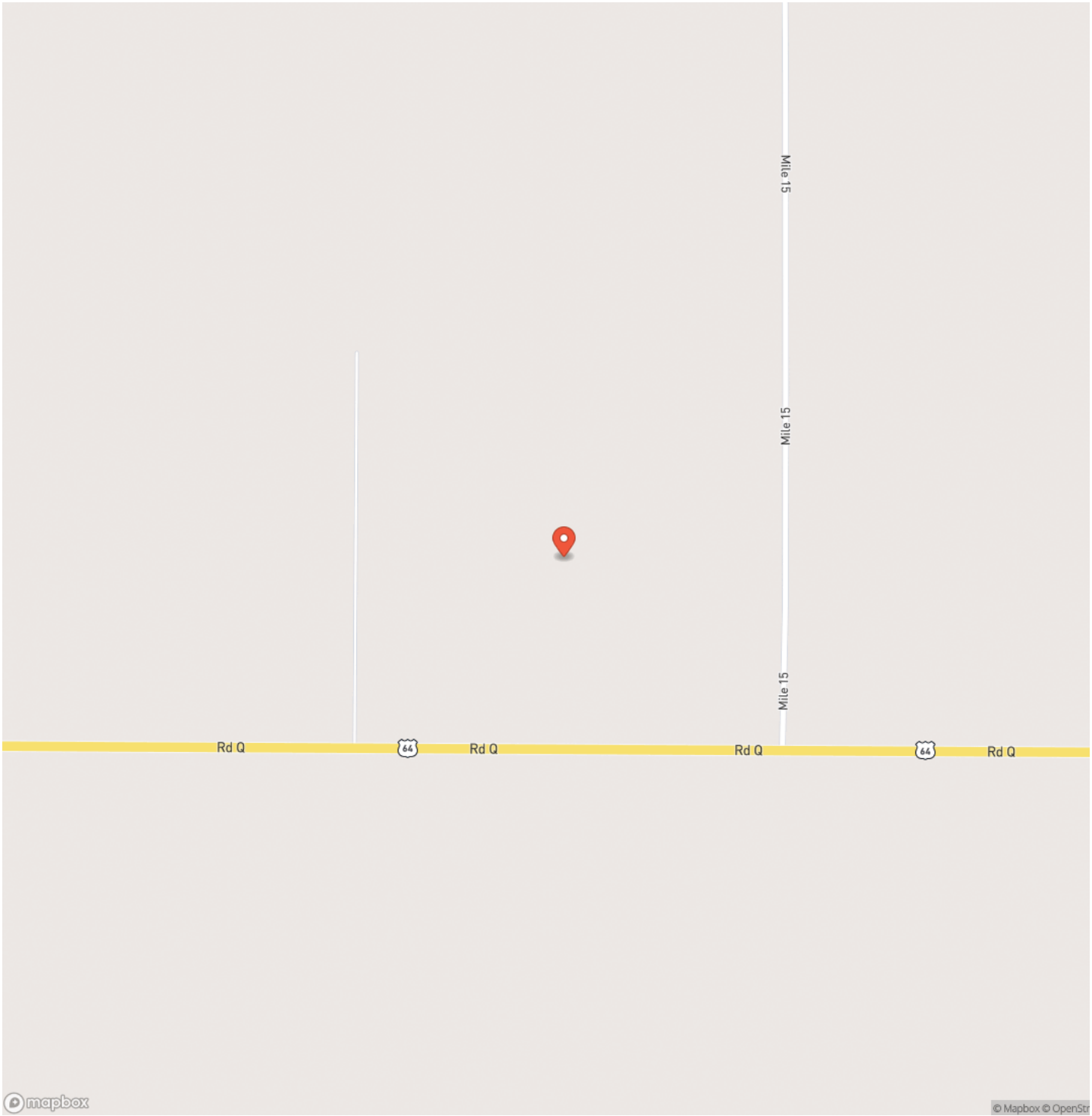

Locator Map

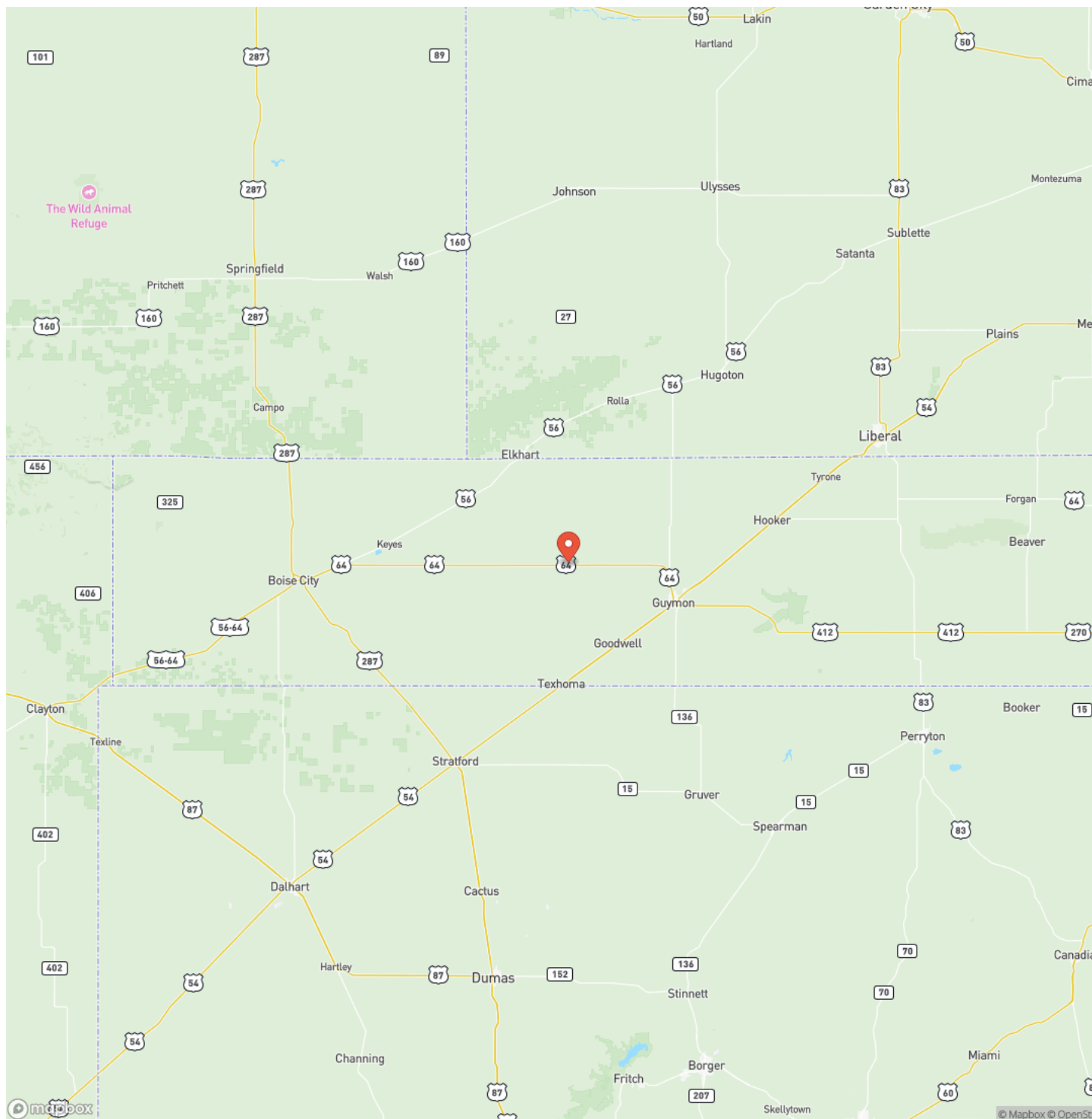

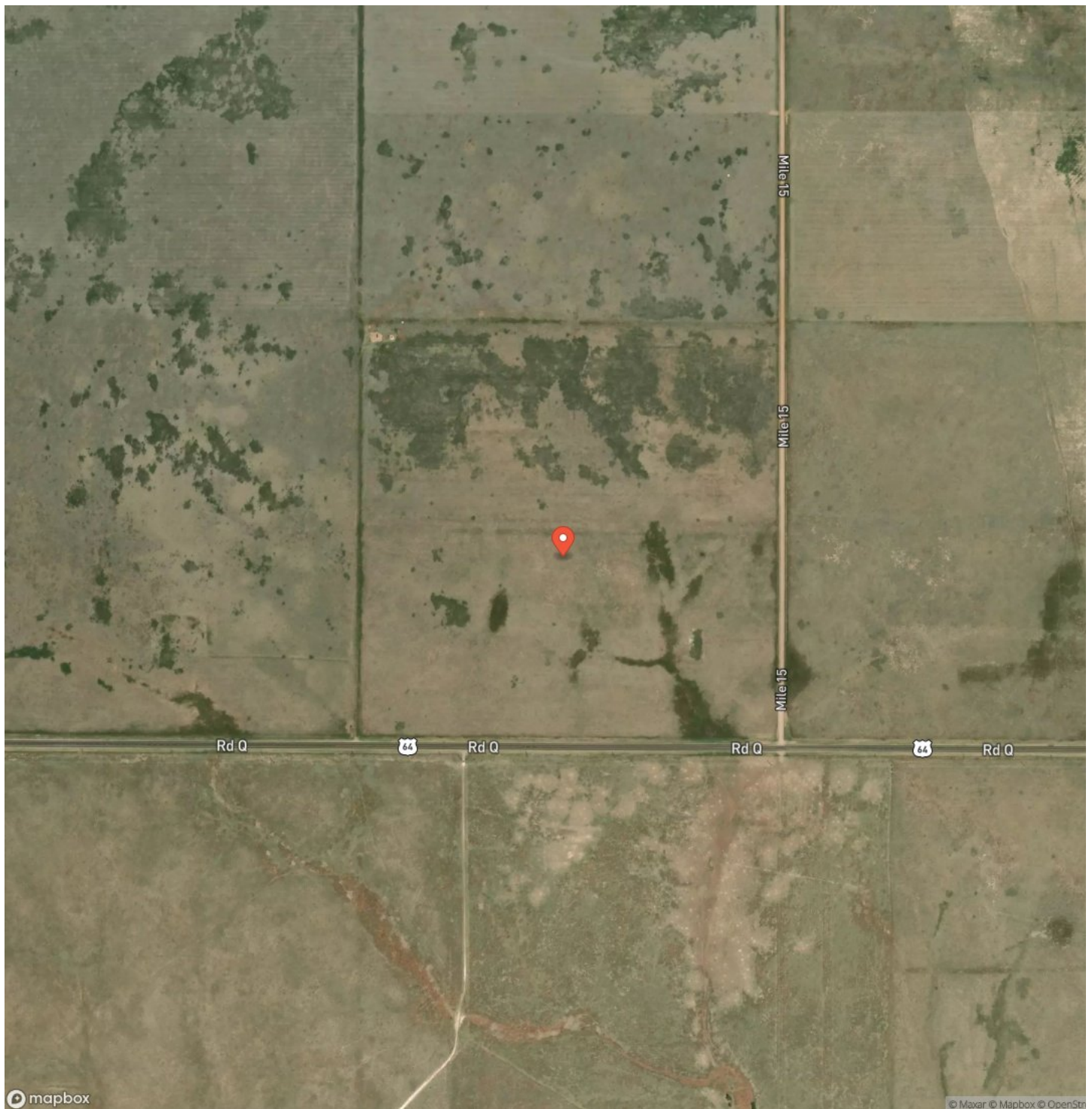
