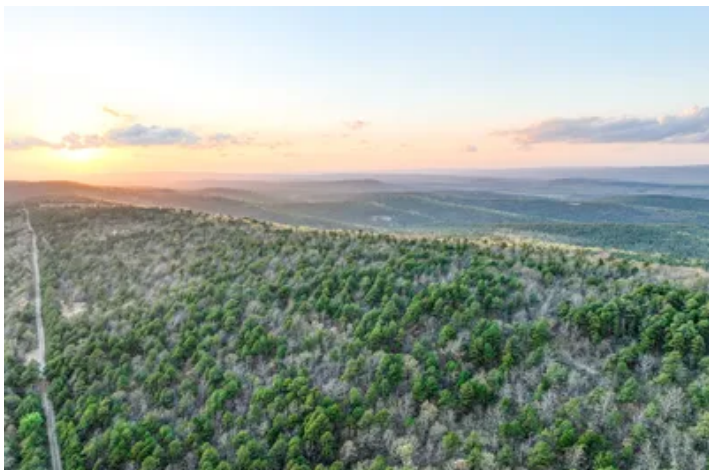

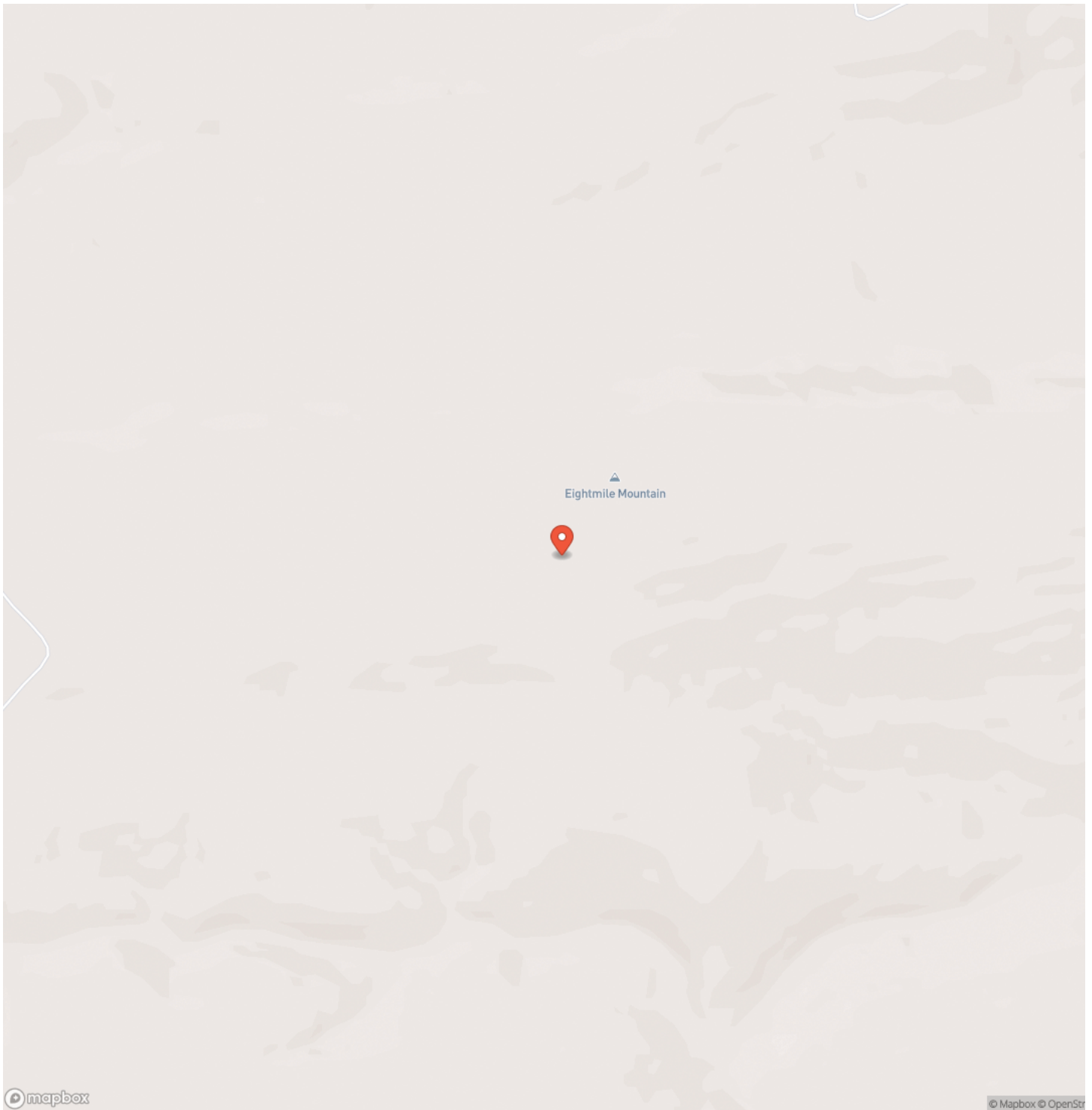
PROPERTY DESCRIPTION

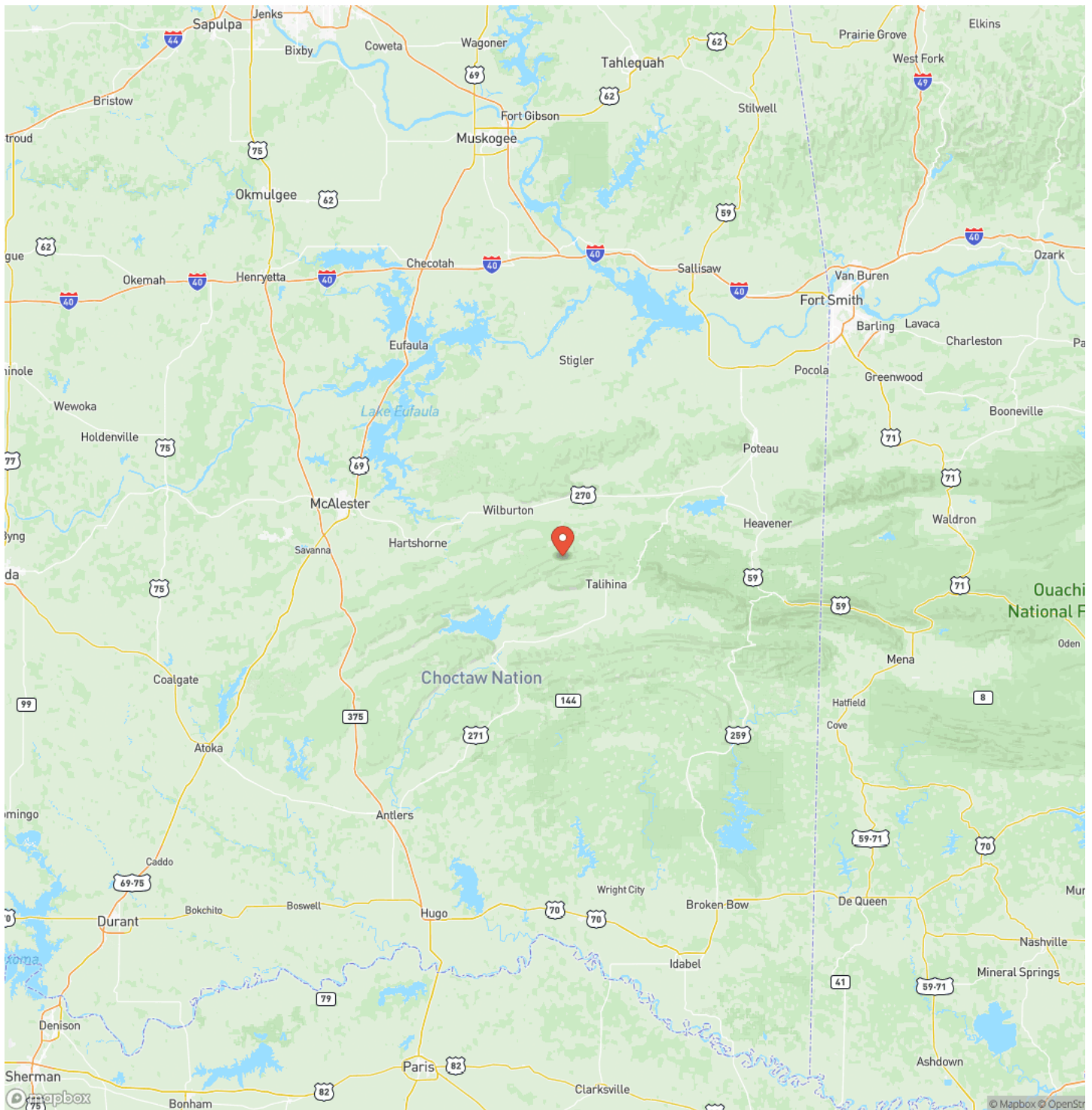

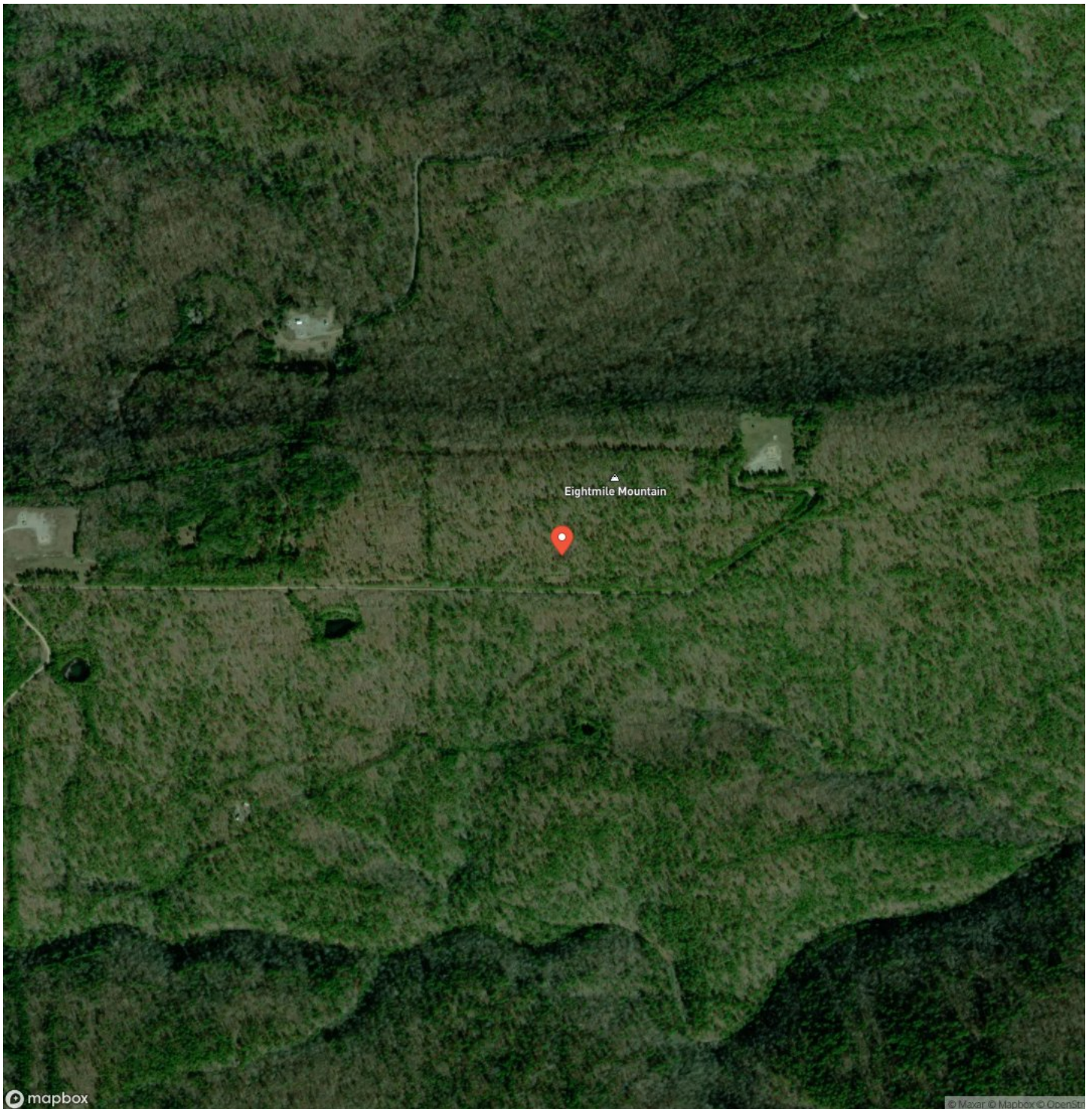
Locator Map



Locator Map

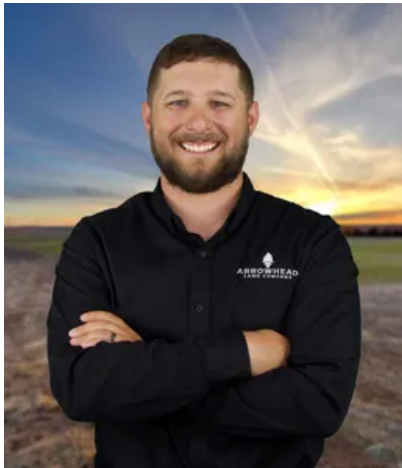


Satellite Map
