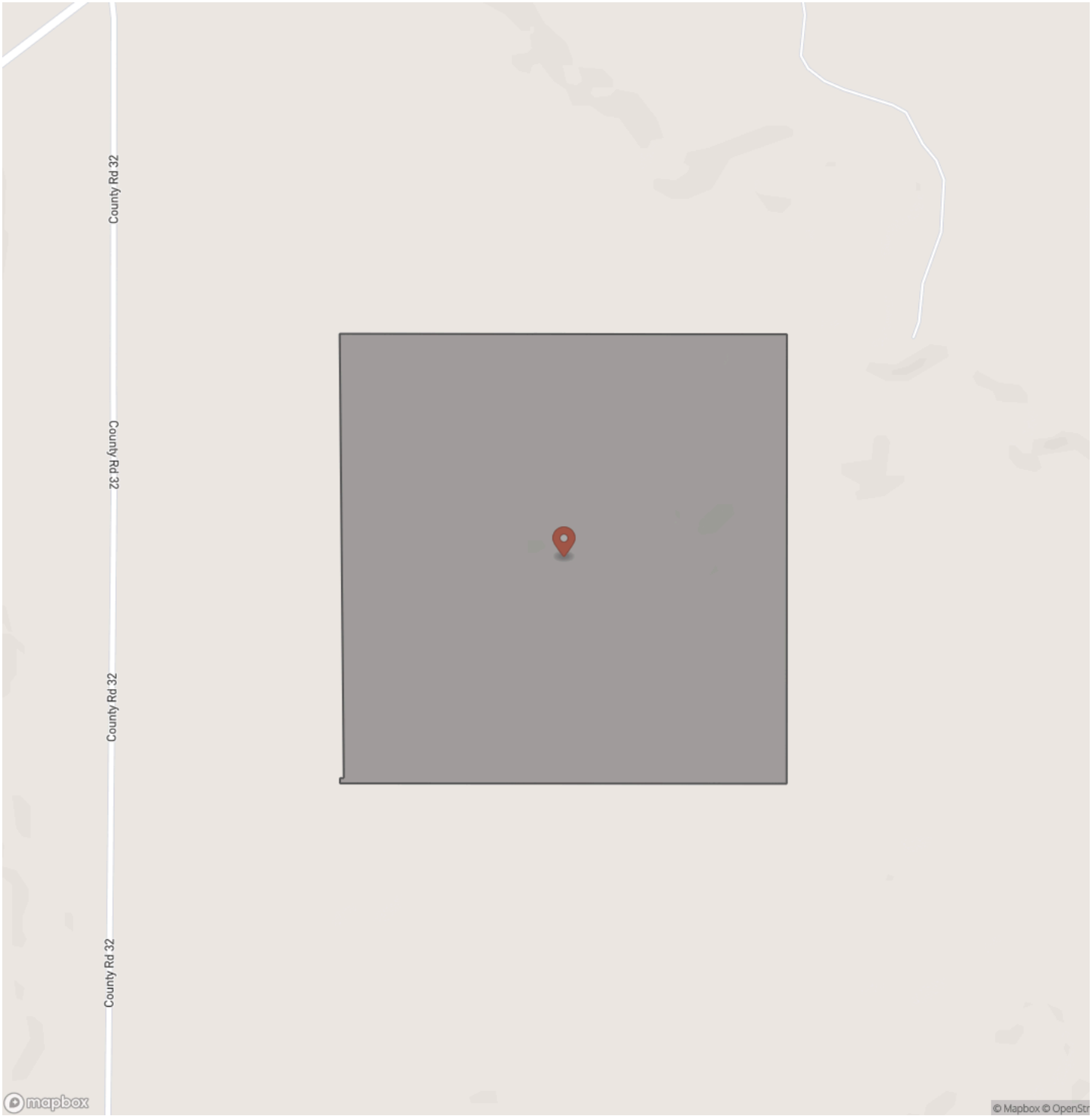

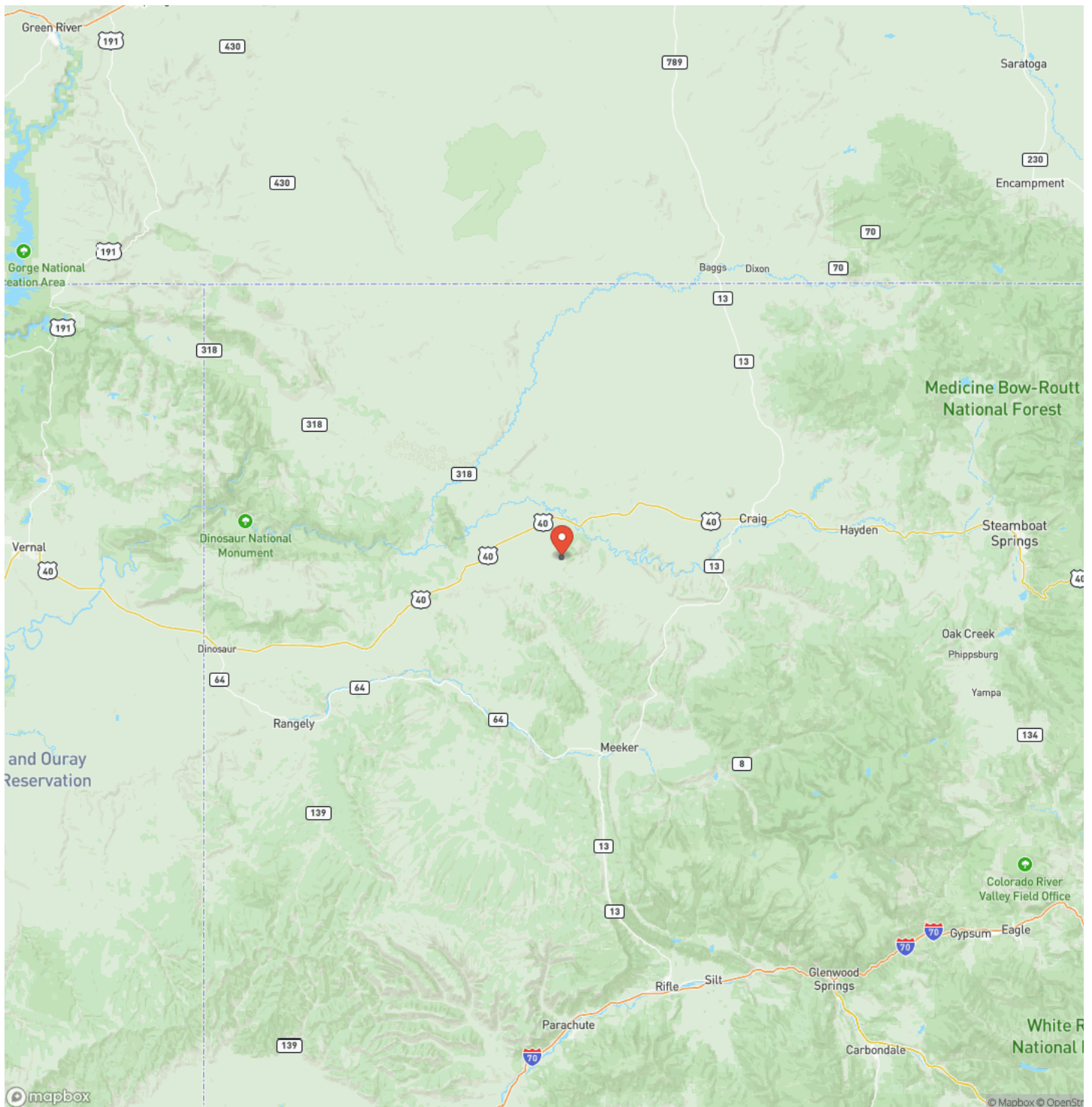

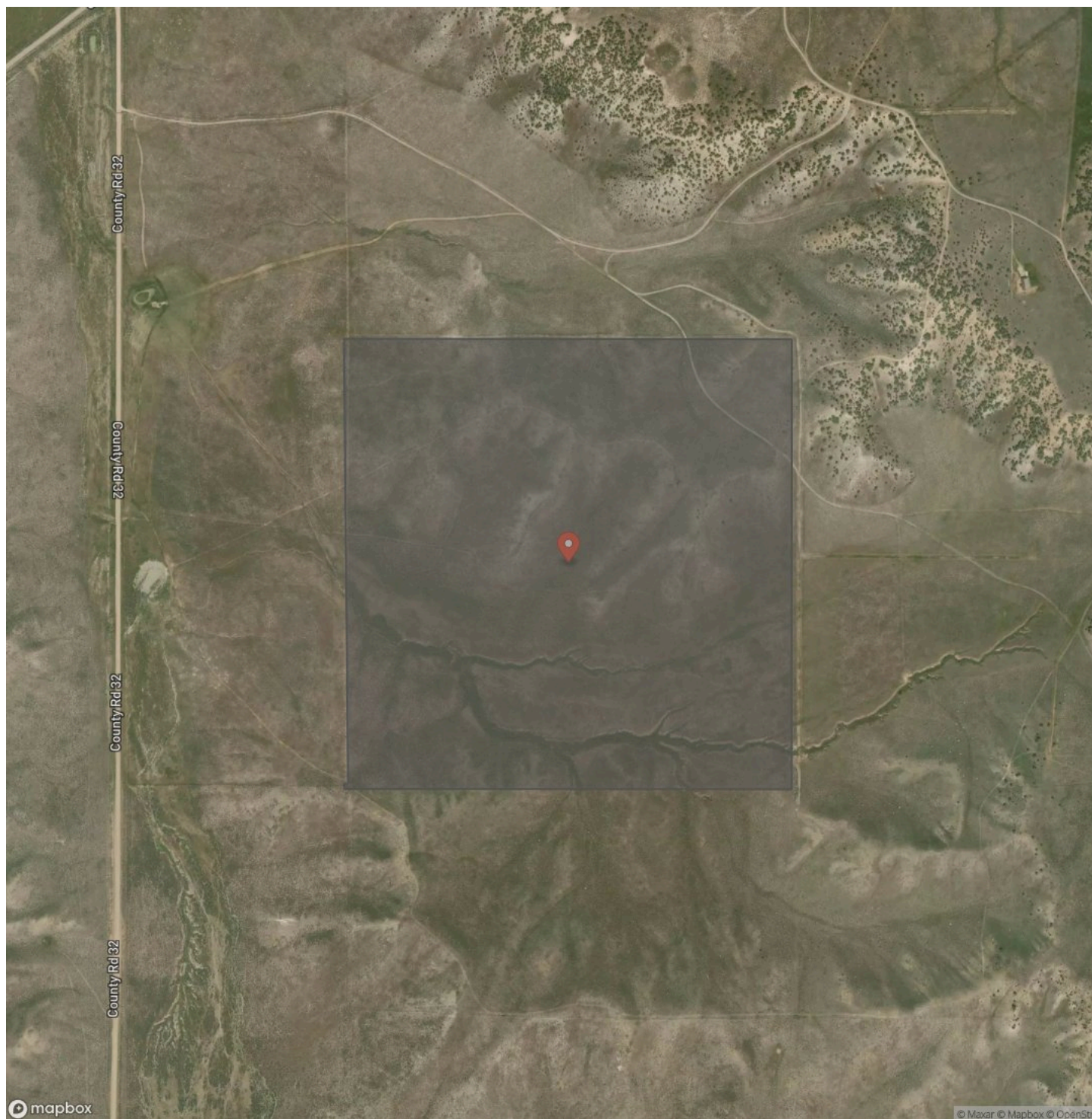
Locator Map
