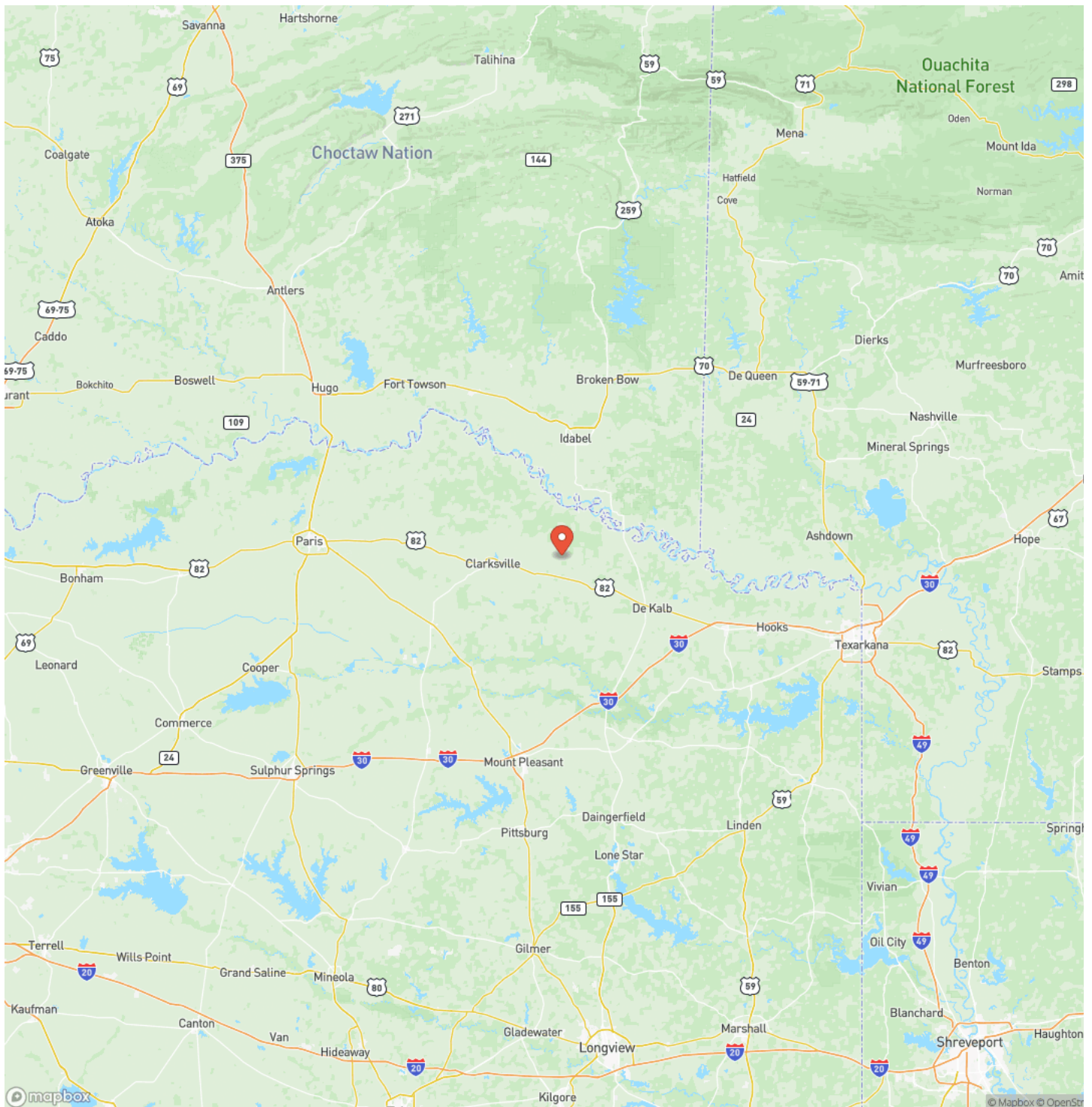

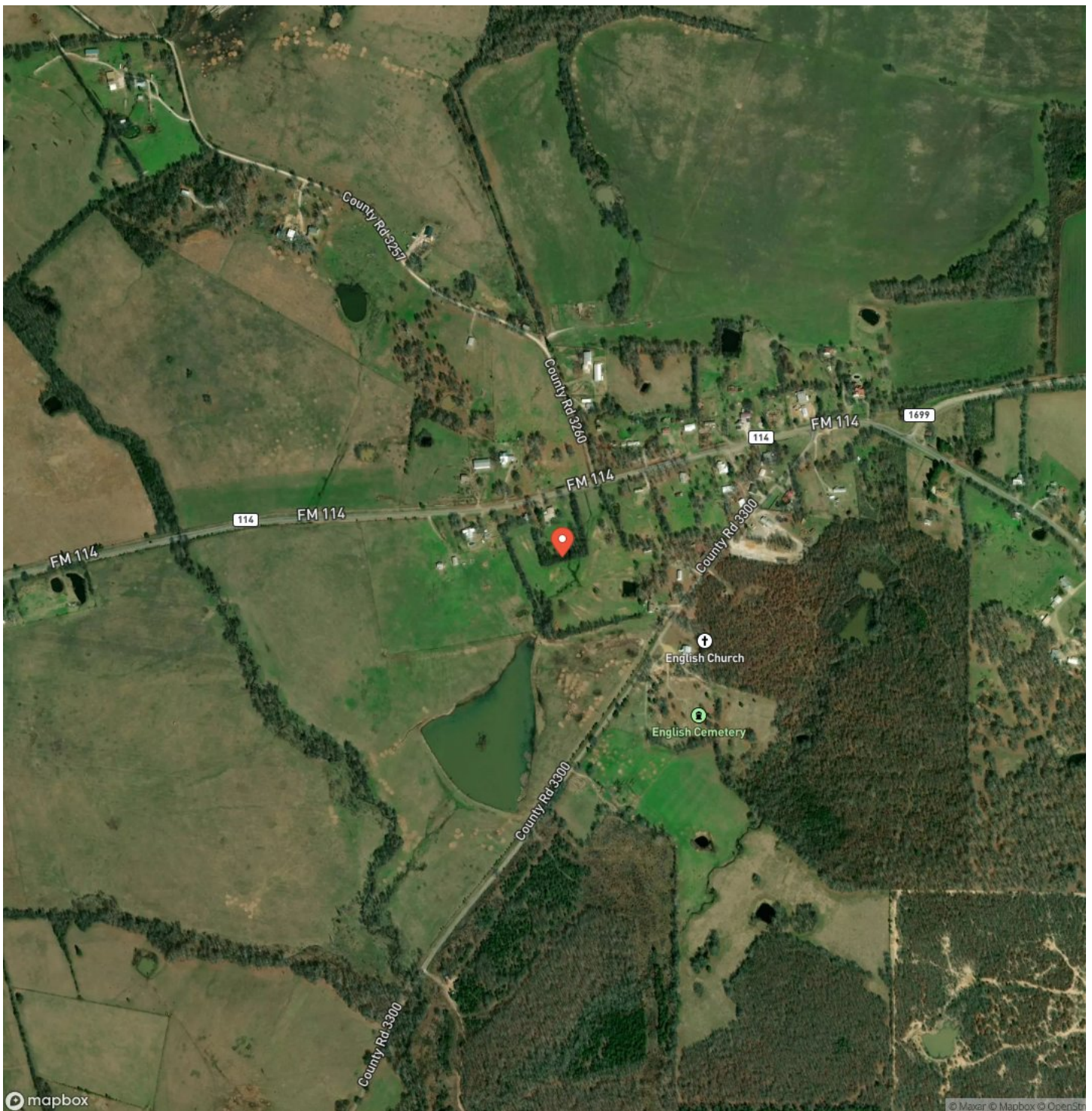
Locator Map
