**PROPERTY DESCRIPTION**

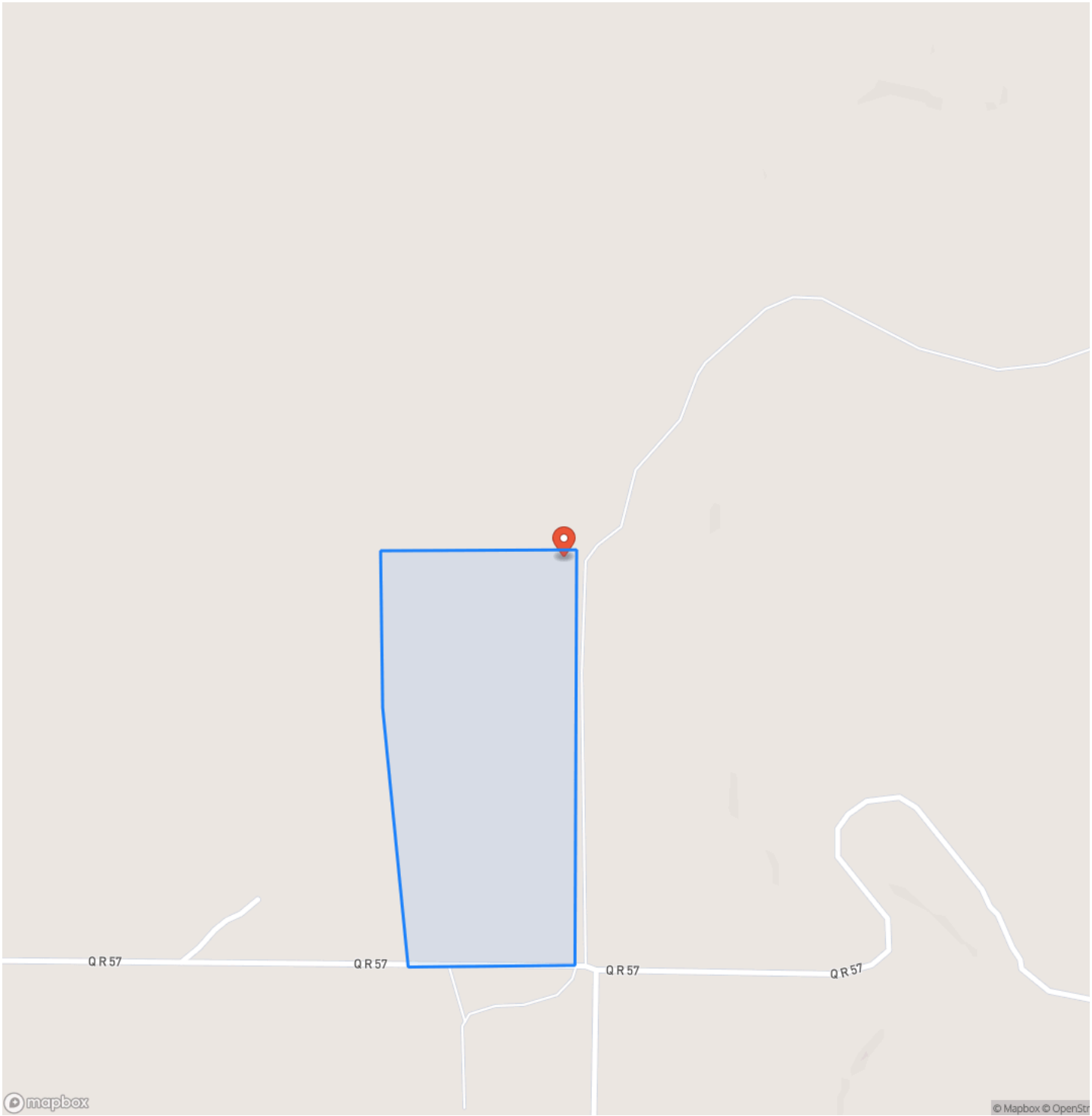

Featuring an operational well with windmill and cistern, along with a dirt tank pond designed to catch seasonal rain runoff, this land offers reliable water sources for livestock or development of a homestead. Electric lines run along county roads that front the South and East borders of this property.

Approximately half of the property has undergone mesquite clearing with windrowing in place to help control erosion allowing native grasses and quail coveys to thrive. The remaining landscape maintains its natural character, providing excellent grazing opportunities. A scattering of trees in the southeast corner offers shade and habitat for wildlife including Mule Deer that frequent the property.

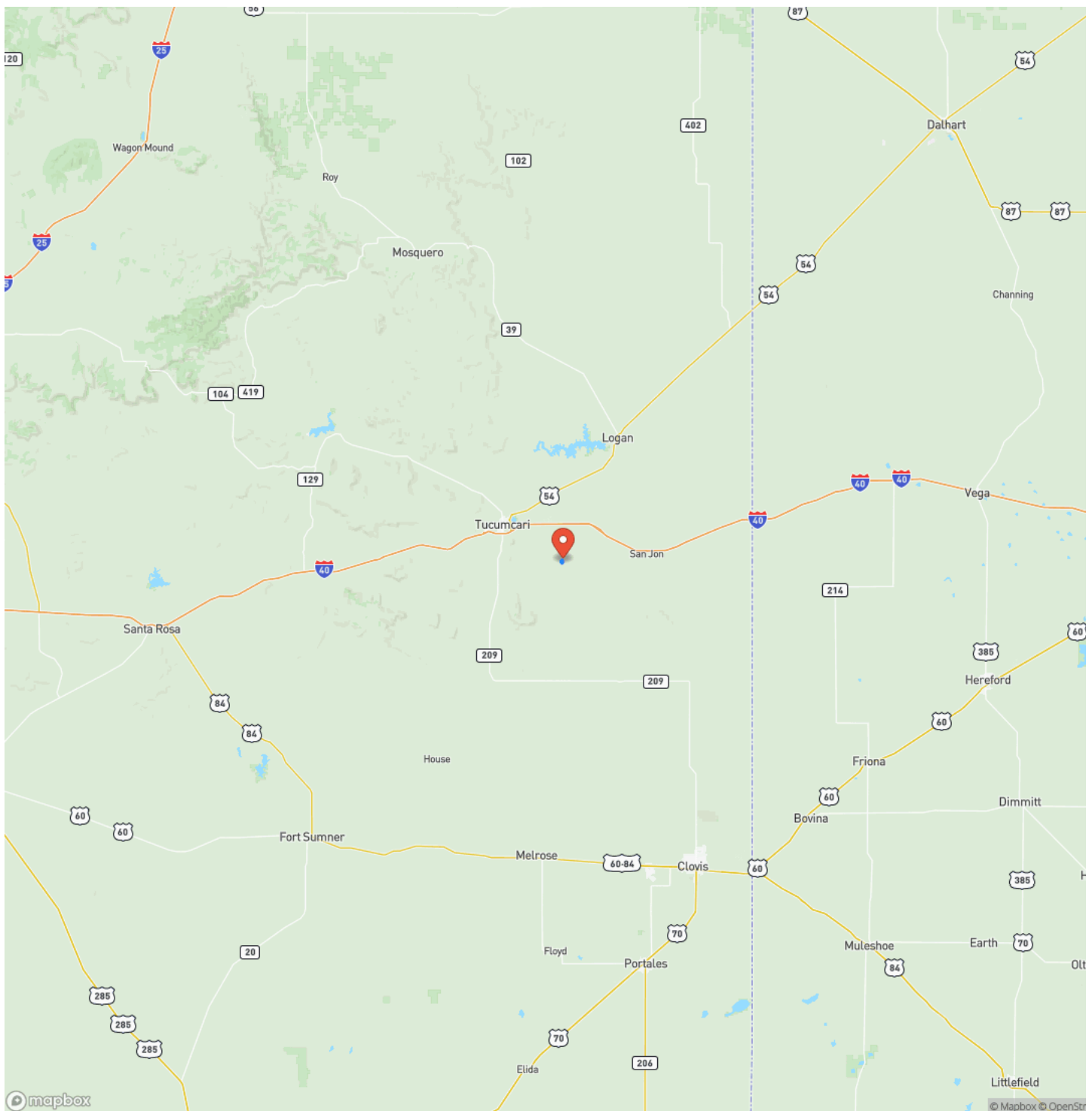
