





**ADDENDUM TO

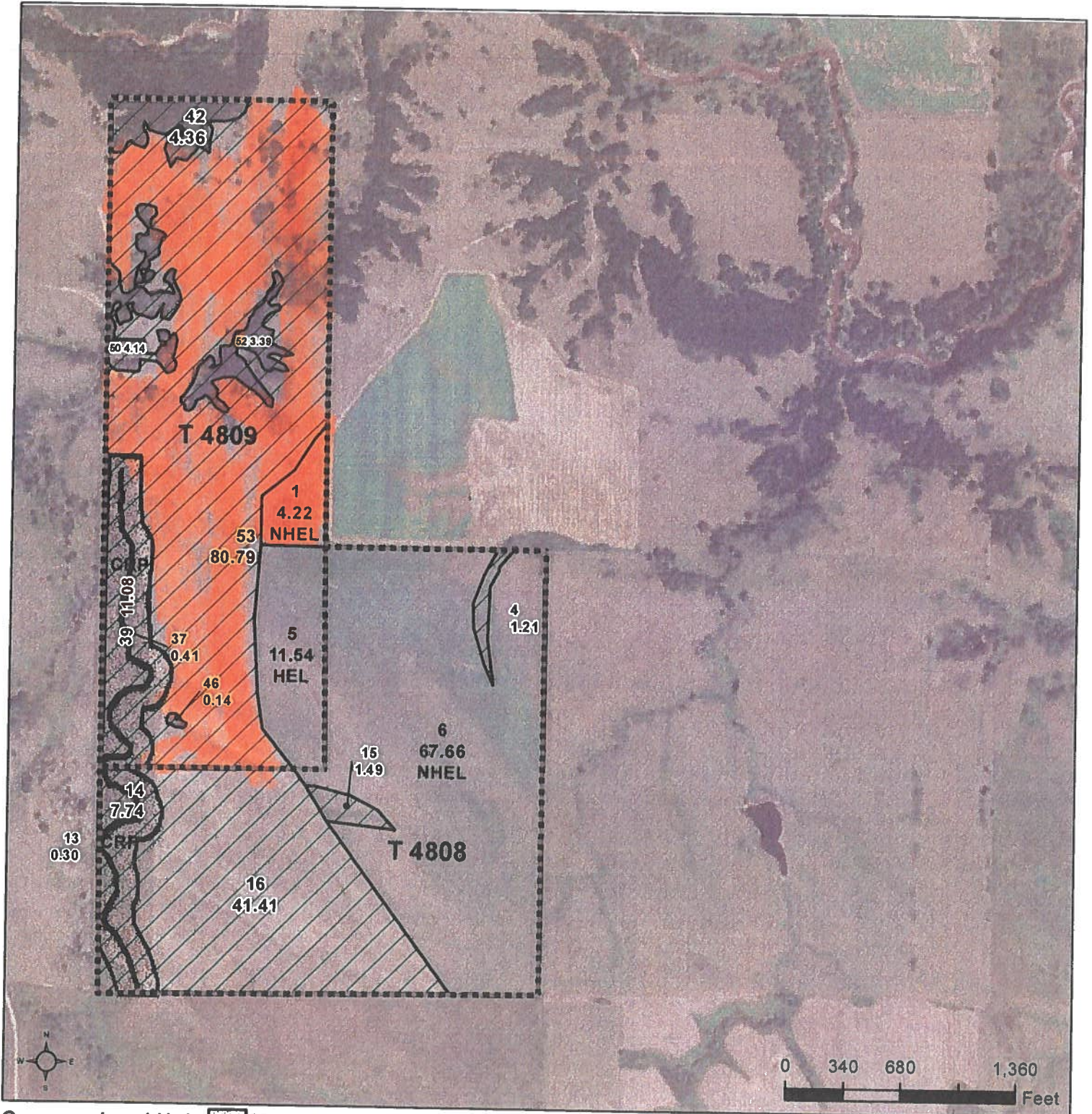
