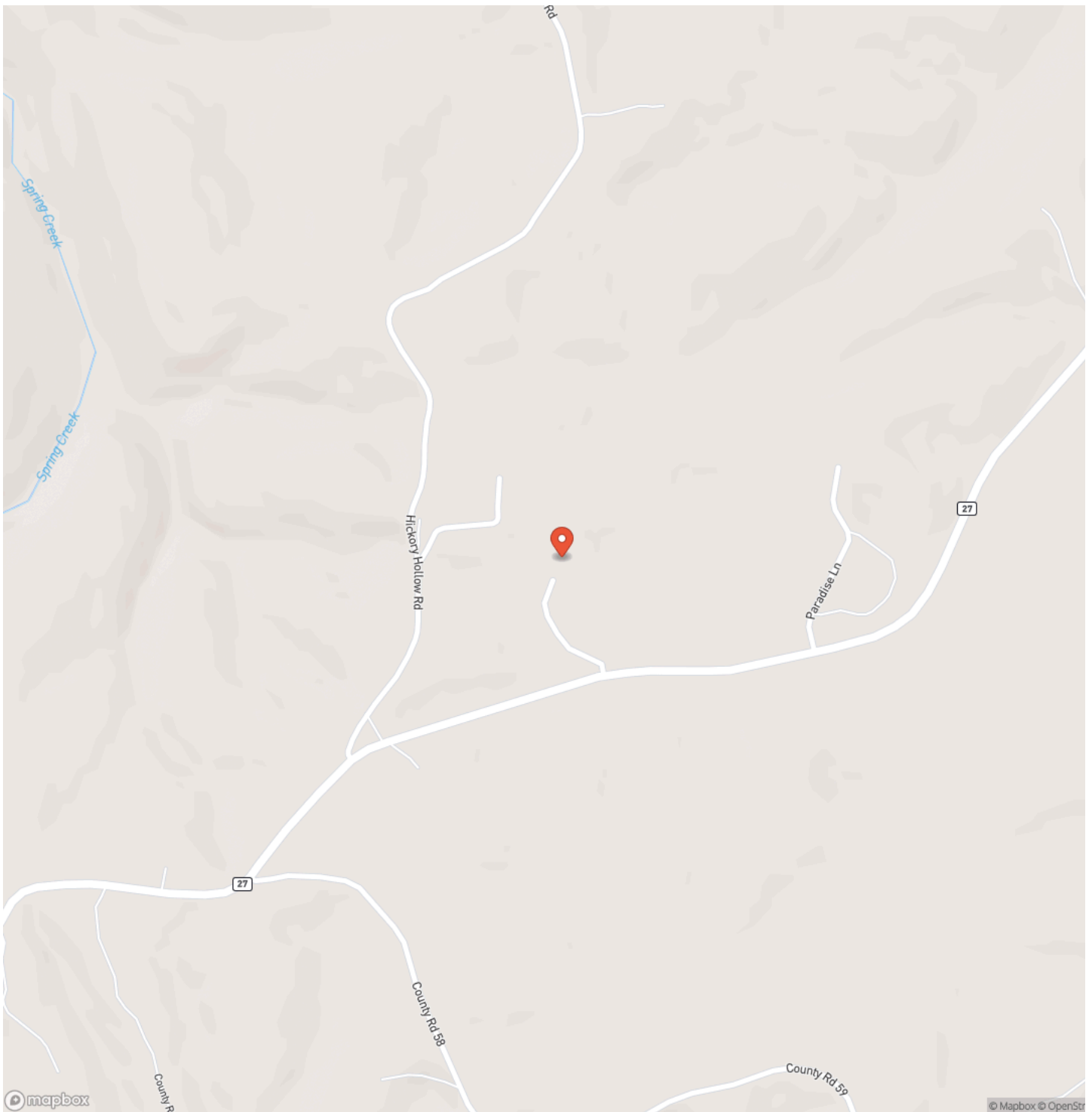

Locator Map

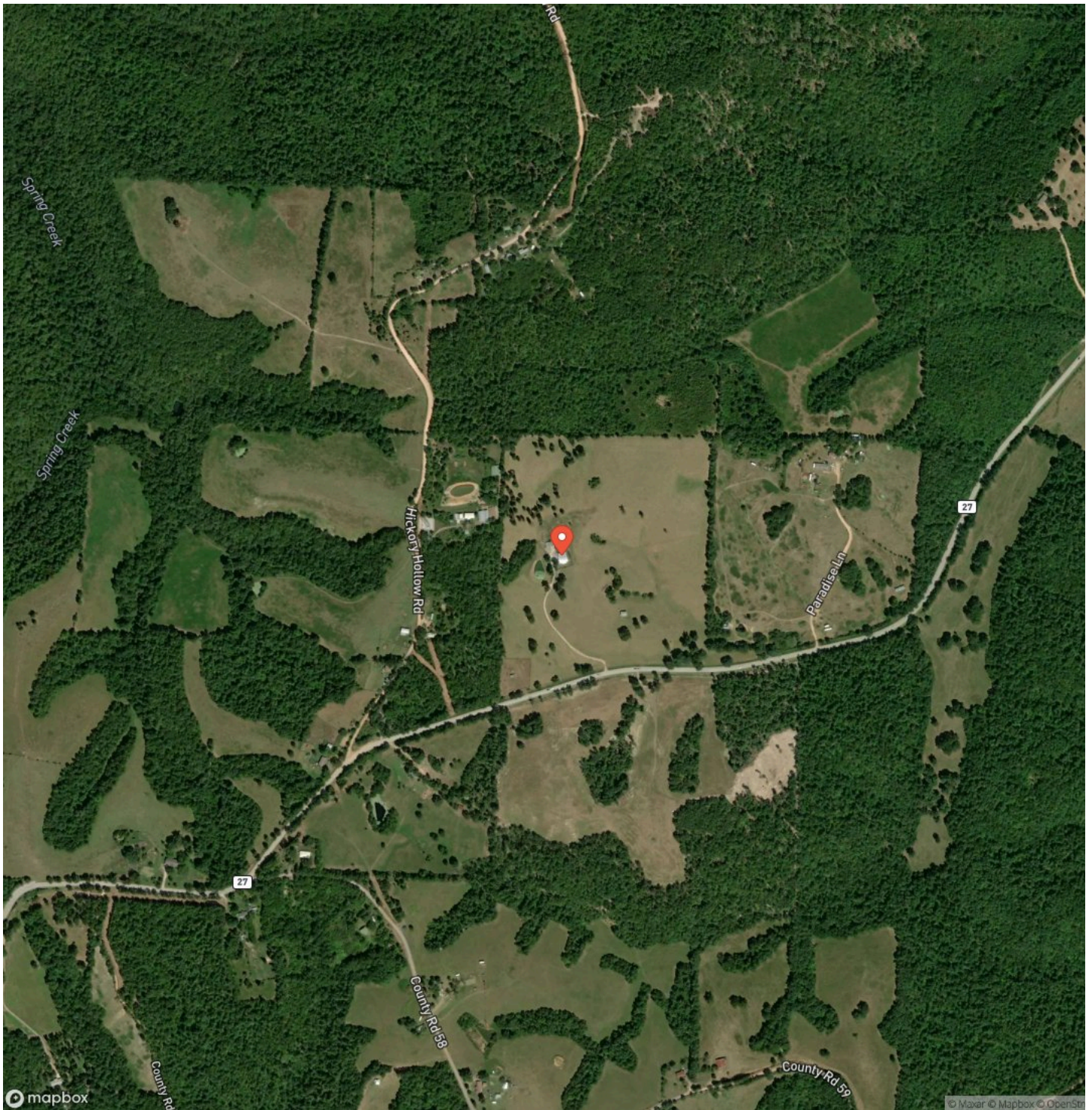
